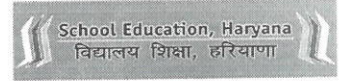

ORDER NO. 13/79-2019 PGT-II (7) DATED, CHANDIGARH, THE 24.08.2022.

Whereas, Sh. Ashok Kumar Saini was appointed as Lecturer in Economics on regular basis and joined as such on 24.02.1994. The incumbent was sent on deputation in UT Chandigarh on 20.05.2002 and remained on deputation upto 06.08.2021 and thereafter repatriated back in Education department, Haryana on 07.08.2014. The incumbent remained posted as Assistant Project Officer in the office Director Secondary Education, Haryana from 07.08.2014 to 05.02.2015. Thereafter, the incumbent posted in Govt. Sr. Sec. School, Pinjore (Panchkula) on 06.02.2015.

Whereas, an FIR No. 318 dated 07.08.2014 was registered against Sh. Ashok Kumar Saini, PGT Economics, Govt. Model Sr. Sec. School, Sector-38 (W), Chandigarh at Police Station Sector-39, Chandigarh.

Whereas, the incumbent has been convicted under section 10 of POCSO Act, 2012 and under section 354, 354A of Indian Penal Code, 1860 to undergo rigorous imprisonment for One year U/S 354, One year U/S 354 A and Five years U/S-10 of POCSO Act vide judgment/order dated 29.09.2015. The incumbent was remained in custody from 25.09.2015 to 17.10.2016.

Whereas, Sh. Ashok Kumar Saini filed an appeal i.e. Crl. Misc. No. 30332 of 2016 in Crl. A.No. S-4421-SB of 2015 against his conviction. Thereupon, the Hon'ble Additional Session Judge-cum-Judge Special Court, Chandigarh has passed the following order dated 17.10.2016 in which sentence of incumbent was suspended:-

"Hence, without expressing any opinion on the merits of the case and keeping in view the fact that the sentence of co-accused applicant has also been suspended, the application of the applicant-appellant is accepted and the remaining sentence of the applicant-appellant is suspended during the pendency

of the appeal, subject to his furnishing fresh bail bonds to the satisfaction of Chief Judicial Magistrate/Duty Magistrate, Chandigarh."

Thereafter, Sh. Ashok Kumar Saini was deemed suspended w.e.f. 25.09.2015 vide office order No. 13/79-2019 PGT-II (7) dated 18.12.2019. Meanwhile, the incumbent attained the age of superannuation on 31.03.2019 under suspension.


Article 311 of Constitution of India has provided about the dismissal & removal of an employee of Union or State services, the clause (a) of proviso to article 311(2) is produced as under:-

"311. Dismissal, removal or reduction in rank of persons employed in civil capacities under the Union or a State

(1) *****

(2) No such person as aforesaid shall be dismissed or removed or reduced in rank except after an inquiry in which he has been informed of the charges against him and given a reasonable opportunity of being heard in respect of those charges Provided that where it is proposed after such inquiry, to impose upon him any such penalty, such penalty may be imposed on the basis of the evidence adduced during such inquiry and it shall not be necessary to give such person any opportunity of making representation on the penalty proposed: Provided further that this clause shall not apply

(a) where a person is dismissed or removed or reduced in rank on the ground of conduct which has led to his conviction on a criminal charge;"




Whereas incumbent is a teacher in a school. The offences for which he has been convicted are quite serious considering the duties to be discharged by him. The position as exists today is that Sh. Ashok Kumar Saini has been convicted by the Court for the aforesaid three offences against girl child and also under section 10 of POSCO Act, 2012. A teacher with such a conduct, is dangerous for the Education system as the teacher is always a role model for the society, especially to the young minds to whom he is to teach. A convicted teacher

should not be allowed to continue in service in the interest of student and Education fraternity.

Therefore, Sh. Ashok Kumar Saini the then PGT Economics, Govt. Sr. Secondary School, Pinjore (Panchkula), is hereby dismissed w.e.f 29.09.2015 from his services by invoking the powers provided under article 311 (2) (a) of the Constitution of India.

It is ordered accordingly.






