Whereas, Shri Anil Sharma the then Principal, Government Senior Secondary School, Majri (Ambala) [retired from Government Senior Secondary School, Bichpari, Sonapat] was charge sheet under rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 on 28.10.2017/09.11.2017 and the following charges were leveled against him:-

1. That grant of Rs 14,53,250/- was issued vide letter dated RMSA/11/3620 dated 23.12.2011 for construction of six rooms under Rashtryia Mahyamik Shiksha Abhiyan and the said amount was received by him on 11.01.2012 as per entry mentioned in the passbook. In addition to the said amount, he has also received grant of Rs 5,29,500/- under Rashtryia Mahyamik Shiksha Abhiyan for construction of three rooms. Thus, he received total grant of Rs. 19,82,750/- for the construction work. It was found that the construction work was below specification. Accordingly, it was ordered by Consultant O/o SPD, HSSPP to dismantle the said construction work and he was ordered to deposit Rs. 12,85,250/- as recovery and it was also ordered that FIR may be got registered against him.
2. That an amount of Rs. 1,45,500/-, Rs. 1,92,000/- and Rs 1,92,000/- were received by him i.e. in the year 2011-12 respectively for construction of three rooms under Rashtryia Madhyamik Shiksha Abhiyan. As such, he received total Rs 5,29,500/-. The said construction work was inspected by the team i.e. Block Education Officer, Shehzadpur, SDE O/o SSA, Ambala and Account Officer O/o DPC Ambala, on 14.07.2016 and found that you he had spent Rs 6,76,000/- on the said construction. In this way, Rs. 1,46,500/- were spent in excess on the construction.
3. That on perusal of the pass book of account number 3257000100053433 of PTA, it was found that he had received Rs 4,21,000/- on 24.01.2012 on account of auction of trees, which was also misappropriated by him. In this regard, he was unable to produce any record regarding utilization of the same.
4. That he was unable to explain his position for not handing over the Parent Teacher Association charge to any official and thus, he found guilty for manipulation of the record and as such he misappropriated / embezzled the Government money./
5. That all the above mentioned allegations proves that you are responsible for all the financial misappropriation / embezzlements.

Shri Anil Sharma submitted the reply dated 01.10.2018 to the charge sheet and denied the allegation against him. Thereafter, Shri Om Parkash Garg, Addl Dist & Session Judge (Retd) was appointed as an Inquiry Officer vide order dated 07.03.2019/14.03.2019 to conduct regular department enquiry and report dated 19.06.2019 was submitted by the Inquiry Officer wherein the charge no. 2, 4 & 5 were stand proved. Resultantly, the findings of Inquiry Officer dated forwarded to him on 20.09.2019 and the charged officer had made the representation dated 14.10.2019 on the findings of the Inquiry Officer. Thereafter, the Charged Officer was granted opportunity of personal hearing on 04.02.2020 and the competent authority passed the order dated 14.02.2020/25.02.2020 whereby the punishment of stoppage pensionary benefit@25% was inflicted upon him as the charged officer was going to retire in March'2020.

Feeling aggrieved from the order dated 14.02.2020/25.02.2022 passed by the competent authority, Shri Anil Sharma, Principal (Retd) filed Civil Writ Petition No. 7372 of 2020 titled as Anil Sharma V/s State of Haryana for quashing the impugned order dated 14.02.2020/25.02.2020 which subjudice before the Hon'ble Punjab & Haryana High Court.

That Shri Anil Sharma, Principal (Retd) preferred representation dated 20.10.2021 before Hon'ble Education Minister for quashing the order dated 14.02.2020. The appellant was heard by Hon'ble Education Minister and ordered to release the pensionary benefits subject to final outcome of the Civil Writ Petition No. 7372 of 2020 titled as Anil Sharma V/s State of Haryana by taking sympathetic view in the matter.

Keeping in view of the facts of the case and orders passed by Hon'ble Education Minister, order dated 14.02.2020/25.02.2020 passed by the competent authority are superseded and pensionary benefits are ordered to be released subject to final outcome of the Civil Writ Petition No. 7372 of 2020 titled as Anil Sharma V/s State of Haryana.



The charges are based on the statement of allegations appended thereto.

2 Smt. Sheela Devi is hereby required to state in writing within a period of 15 days from the receipt of this memorandum by her whether she admits the truth of all, or any, of the charges, what explanation or defence, if any, she has to offer and whether she desires to be heard in person.

3 Smt. Sheela Devi is hereby further informed that if for the purpose of preparing her written statement, she wishes to have access to the relevant official records, she should inspect the same in the office of the Director General Secondary Education Haryana, Panchkula, on any working day after making prior appointment with him. It is, however, pointed out that only such documents will be shown to her as are in the possession of the Director General Secondary Education, Haryana, Panchkula, and as are strictly relevant to the case. If in the opinion of the Government, it is not desirable in the public interest, to allow her access to any document, such access shall be refused. If, Smt. Sheela Devi wishes to consult any other relevant record, which is not in the custody of the Director General Secondary Education Haryana Panchkula it is for her to undertake its inspection. It is, however, made clear to Smt. Sheela Devi that her failure to inspect the documents shall not constitute a valid ground for delay in the submission of her written statement and if the written statement is not received by the undersigned within the specified period, it shall be presumed that she has none to submit.

Statement of allegations against Smt. Sheela Devi [072174] the then Principal, Government Girls Senior Secondary School, Nangal Kalan [3643], Sonapat [now posted at Government Senior Secondary School, Kundli [3628], Sonapat]

While being posted as Principal at Government Girls Senior Secondary School, Nangal Kalan [3643], Sonapat from 26.04.2012 to 22.08.2019 and Government Senior Secondary School, Kundli [3628], Sonapat from 22.08.2019 to date, Smt Sheela Devi committed following acts of omission and commission:-

That Shri Sanjeev Dahiya son of Shri Om Parkash resident of House No. 421/20, Patel Nagar, Sonapat made a complaint dated 29.10.2021 against her i.e. Smt Sheela Devi wherein allegation of financial misappropriation/embezzlement of Government funds were leveled. In this regard, District Education Officer, Sonapat was directed vide letter no. 5/253-2021 HRG-I(1) dated 07.01.2022 to enquire into the complaint by constituting a Committee and District Education Officer, vide letter no. E-1/22/796 dated 19.01.2022 submitted its report. Further, the Superintendent of Police, Chief Minister Flying Squad Office of Additional Director General Police, Haryana, vide letter no. 271/Complaint Branch-4 dated 10.01.2022 submitted the enquiry report dated 08.12.2021 of Shri Sandeep Singh, Deputy Superintendent of Police, Chief Minister Flying Squad Office, Rohtak. On examination of the report dated 19.01.2022 and dated 08.12.2021 of District Education Officer, Sonapat and Deputy Superintendent of Police, Chief Minister Flying Squad Office, Rohtak following lapses were found to be committed on her part i.e. Smt Sheela Devi:-

1. That a grant amounting to rupees 19,27,000/- was released by the Directorate vide letter no. 2/21-2018 Works(1) dated 24.10.2018 for repair of rooms of building of Government Girls Senior Secondary School, Nangal Kalan (Sonapat) to her i.e. Smt Sheela Devi being principal but record of the said grant such as cash book, bill file, bills quotation, stock register, visitor register, measurement book etc was found missing from the School record. That grants amounting to rupees 13,97,000/- in the year 2018-19, rupees 13,68,000/- and rupees 19,11,000/- in the year 2019-20 for repair were released to her i.e. Smt Sheela Devi for Government Senior Secondary School, Kundli Sonapat but she i.e. Smt Sheela Devi failed to submit any utilization certificate for such grants and further she i.e. Sheela Devi got released the grant of Rs 19,93,000/- and Rs 19,68,000/- in the year 2020-21 for the same cause.
3. That grant amounting to Rs 19,11,000/- was released by the Director Secondary Education, Panchkula vide letter no. 2/85-2019 Work(1) dated 16.07.2019 to her i.e. Smt Sheela Devi and the same was to be utilized by constituting School Management Development Committee under the Chairmanship of the District Education Officer,

Sonepat but she i.e. Smt Sheela Devi being Principal failed to follow the instructions mentioned in the said letter dated 16.07.2019. Further, she i.e. Smt Sheela Devi got the M.B. completed from Shri S K Lal, Junior Engineer (on contract) instead of Shri Ashish Kumar, Junior Engineer office of Sarv Shiksha Abhiyan Rai, Sonepat who was the technical member of the Committee.

In this way, she i.e. Smt Sheela Devi committed an act unbecoming of a Government officer and acted in a negligent and irresponsible manner and violated the provisions of rule 4(1) and (2) of the Haryana Civil Services (Government Employees Conduct) Rules, 2016.

The lapses detailed above constitute grave misconduct on the part of Smt. Statement of charges against Smt. Sheela Devi [072174] the then Principal, Government Girls Senior Secondary School, Nangal Kalan [3643], Sonapat [now posted at Government Senior Secondary School, Kundli [3628], Sonapat]

While being posted as Principal at Government Girls Senior Secondary School, Nangal Kalan [3643], Sonapat from 26.04.2012 to 22.08.2019 and Government Senior Secondary School, Kundli [3628], Sonapat from 22.08.2019 to till date, Smt Sheela Devi committed certain acts of omission and commission for which she is charged as under:-


That Shri Sanjeev Dahiya son of Shri Om Parkash resident of House No. 421/20, Patel Nagar, Sonapat made a complaint dated 29.10.2021 against her i.e. Smt Sheela Devi wherein allegation of financial misappropriation/embezzlement of Government funds were leveled. In this regard, District Education Officer, Sonapat was directed vide letter no. 5/239-2021 HRG-I(1) dated 07.01.2022 to enquire into the complaint by constituting a Committee and District Education Officer, vide letter no. E-1/22/796 dated 19.01.2022 submitted its report. Further, the Superintendent of Police, Chief Minister Flying Squad Office of Additional Director General Police, Haryana, vide letter no. 271/Complaint Branch-4 dated 10.01.2022 submitted the enquiry report dated 08.12.2021 of Shri Sandeep Singh, Deputy Superintendent of Police, Chief Minister Flying Squad Office, Rohtak.
