

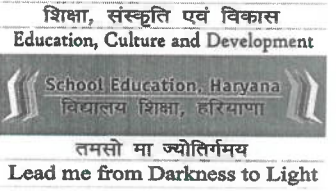

Whereas, Ms. Janko Rani (Emp.ID 060690) PGT History has filed subject cited CWP No.19753 of 2022 titled as Janko Rani Vs. State of Haryana & Others praying therein for issuance of a writ in the nature of certiorari quashing the impugned transfer drive detail (P-5), impugned allocation (P-6) and impugned transfer order dated 28.08.2022 (P-7), issued by the respondent department, vide which the employees/teachers having less points than the petitioner have been transferred/allocated the stations against the preferences filled by the petitioner as her preferences/choices and petitioner has not been allocated any of her preferences despite having higher points, being totally illegal, arbitrary, unconstitutional and contrary to the Teachers Transfer Policy. Further, to issue a writ in the nature of mandamus directing the respondents to allot the stations to the petitioner as per her preferences/points and entitlement as per the transfer policy (P-2) and further restraining the respondents from relieving her from her present place of posting i.e. GGSSS Mela Ground (2845), Sirsa, keeping in view the peculiar facts and circumstances mentioned herein above. Further, it is also prayed that in case the petitioner got relieved from the present place of posting, the impugned orders may kindly be stayed and petitioner may not be transferred from current school i.e. GGSSS Mela Ground [2845], Sirsa and her posting may be kept intact, during the pendency of the present writ petition.

The aforesaid writ petition along with the connected CWPs came up for hearing before this Hon'ble Court on 05.09.2022 and the on that day Hon'ble Court was pleased to dispose of the same with a common direction to respondents. The operative part of the order dated 05.09.2022 is as under:-

*Mr. Harish Nain, AAG, Haryana accepts notice on behalf of the respondent-State and submits that as the petitioners are raising dispute with regard to the non-adherence of various clauses of the policy, therefore, in case petitioners have already filed a representation or if they file any representation with the respondents within a period of two days from today, the same will be considered in accordance with law by the respondents and an appropriate speaking order will be passed within a period of 07 days thereafter. In case after the decision, it is found that the petitioners*

*are entitled for any relief, the same will be extended to them.*

*Learned counsel for the petitioner(s) submits that keeping in view the statement of the learned State counsel, the present petition(s) may kindly be disposed off having been not pressed any further but prays that keeping in view the fact that the respondents have agreed to look into the grievance of the petitioners, the petitioner(s) be allowed to continue at their present place of posting so that in case their claim is accepted by the respondents, they do not suffer harassment of shifting base again.*

That in compliance of the Hon'ble High Court order dated 05.09.2022; the petitioner Ms. Janko Rani (Emp.ID 060690) PGT History has submitted her grievance on Sugam sampark Portal with Ticket No. 060690068E6 dated 28.08.2022, which has been examined in view of the provisions of the teacher transfer policy. As per General Transfer Drive data, she was included in Transfer drive due to completion of 5 years in her present zone. The system has not allocated any station to her because she has filled the preferences and saved but did not lock or make the final submission/confirmed any choices. She participated in the 2<sup>nd</sup> round of transfer drive and got 1<sup>st</sup> preference as per her merit points (72.5644) in this round. As per policy, she has been allocated at Government Senior Secondary School, Kharian (2831) in Zone-6.

Whereas, the Government of Haryana has framed **Teachers Transfer Policy, 2016** dated 29.06.2016 and the same was amended on 01.06.2017. Thereupon, transfers were made under this amended policy of 2017 to ensure equitable, demand based distribution of teachers/Heads to protect academic interests of students and optimize job satisfaction amongst its employees in a fair and transparent manner. Under this policy all government schools have been categorized into seven zones for the purpose of transfer of teachers and the teacher is eligible to opt any number of schools across the zones available to him, across the district in the State. She/He is free to give preferences in order of their suitability. For the purpose of Transfer Drive, the teachers who have already completed a period of 1 year service in a particular zone may seek transfer to some other station, on the other hand following categories of teachers have been asked to participate in the transfer drive compulsorily:

- a. A post of any cadre held by a teacher previously or presently in the school education department in a regular capacity for a period of 5 years or more on the qualifying date in the present

zone of posting, shall be taken as a deemed vacancy and such teacher shall participate compulsorily in the transfer drive.

- b. Teachers declared surplus from a station as a part of rationalization/Normalization shall also participate compulsorily in the transfer drive.
- c. Teachers who have been given temporary manual posting previously due to non-availability of online transfer drive or technical problem or compulsion

In view of the facts and circumstances explained above, the grievance of the petitioner has been redressed. Hence, the claim of the petitioner is rejected and she is directed to join the station allotted in the second round.

I order accordingly.
