Whereas the petitioners had filed the CWP No. 10010 of 2021 titled as Deepak and others V/s State of Haryana & others, before the Hon'ble Punjab & Haryana High Court, praying therein for issuance of a writ in the nature of certiorari for setting aside the speaking order dated 13/120-2020 HRME-I (4) dated 13.04.2021 (Annexure P-13) qua the petitioner only wherein the relief sought in representation dated 21.08.2020 (Annexure P-6) has been declined.

The above said Civil Writ Petition came up for the adjudication before the Hon'ble Court on 12.07.2022 and the same was disposed of by the Hon'ble High Court. The operative part of the aforesaid orders is reproduced here as under:-

“Keeping in view the above, the present petitions are disposed of in the agreed terms that the petitions will file representation within a period of 7 days from today i.e. upto 18<sup>th</sup> of July, 2022 giving their options for transfer to the posts which are still lying vacant. The State is directed to decide the said representations in accordance with law coupled with the provisions of the policy with a sympathetic consideration so as to avoid any further litigation and to streamline the functioning of the schools concerned, within a period of 4 weeks thereafter.

It is made clear that till the decision of the representation, the petitioners will be allowed to serve at the places where they are actually working now and in case, their representation is accepted and they are posted in a school which they have opted in the representation, they will join the same, otherwise, the petitioners will join schools where they have already been transferred by the respondents in the orders impugned in their petitions, which fact would be made clear by the respondents while deciding their representation. It is also made clear that a particular

petitioner cannot opt for more than three schools in his representation and in case, any of the petitioners opt for the same posting, the length of the service should be taken into consideration while deciding their claim with regard to the option.

Civil miscellaneous applications No. CM-2758-CWP-2022 and CM-1671-CWP-2021 in CWP No. 13810 of 2021, CM-13046-CWP-2021 in CWP-9163-2021, CM-16284-CWP-2021 in CWP-15468-2021 and CM-5074-CWP-2022 in CWP-11116-2021 also stand disposed of.

**A photocopy of this order be placed on the connected files.”**

In compliance of the above mentioned orders of the Hon'ble High Court, the representations dated 18.07.2022 of the petitioners were examined wherein all the petitioners have opted for 3-3 stations as per the orders dated 12.07.2022 of the Hon'ble High Court. During the examination of the representations, it was found that as per the transfer policy dated 06.03.2020, some of the petitioners participated voluntarily, whereas some of the petitioners participated compulsorily on completion of their maximum 05 years stay in a particular zone. All the petitioners opted the stations according to their suitability and choices. But due to low merit scores obtained by them most of the petitioners could not get the stations opted by them. Such stations were given/allocated to the employees who have scored higher marks than the petitioners though some of the petitioners allocated the stations out of their preferences. Thus transfer of the petitioners has been done in a fair & transparent manner in strict compliance of the Online Transfer Policy of Ministerial Staff dated 06.03.2020.

Earlier also the petitioners had filed the CWP No. 13085/2020 titled as Joginder Sharma and Others V/s State of Haryana and Others before the Hon'ble Punjab & Haryana High Court with the prayer for issuance of a writ in the nature of certiorari for setting aside impugned order dated 14.08.2020 qua the petitioners.

The above said Civil Writ Petition came up for adjudication before the Hon'ble High Court on 28.01.2021 and same was disposed of with following orders:-

**"In view of the agreed stand taken by both sides, this writ petition is disposed off with a direction to the competent authority to consider and decide the representation dated 21.08.2020 (P-10) expeditiously in accordance with law preferably within two weeks from today if there is no legal impediment. It is clarified that in case the desired representation is not decided within the stipulated time, the same shall be considered as disobedience of the order of this Court. It is also clarified that interim order dated 01.09.2020 will continue till the representation is decided in accordance with law. Since main writ petition stands disposed off, therefore, the pending applications, if any, shall also dispose off."**

In compliance of the above said orders of the Hon'ble High Court the department passed the speaking orders dated 13.04.2021 while rejecting the claim of the petitioners.

Whereas, the Government of Haryana framed Online Transfer Policy of Ministerial Staff dated 06.03.2020, thereupon, transfers were made under this policy to ensure equitable distribution of Ministerial Cadre Employees of the Department across the State, in a fair & transparent manner and to maximize job satisfaction amongst the employees. Under this policy all the government schools/ institutes have been categorized into seven zones for the purpose of transfer of clerks and every participant is eligible to opt for any number of schools/institutes across the zones available to him/her. He/ She is free to give preferences in order of his/her suitability, so that the chances of being posted in **'Anywhere in the State'** category may be decreased. Further, according to the Para No. 4 sub clause V (b) of the Transfer Policy of Ministerial Staff 2020, the department is at liberty to post an employee anywhere in the State if he/she fails to get one of his/her preferred options. Thus the



petitioners got the stations as per the online transfer policy of Ministerial Staff 2020.

Whereas the stations were blocked by following the process of rationalization. It is worthwhile to mention here that according to the sub clause-iv of Clause-4 of online transfer policy of Ministerial Staff 2020, the department can block actual vacant post for the purpose of rationalization. Sub clause-iv of Clause-4 online transfer policy of Ministerial Staff 2020 is as under:-

**iv) Rationalization and Blocking of posts: To avoid disproportionate concentration of employees at a particular station, the department should rationalize their sanctioned posts and also block actual vacant post to be kept vacant in the transfer drive. In the long run, however, the department may increase/decrease the total number of sanctioned posts as per the assessment/requirement in consultation with work Assessment Cell in the Administrative Reforms Department and Finance Department.**

The posts with less workload were blocked by the department, because these stations with over workload require more employees for smooth working in the department. So, for maximum utilization of the potential of an employee at over work-loaded station and to avoid misappropriate concentration of employees at a particular station, the blocking of posts was done by the process of rationalization in the public interest.

d Moreover, the stations were blocked by the department by following the proper criteria i.e. the schools in which student strength is less than 125 but where the strength of the students is more than 125 the transfer of clerks has been done as per the online transfer policy. Thus for the process of even distribution of clerks in the State, the process of rationalization was done as per mandate of Clause 4 (iv) of Online Transfer Policy of Ministerial Staff dated 06.03.2020.

Whereas it is germane to mention here that the blocked seats were opened only for the purpose of temporary posting of the clerks who later on

joined the department after the present transfer drive by following the proper criteria and lowered the strength of students from 125 to 55 only for the purpose of temporary posting. It is pertinent to mention here that these new appointees will also have to compete with the order clerks in the next online transfer drive whenever the same will be conducted by the department.

Whereas as per the provision of the policy, allotment of a vacant seat/station to an employee is based on total composite score earned by the employee concerned out of total 80 score points. The employee concerned earning highest score is entitled to be transferred against a particular vacancy. For merit points, age is prime factor for deciding the claim of the employee against a vacancy, as it has weightage of maximum of 60 points out of total 80 points. However, it is worthwhile to mention here that the categories like women, windows, widowers, differently-abled persons, employees with serious ailments have a privilege of maximum 20 points. Therefore, the employees were asked to opt for maximum stations as per their choice suitable to them so that their chances of getting posted on an un-opted station in 'anywhere in the state category' may be reduced. In other words, if a employee could not be transferred against any of the stations preferred by him/her, he/she shall be transferred under '**Anywhere in the State**' category. In case, an employee is to be transferred on an un-opted station in "Anywhere in state" category then Computer Programme/Software, instead of sending them at a distance place, searches for a vacancy nearest to them and put them at that vacancy as per their merit points.

Whereas, according to general principles of the policy, every employee is responsible for the accuracy and regular updation of data on MIS Portal in respect of his/her credentials, otherwise the department is at liberty to transfer him/her, in anywhere category in the state. Employees are liable to be transferred under this policy in any zone or anywhere in the State, in public interest, on completion of prescribed tenure.

Whereas, the score obtained by the petitioners along with the reasons for their transfer are described as under:-



Whereas, Smt. Purnima Gupta [052396] has filed the CWP No.17722 of 2022 in the Hon'ble High Court of Punjab & Haryana, Chandigarh and prayed for quashing the order/clarification dated 16.07.2021/06.09.2021 issued by respondent department, qua 5 marks allocated under para 7 (iii) (b) 9 for Academic Performance, whereby no marks have been allotted to the petitioner as she had not taught any Board classes from last 5 years and she was working as District Science Specialist (non-teaching post).

The writ petition was disposed of vide order dated 10.08.2022. The operative part of the order is as under:-

***"Notice of motion.***

*On the asking of the Court, Mr. Harish Nain, learned Assistant Advocate General, Haryana, who is present in Court, accepts notice on behalf of the respondent-State and raises no objection in deciding the representation dated 02.08.2022 (Annexure P-15) in a time bound manner by passing an appropriate speaking order.*

*In view of the pleadings in the present petition, without expressing any opinion on the merits of the case or the claim being made by the petitioner in the representation, respondent No. 2 is directed to decide the representation dated 02.08.2022 (Annexure P-15), by passing a speaking order within a period of 10 days from the receipt of copy of this order.*

***Present writ petition stands disposed of."***

In compliance of the above said order, the representation dated 02.08.2022 of the petitioner was examined at length. The Government of Haryana framed Teacher Transfer Policy, 2016 which was notified on 29.06.2016 and the same was amended on 01.06.2017 and further amended from time to time. The vision of the policy of 2017 is to ensure equitable, demand based distribution of teachers/heads to protect academic interest of the students and to optimize job satisfaction among its employees in a fair and transparent manner. As per provision of this policy, a teacher has given right to compete against a vacancy of his choice and the teacher earning highest points shall be entitled to be transferred against a particular vacancy through transfer drive and then he/she will be protected for five years. The main object of the policy is to grant

protection of 5 years only to those teachers who got posting by competing with other teachers. Since a right has been given to every teacher to compete against every vacancy if he /she has not already completed 5 years stay against that very vacancy and if protection of 5 years is granted to a teacher of manual posting, then the right of a teacher to compete against that vacancy will be frustrated. Therefore, if the government decided to protect to those teachers who have been transferred through manual mode between two transfer drive then the right of other teacher to compete against that very post will be frustrated and this action will be against the vision of this policy and which is not the intention of the framer of the policy. Online transfer is more fair and transparent than the manual posting as there is no human interference and hence the protection of 5 years stay has been granted to teacher who got posting after competing with other employees. Further, the power of manual posting between two transfer drive has been provided with some check and balances. Further the provisions of the mandatory participation of manual posting in next transfer drive regulates the discretionary power of the authority to whom the power is provided within the provisions of the policy for manual postings. There is a rational nexus to the object which is to be achieved. Further in order to discourage the practices of the teachers seeking manual posting, the condition for mandatory participation in the next transfer drive is imposed in cases of manual transfer order.

That further the issue of mandatory participation for manual posting had also been raised before the Hon'ble High Court in the bunch of cases tagged with CWP No. 15099 of 2021 titled as Ashish Bala V/s State of Haryana and Ors. and the Hon'ble High Court has declined to interfere and dismissed the writ petition.

That the persons who were manually adjusted due to various reasons between the time period of two general transfer drives are liable to compulsorily participate in the next drive and the same has been provided in the un-amended Policy of 2017 itself at Para 2 clause 8(i)b(i) which is reproduced as under:-

**b) Deemed Vacancy:**

- i. Involuntary deemed vacancy: A post of any cadre (whether teaching or non-teaching), held by a teacher previously or presently in the school education department in a regular capacity for a period of five years or more on the qualifying date in present zone of posting; or



A post occupied by a teacher given temporary manual posting due to non-availability of online transfer drive or technical problems or compulsions of administrative or litigational nature.

That Para 2 of 8(i) (b) (i) which was originally consisted in the Teacher Transfer Policy of 2017, was inadvertently left out by the Department while amending the policy in the year of 2021. Thereafter, the same has been incorporated again by the issuance of corrigendum on 25.08.2021.

That the petitioner is governed by the Haryana State Education School Cadre (Group-B) Service Rules, 2012. According to the rules the employee is liable to serve at any place within or outside Haryana. The rule 12 (1) of the 2012 rules is reproduced here under:-

*“A member of the service shall be liable to serve at any place, whether within or outside the State of Haryana on being ordered so to do by the appointing authority.”*

Further, it is relevant to mention here that there are various reasons for manual postings and some of these exigencies are as follows:

- New Appointment:-

Whenever a new employee joins the department, the employee is posted manually to the station as the online mode is available only for the General Transfer Drive which is held once in a year and the department allocate temporary station to him/her with the condition that whenever the department will conduct the online transfer drive he/she will have to participate compulsorily in that drive. Therefore, it is mandatory for the employee to join at the appointed station and to participate in the next transfer drive for permanent posting and further when he/she accepts the appointment order he/she has to give joining at the said station.

- Promotion cases:-

Whenever an employee is promoted to the promotional post, he has to be posted on a fresh station and that exercise is conducted manually with the condition that he/she has to participate compulsorily in the next transfer drive.

- Court cases:-

Whenever a stay has been granted by the Hon'ble Court to any of the transferred employee, then the department has to issue the manual transfer orders for the employee in whose place, such stay has been granted.

- Conversion of normal schools to the Model Sanskriti Schools:-

With a view to provide quality education to the students in the State, the Department has converted some normal schools in the Model Sanskriti Schools in which the students are to be taught under the CBSE pattern and the teachers are also selected in those schools through the screening process. Therefore, the employees who did not applied for Model Sanskriti Schools or were not selected in the interview process were adjusted manually in other schools. Therefore, to provide them proper stations, their participation in the General Transfer Drive is required.

- Administrative Grounds:-

In some cases to conduct a fair enquiry, a person who was transferred at some other place manually or some persons who, by any means were able to get the relaxation in the policy were also liable to participate mandatory in the next transfer drive. It is germane to mention here that in such type of orders it was specifically mentioned that they have to participate compulsorily in the next transfer drive, as in the case of petitioner. She /He will be able to get relaxation in the policy on the recommendation of the District Level Committee.

That in view of the submissions made above, it is clear that the manual transfers had been made with the condition that the employee had to participate in the next transfer drive. The petitioner being well known of the condition had accepted the adjustment order and never filed any grievance with regard to the condition.

That a government employee (i.e. petitioner) or any servant of a Public Service has no legal right to insist for being posted at any particular place and the same has also been upheld by the Hon'ble Apex court on 06.09.2021 in SLP No. 36717 of 2017 in CWA no. 48447 of 2017 in which the Hon'ble Apex Court has held that "*it is not for the employee to insist to transfer him/her and/or not to transfer him/ her at a particular place. It is for the employer to transfer an employee considering the employment.*" It cannot be

disputed that the petitioner holds a transferable post and unless specifically provided in his service conditions, he has no choice in the matter of posting. Since the petitioner has no legal or statutory right to claim his posting at a place of his choice. Therefore, there was no justification impugning the compulsorily participation in the transfer drive.

The petitioner ie. Purnima Gupta [052396] was promoted to the post of Principal on 15.06.2022/17.06.2022 and given temporary posting at GSSS Rampura [1311], Hisar vide order dated 11.07.2022 with the condition that the officer concerned will have to participate in the next General Transfer Drive. Earlier, the petitioner was working as District Science Specialist O/o DEO Hisar from 02.06.2010 to 14.07.2022 and she remained posted on non-teaching post from the last 12 years. It means the petitioner did not taught any board classes from the last 12 years and thus, she is not entitled for 5 marks for well academic performance.

The department has issued the instructions dated 16.07.2021 in which teachers will be entitled to the points on the basis of latest results of board classes taught by her out of the previous five academic sessions only. The petitioner did not taught any classes from the last 12 years. Hence, the petitioner is not eligible to get 5 points.

The petitioner participated in the General Transfer Drive-2022 and got first choice i.e. Shiv Lal Singla Government Girls Senior Secondary School, Hansi [1442], Hisar during the first round of the transfer drive.

Keeping in view the provisions in the rule, there is no force in the representation of the petitioner. Hence, the claim of the petitioner is hereby rejected with direction to join at the new place of posting.

While being posted as Principal, Government Senior Secondary School, Datauli, Sonapat from 23.02.2022 to 02.08.2022, Shri Vinod Kumar committed certain acts of omission and commission for which he is charged as under :-



That Smt Indra Beniwal, Deputy Director office of Director Elementary Education Department, Panchkula was appointed as Inquiry Officer vide order no. 5/169-2022 HRG-I(1) dated 13.07.2022 to enquire into the theft of furniture and other items amounting to Rupees seven lacs purchase by the then Principal, Government Senior Secondary School, Datauli, Sonapat i.e. Shri Vinod Kumar. The Inquiry Officer visited the school on 18.07.2022 and submitted the report on dated 22.07.2022. The following irregularities were found to be committed by him i.e. Shri Vinod Kumar being principal:-

1. That he i.e. Shri Vinod Kumar [072262] being Principal, Government Senior Secondary School Datauli [3548] (Sonapat) procured 200 'Plastic Mouled Chair' from M/s Anmol Merchants, Narender Nagar, Sonapat on 14.03.2022 for an amount of rupees 2,92,050/- @1237.50 per chair vide cheque No. 152786 dated 14.03.2022 and 50 'Plastic stool'@355/- and 5 Wooden Table@4510/- from M/s Anmol Merchants, Narender Nagar, Sonapat on 15.04.2022 for an amount of rupees 47,554/- vide cheque No. 152790 dated 15.04.2022 without any supply order and without constituting committee for inspection and thus, violated the guidelines of Consolidated Children Welfare fund and also violated the purchase guidelines issued by Directorate vide order no. 10/26-2011 Admn (4) dated 01.08.2011. Further, he i.e. Shri Vinod Kumar made two attempts on 10.03.2022 through cheque No. 152784 and 152785 to make payment of Rs 2,92,050/- to M/s Anmol Merchants, Narender Nagar, Sonapat though the invoice for this material was issued on 14.03.2022. Thus, he i.e. Shri Vinod Kumar being principal attempted to make payment to the said merchant without physical delivery of the furniture. Further, he i.e. Shri Vinod Kumar took physical delivery himself of the said furniture without any inspection by the committee which needs to be constituted for this purchase. The procured furniture was placed in the store room but the chowkidar and other staff members were unaware of such purchase which was stolen from the school. An FIR No. 0168 dated 17.05.2022 was registered by him i.e. Shri Vinod Kumar being principal at Police Station HSDIC Brahi, Sonapat Further, Shri Jagbir Singh [079156], Post Graduate Teacher History, GSSS Datauli, Sonapat made statement before the committee that he i.e. Shri Vinod Kumar being principal called him on 16.05.2022 in the school and who reached the school on 16.05.022 with Shri Bijender Singh, Post Graduate Teacher in Mathematics and found that both locks of the main gate were in proper condition but furniture was stolen from the store room. Further, he i.e. Shri Vinod Kumar allowed two days leave for 16.05.2022 and 17.05.2022 to the chowkidar without making any alternate arrangement of chowkidar and thus, the act of the then principal i.e. Shri Vinod Kumar was suspicious
