Whereas, Aruna, Guest PGT History (Emp.ID 5004357) has filed CWP No.21471 of 2022 titled as Aruna v/s State of Haryana and others, for issuance of a writ in the nature of certiorari for quashing the impugned transfer orders dated 11.09.2022 (P-3) for Guest Teachers, vide which the respondent department has transferred the petitioner during transfer drive and allotted Station from Govt. Girls Sr. Sec. School, Jatola (3625) Sonipat to Govt. Sr. Sec. School Sarai Khawaja (998) Faridabad.

The aforesaid writ petition came up for hearing before this Hon'ble Court on 19.09.2022 and the on that day Hon'ble Court was pleased to dispose of with direction to respondents. The operative part of the order dated 19.09.2022 is as under:-

**Notice of motion.**

*Mr. Harish Nain, Assistant Advocate General, Haryana accepts notice on behalf of the respondents and submits that the reasons for challenging the transfers being forwarded by the petitioner(s) are specific to them and in case, the petitioner(s) have already raised their grievances by filing of appropriate representation(s) or any representation, if filed manually till Wednesday i.e. 21.09.2022, will also be accepted and the same shall be looked into by the competent authority within an period of 10 days from today by passing an appropriate speaking order.*

*Learned State counsel further submits that in case, the petitioner(s) have not been relieved till today from the present place of posting then they will be allowed to continue at the present place of posting till the decision of the said representation(s) in case, the same are filed and in case, the petitioner(s) have already been relieved from the present place of posting, they will not be forced to join at the new place of posting till the decision of the said representation(s).*

*Learned counsel for the petitioner(s) submit that keeping in view the statement of the learned State counsel, the present petitions may kindly be disposed of as having been not pressed any further with liberty to the petitioner(s), who are yet to file the representation, to approach the respondents by filing appropriate representation(s) raising their grievances as raised in the present petitions.*

Whereas, the Government of Haryana has framed **Teachers Transfer Policy, 2016** dated 29.06.2016 and the same was amended on 01.06.2017. Thereupon, transfers were made under this amended policy of 2017 to ensure equitable, demand based distribution of teachers/Heads to protect academic interests of students and optimize job satisfaction amongst its employees in a fair and transparent manner. Under this policy all government schools have been categorized into seven zones for the purpose of transfer of teachers and the teacher is eligible to opt any number of schools across the zones available to him in the State. She/He is free to give preferences in order of their suitability. For the purpose of Transfer Drive, the teachers who have already completed a period of 1 year service in a particular zone may seek transfer to some other station, on the other hand following categories of teachers have been asked to participate in the transfer drive compulsorily as per amendment in Teacher Transfer Policy vide Memo No.8/2-2020 CO-1(2) dated 28.06.2022. The same has been provided in clause 8(i)(b)(ii) which is reproduced as under:-

**b) Deemed Vacancy:**

(ii) A post occupied by a guest/contractual/adhoc teacher

That in compliance of the Hon'ble High Court order dated 19.09.2022, the petitioner Aruna, Guest PGT History (Emp.ID 5004357) has submitted his representation on 15.09.2022, which has been examined in view of the provisions of the teacher transfer policy. The transfers of Guest teachers were carried out as per amendment of Teacher Transfer Policy



issued on 28.06.2021. She participated in the transfer drive and got 8<sup>th</sup> preference out of 52 preferences filled by her. As per policy, she has been allocated to Government Senior Secondary School, Khawja (998) Faridabad.

Whereas, it is also submitted here that, a Government employee (i.e. petitioner) or any servant of a Public Service has no legal right to insist for being posted at any particular place and the same has also been upheld by the Hon'ble Apex Court on 06.09.2021 in SLP No. 36717 of 2017 in CWA No. 48447 of 2017 in which the Hon'ble Apex Court has held that **"it is not for the employee to insist to transfer him/her and/or not to transfer him/her at a particular place. It is for the employer to transfer an employee considering the employment."**

In view of the submission made above, the claim of the petitioner as prayed in the petition as well as representation dated 15.09.2022 are not tenable as the transfer of the petitioner has been done as per the provisions of the transfer policy and as per reasons cited supra. Therefore, there is no merit in claim of the petitioner and the same is liable to be rejected, she is directed to join the allotted station.

**Order No. 13/88-2022 PGT-II (6)**

**Dated, Chandigarh, the 20.9.2022**

Whereas, Smt. Parmila Guest PGT Hindi (Emp.ID 5000808) has filed CWP No.21135 of 2022 titled as Parmila & Others v/s State of Haryana and others, for issuance of a writ in the nature of certiorari for quashing the impugned transfer orders dated 11.09.2022 (P-8 & P-9) and the impugned transfer order 13.09.2022 (Annexure P-10), issued by the respondent no.2, while transferring the petitioners, being guest teachers, at a far away stations, in pick and choose manner, allowed 467 guest teachers to remain posted at their present place of posting, with the same stroke, while issuing the notice of the same date 11.09.2022, Annexure P-11. Further prayer for issuance of writ in the nature of mandamus to directed the respondent nos. 1 & 2 to grant the same equitable relief to the petitioners.

The aforesaid writ petition came up for hearing before this Hon'ble Court on 15.09.2022 and the on that day Hon'ble Court was pleased to dispose of with direction to respondents. The operative part of the order dated 15.09.2022 is as under:-

***Notice of motion.***

***Mr. Harish Nain, learned Assistant Advocate General, Haryana, who is present in the Court, accepts notice on behalf of the respondents.***

***Learned counsel for the respondents submits that as per his instructions, order dated 11.09.2022 has already been withdrawn on 12.09.2022 and these 467 posts which are to be treated as "kept vacant" posts as per the transfer policy and are not to be filled up and those Guest Teachers working against those 467 posts will be transferred to a suitable stations. Learned counsel for the respondents submits that sill an appropriate decision with regard to the filling up of these 467 posts or to keep them vacant will be taken by the Government within a period of next two weeks and in case, it is decided that these 467 posts need to be filled up. keeping in view the number of students at a particular station, the appropriate order will be passed giving opportunity to all concerned who are eligible to compete for posting against these posts as well.***



*Learned counsel for the respondents further submits that the grievance which the petitioners have, in case the same is already raised by filing representation or is raised upto Monday i.e. 19.09.2022 by filing any representation, the same will be looked into by the competent authority and appropriate order will be passed within a period of 10 days and further that in case the petitioners have not been relieved from their present place of posting, then they will be allowed to continue at their present place of posting till the decision of the representations and in case, the petitioners have been relieved, they will not be forced to join the transfer place till appropriate order on the representations of the petitioner is passed by the competent authority.*

*Learned counsel for the petitioners submits that keeping in view the statement of the learned counsel for the respondents, the present petitions may kindly be disposed of as having been not pressed any further with liberty to the petitioners to approach the respondents by filing appropriate representation raising the grievance as raised in the present petitions.*

Whereas, the Government of Haryana has framed **Teachers Transfer Policy, 2016** dated 29.06.2016 and the same was amended on 01.06.2017. Thereupon, transfers were made under this amended policy of 2017 to ensure equitable, demand based distribution of teachers/Heads to protect academic interests of students and optimize job satisfaction amongst its employees in a fair and transparent manner. Under this policy all government schools have been categorized into seven zones for the purpose of transfer of teachers and the teacher is eligible to opt any number of schools across the zones available to him in the State. She/He is free to give preferences in order of their suitability. In this regard, it is submitted that transfer of guest teachers were carried as per amendment of Teacher Transfer Policy issued on 28.06.2022/25.08.2021. Hence, orders of 467 guest teachers to remains at their place of posting due to reason that their post was remained unfilled during transfer drive of regular teacher is also cancelled by the department and these all guest were also included in transfer drive.

That in compliance of the Hon'ble High Court order dated 15.09.2022, the petitioner Smt.Parmila (5000808) Guest PGT Hindi has submitted her representation on 19.09.2022, which has been examined in view of the provisions of the teacher transfer policy. The transfers of Guest teachers were carried out as per amendment of Teacher Transfer Policy issued on 28.06.2021. She participated in the transfer drive and got 21<sup>st</sup> preference out of 52 preferences filled by her. As per policy, she has been allocated to Government Senior Secondary School, Sukhchain, Sirsa.

Whereas, it is also submitted here that, a Government employee (i.e. petitioner) or any servant of a Public Service has no legal right to insist for being posted at any particular place and the same has also been upheld by the Hon'ble Apex Court on 06.09.2021 in SLP No. 36717 of 2017 in CWA No. 48447 of 2017 in which the Hon'ble Apex Court has held that "it is not for the employee to insist to transfer him/her and/or not to transfer him/her at a particular place. It is for the employer to transfer an employee considering the employment."

In view of the submission made above, the claim of the petitioner as prayed in the petition as well as representation dated 19.09.2022 are not tenable as the transfer of the petitioner has been done as per the provisions of the transfer policy and as per reasons cited supra. Therefore, there is no merit in claim of the petitioner and the same is liable to be rejected, she is directed to join the allotted station.

**Order No. 13/49-2022 PGT-II (5)**

**Dated, Panchkula the 20.09.2022**

Whereas, Sh. Shamsher (Emp.Id 201820) PGT History has filed CWP No. 17560 of 2022 titled as Vikramjeet Singh & Others V/s State of Haryana and Ors. for quashing the action of the respondents in effecting the transfer through online mode in mid session in total contravention of the Teacher Transfer Policy dated 09.06.2016 (P-1) and amended policy dated 05.06.2017 (P-2), writ of certiorari quashing the action of the respondents in keeping various posts blocked so as to exclude those posts from the Transfer Drive. Further, petitioner prayed for quashing the action of the respondents is not providing the option of YES or No to the petitioner in the Transfer Drive, 2022 as per cutoff date has been mandated by the Teacher Transfer Policy and petitioner prayed to issue writ of mandamus directing the respondents to rectify MIS profile of the petitioners including zones and to upload marks in question in accordance with the transfer policy.

The aforesaid writ petition came up for hearing before this Hon'ble Court on 23.08.2022 and the on that day Hon'ble Court was pleased to dispose of with direction to respondents. The operative part of the order dated 23.08.2022 is as under:-

***Notice of the application to the counsel opposite.  
Mr. Harish Nain, learned Assistant Advocate  
General, Haryana, who is present in Court,  
accepts notice on behalf of respondent-State and  
raises no objection for the grant of prayer as  
raised in the present application.***

*Keeping in view the above, application is allowed and the hearing of the main petition i.e. CWP No. 17560 of 2022 is preponed from Learned counsel for the petitioners submits that the petitioners have a grievance with regard to their compulsory participation in the transfer drive keeping in view*

*the fact of each petitioner as stated in the petition. Learned counsel submits that some of the petitioners have a grievance that as per the transfer policy they are entitled for the marks keeping in view the ailment being suffered either by them or their family members or on some other valid ground as permissible in the transfer policy.*

*Learned counsel for the petitioners further submits that five of the petitioners have a grievance that their zone has not been fixed properly, which is causing prejudice to them. Learned counsel for the petitioners submits that the petitioners have already raised the said grievance before the authorities concerned by filing representations and they will be satisfied, at this stage, in case a time bound direction is issued to decide the said plea of the petitioners.*

*Learned State counsel submits that though a reply has already been filed but he has instructions to submit that the representations filed by the petitioners Annexures P-8 to P-11 will be decided within a period of seven days from today and the transfer, if issued in the meanwhile, will only be implemented after the passing of the order on their representations.*

*Learned counsel for the petitioners submits that keeping in view the statement of learned State*



***counsel, the present petition may kindly be disposed of having been not pressed any further.***

That in compliance of the Hon'ble High Court order dated 23.08.2022, the petitioner, Sh. Shamsheer (Emp.Id 201820) PGT History, submitted his representation dated 24.08.2022 which have been examined in view of the provisions of the policy and it has been found the wife of the Petitioner is suffering from Rheumatoid Arthritis which is not covered under diseases of "Debilitating Disorders under para 6 (iii)(b)(5) of the Teacher Transfer Policy, 2016. Order No. 1/72-2016-eGov.Cell dated 27.06.2016 has been issued in this regard and petitioner never challenged the policy in this petition. Therefore, he is not entitled for getting points. Moreover, the petitioner was included in Drive due to completion of more than 5 years in present Zone and he filled 43 preferences in 1<sup>st</sup> round, but all preferences has been allotted to others who have higher points than him and he was marked for 2<sup>nd</sup> round. He had got 1 choice out of 2 filled in the second round. As per policy, he has been allocated to Government Senior Secondary School, Isharwal (338), Bhiwani in Zone-7.

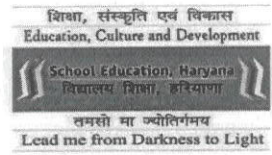
