#### ORDER

Order No. 13/76-2022 PGT-II (7) Dated, Chandigarh, the

Whereas, Karamveer (Emp.ID 211194) PGT Punjabi has filed CWP No. 21132 of 2022 titled as Karamveer v/s State of Haryana and others, for issuance of a writ, order, direction especially in the nature of certiorari thereby quashing the impugned order dated 09.09.2022 (Annexure P-2) qua the petitioner whereby he has been ordered to be transferred from Kurukshetra to Mohindergarh.

The aforesaid writ petition came up for hearing before this Hon'ble Court on 15.09.2022 and the on that day Hon'ble Court was pleased to dispose of with direction to respondents. The operative part of the order dated 15.09.2022 is as under:-

Mr. Harish Nain, AAG, Haryana accepts notice on behalf of the respondents and submits that the representation dated 12.09.2022 (Annexure P-3) moved by the petitioner shall be decided within a period of 10 days from the receipt of copy of this order. In case, the petitioner has not been relieved till today from the present place of posting then he will be allowed to continue at the present place of posting till the decision of the said representation and in case, the petitioner has already been relieved from the present place of posting, he will not be forced to join at the new place of posting till the decision of the said representation.

Whereas, the Government of Haryana has framed **Teachers Transfer Policy, 2016** dated 29.06.2016 and the same was amended on

01.06.2017. Thereupon, transfers were made under this amended policy of 2017 to ensure equitable, demand-based distribution of teachers/Heads to protect academic interests of students and optimize job satisfaction amongst its employees in a fair and transparent manner. Under this policy all government schools have been categorized into seven zones for the purpose of transfer of teachers and the teacher is eligible to opt any number of schools across the zones available to him in the State. She/He is free to give preferences in order of their suitability. For the purpose of Transfer Drive, the teachers who have already completed a period of 1 year service in a particular zone may seek transfer to some other station, on the other hand following categories of teachers have been asked to participate in the transfer drive compulsorily:

- a. A post of any cadre held by a teacher previously or presently in the school education department in a regular capacity for a period of 5 years or more on the qualifying date in the present zone of posting, shall be taken as a deemed vacancy and such teacher shall participate compulsorily in the transfer drive.
- b. Teachers declared surplus from a station as a part of rationalization/Normalization shall also participate compulsorily in the transfer drive.
- c. Teachers who have been given temporary manual posting previously due to non-availability of online transfer drive or technical problem or compulsion

That in compliance of the Hon'ble High Court order dated 15.09.2022, the petitioner submitted his representation on 15.09.2022 which have been examined in view of the provisions of the policy and it has been found that the petitioner Karamveer (Emp.ID 211194) PGT Punjabi was require to compulsorily participate in the transfer drive due to completion of 5 years stay in present Zone-6. He has filled 64 preferences, but all of his



preferences were allocated to other employees having high points and he was marked for round 2<sup>nd</sup>. During round 2<sup>nd</sup> he did not fill any preferences, hence he got station under anywhere category. So, he has been transferred as per provisions of the transfer policy.

In view of the submissions made above, the contention of the petitioner in the representation dated 15.09.2022 is not tenable as the transfer of petitioner is done as per the provisions of the transfer policy and as per reasons cited supra. Therefore, there is no merit in the representation of the petitioner and the same is liable to be rejected.

I order accordingly.
