





Terms and conditions:-

1. His appointment is against a purely temporary post which is liable to be abolished at anytime and carries no promise of subsequent permanent employment. No offer of permanent vacancy can be made to them at present. His services can be terminated without any notice, whenever there is no vacancy against which he can be retained.
2. If at any stage he desires to resign his post he will be required to give one month's notice or forfeit in lieu thereof, his salary including allowances for one month or for the period by which the notice falls short of one month. Such a notice will be given to him by the Directorate Secondary Education, Haryana, Panchkula in case it is proposed to terminate his services for the reason other than that mentioned in clause (I) above.
3. He will be required to take the prescribed oath of allegiance to the constitution of India.
4. In case any candidate is married, he will have to furnish a declaration to the Head of the Department that he has not taken any dowry after marriage. The declaration should be signed by his wife, father and father-in law, as per Chief Secretary to Govt. Haryana letter No. 18/1/2004-2GSI dated 21.02.2006."
5. In case he is unmarried, he will have to furnish a declaration to the effect that each of these will not have more than one living spouse.
6. The candidate will have to qualify the State Eligibility Test in Computer Appreciation and applications (SETC) within the probation period of two years, extendable by one year in case of direct recruitment. The candidate appointed against the aforesaid categories of posts in the group 'C' shall not



- be entitled to earn any increment in his pay scale till he/she qualifies the said test failing which the services of such employees shall be dispensed with.
7. He will not undertake higher studies of any kind without prior permission of the competent authority. Consequently, no leave of any kind will be granted for the pursuing of higher studies.
 8. He will be required to produce the original Educational documents and date of birth certificate before joining his duties of the said post.

 15. His services will be governed under the "NEW DEFINED CONTRIBUTORY PENSION SCHEME" of the Haryana Government as per Finance Department's notification dated 28.10.2005.
 16. All recommended candidate is subject to the verification of Socio-economic criteria marks and other qualification by the department. If any candidate is found taken fake/false benefit of Socio-economic criteria, then he/she will be ousted from the selection list and candidature may also be cancelled.


