Whereas, Sh. Sanjay Kumar had filed a CWP No. 18682 of 2021 titled as Sanjay Kumar vs. State of Haryana & others before the Hon'ble Punjab and Haryana High Court praying therein to direct the respondents to consider the petitioner under Mewat Cadre by considering the service rendered by the petitioner w.e.f. his date of appointment i.e. 21.11.2012 to till date as qualifying service for the purpose of seniority, promotion and other consequential service benefit as per the rules an option had to be given within 3 months once the rules came into force, but the same was not done by the Authority, therefore, as per policy 2012, petitioner is entitled to be considered in Mewat Cadre, but till date the petitioner has not been considered under Mewat Cadre.

The Hon'ble Punjab & Haryana High Court disposed of said petition on dated 05.09.2022 with following orders:-

***"....Learned counsel for the respondents submits that in case, representation dated 18.11.2020 (Annexure P-4) has not been decided so far, appropriate order on the said representation will be passed by the respondents within a period of eight weeks from the receipt of copy of this order.***

***Keeping in view the above, no grievance of the petitioner survives in the present petition and the present petition is disposed of keeping in view the undertaking of the learned counsel for the respondents as recorded hereinbefore."***

In compliance of above said order, the representation dated 18.11.2020 of Sh. Sanjay Kumar, PGT English has been duly examined and it is found that he was appointed as Lecturers (PGT English) school cadre in School Education Department Haryana vide order No. 6/13-2012 HRL (4) dated 23.11.2012.

Whereas, in 2012, the department created two separate cadres namely Mewat Cadre and Rest of Haryana Cadre. Further, School Education (Group B) Service Rules, 2012 were also drafted for the employees posted in the Mewat District. Subsequently, a tentative seniority list of PGT (Mewat Cadre) was made on 05.04.2017. Consequently, some of the similarly situated employees challenged this tentative seniority list by filing a CWP No. 11285 of 2017 titled Ramesh Kumar & Ors. vs. State of Haryana & Ors. The Hon'ble High Court disposed off the Writ Petition on 22.05.2017 with the following directions:-

**“.....Petitioners have questioned the tentative seniority list of Lecturers (Mewat Cadre) as on 05.04.2017. The petitioners are stated to have submitted objections to the same. The concerned respondent has not considered the objections and suggestions and finalized the seniority list. Writ petition is premature. The concerned respondent is hereby directed to consider petitioners' objections/suggestions with reference to tentative seniority list and finalize the same and communicate to the petitioners at the earliest.**

**With the above observations, petition stands disposed off”.**

Whereas, in view of the above said order, the Department gave option on 07.11.2017, 14.11.2017 and 20.11.2017 to the all Post Graduate Teachers to opt for either Mewat Cadre or Rest of Haryana Cadre. Thereafter, the Department again on 12.12.2017 and 20.12.2017 has given option and Gurugram District to opt for either Mewat or Rest of Haryana Cadre as well as to raise objections regarding the tentative Seniority list if any. Sh. Sanjay Kumar miserably failed to submit his option despites number of opportunities given to him.

Whereas, the Department has again given option via online mode on 05.04.2022 to 21.04.2022 to the all Post Graduate Teachers to opt for either Mewat Cadre or Rest of Haryana Cadre. As per the report vide dated 02.09.2022 of the District Education Officer, Nuh (Mewat Cadre), Sh. Sanjay Kumar has again not chosen Mewat Cadre as per option given to all the Post Graduate Teachers.

Since, the Department has already prepared the tentative Seniority list of Post Graduate Teachers (Mewat Cadre) on dated 01.06.2022 as per the options received through District Education Officers and objections has also been invited from all the Post Graduate Teachers vide letter No. 15/13-2022 PGT-I (4) dated 31.08.2022 and disturbing the same will cause the infringement of right of employees in the above said list.

In view of the facts mentioned above, representation of Incumbent and documents on record, the claim of Sh. Sanjay Kumar is not tenable & hereby rejected being devoid of merits.

It is ordered accordingly.
