The CEO shall forward only such proposal(s) that are cleared by the aforesaid Screening Committee, to the Commission alongwith his/her comments immediately.

3. The proposals to be sent to CEO, Haryana after clearance by Screening Committee should be sent online by uploading on cVIGIL app of the ECI. Password & user Ids provided to Administrative Secretaries during the recently concluded Lok Sabha and Haryana Vidhan Sabha Election, 2019 may be used.
