Sir/ Madam,

It is hereby intimated that HAFED is setting-up a Mega Food Park at Industrial Model Township (IMT), Rohtak under the Mega Food Park Scheme of the Ministry of Food Processing Industries (MOFPI), Govt. of India which is spread across 50 acres. It has plots varying from 450 to 4050 sq. mtrs in size. Units relating to Food Processing Units, Bakery and flaking Products, Canning, Dal and Rice milling, Instant traditional foods, Multi Crop Processing Line (Fruits and Vegetable), Oil Extraction (Anchor unit), Ready mix snacks and sweets, Ready to Serve Juices and Beverages, Ripening, RTE Food, Spice processing and packaging, Integrated Milk processing and tetra packaging, Animal feed formulation etc., can be set up by the Investors in this Mega Food Park. The common core processing facilities like Multipurpose Cold Store, Deep Freezer, IQF with processing line, Boiler, Warehouse and Silos etc., have been/ are being setup by HAFED, which will be available to the units on rental basis at Mega Food Park Rohtak. As per the schedule, **the registration of the prospective bidders has been started from 15.09.2022 and the last date of registration is 14.10.2022, the tentative e-Auction will be start w.e.f. 28.10.2022.**
