Whereas, Sh. Satish Kumar PGT Hindi at Govt. Model Sr. Sec. School Krishanpura, Distt. Panipat has filed CWP No. 27684 of 2018 titled as Satish Kumar Vs State of Haryana with the prayer to quash the order dated 26.09.2018 vide which the claim of the petitioner for pay protection on account of service rendered by him in Kendriya Vidyalaya Sangthan (KVS) was rejected.(P-20).

Whereas in the above said writ petition, the petitioner has cited example of Smt. Vimla Kumari PGT Chemistry GSSS Kheri Kalan (Faridabad) now at GSSS Badkhal (Faridabad) who has been granted the benefit of pay protection on account of service rendered by her in KVS New Delhi from 31.01.1994 to 30.06.1999 vide order No. 10/4-2001 E-IV(1) dated 21.01.2004/29.01.2004.

Whereas on examination it is found that Smt. Vimla Kumari, PGT Chemistry has been granted the above said benefit of pay protection inadvertently. Actually she is not entitled for this benefit in view of the Rule 4.4 of Punjab Civil Service Rule Vol.-I Part-I read with Rule 1.2(i) Punjab Civil Service Rule Vol.-I Part-I. As per the aforesaid rules the benefit of pay protection is to be granted only to those employees who have rendered previous service under Haryana Govt. However, Smt. Vimla Kumari, PGT Chemistry has rendered previous service under KVS which is Central Autonomous Body.

Further, as per instruction No.1/2/77/87-2FR/IT dated 20.08.1988 an employee who has shifted from a Central Autonomous Body to Haryana Govt. Service will be entitled to the benefit of past service towards pensionary benefits only, subject to fulfilment of terms & conditions.

Finance Department Haryana has advised vide U.O. No. 1/54/2017-4PR (FD) dated 29.11.2017 in a separate case, that there is no any provision in CSR Vol.-I Part-I to grant the benefit of past service in the central Govt. or any other State Govt. towards pay, on subsequent appointment in State of Haryana.

In view of above, it emerges that Smt. Vimla Kumari, PGT Chemistry has been granted the aforesaid benefit wrongly.

Therefore, show cause notice is served upon Vimla Kumari, PGT Chemistry, GSSS Kheri Kalan (Faridabad) now at GSSS Badkhal (Faridabad) as to why the benefit of pay protection granted vide order No. 10/4-2001 E-IV(1) dated 21.01.2004/29.01.2004 may not be withdrawn. If, any representation, you want to submit in this regard that will be considered under the Rules, which should be reached in the Directorate of Secondary Education not later than 15 days from the receipt of this notice. In case of failure, the Department shall be at liberty to take a decision ex-parte.


