Smt. Nirmal Dahiya [006645], Deputy District Education Officer is hereby informed that it is proposed by the Governor of Haryana to take action against her under rule 7 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016, on the grounds set out in the enclosed statement of charges. The charges are based on the statement of allegations appended thereto.

2 Smt. Nirmal Dahiya is hereby required to state in writing within a period of 15 days from the receipt of this memorandum by her whether she admits the truth of all, or any, of the charges, what explanation or defence, if any, she has to offer and whether she desires to be heard in person.

3 Smt. Nirmal Dahiya is hereby further informed that if for the purpose of preparing her written statement, she wishes to have access to the relevant official records, she should inspect the same in the office of the Director General Secondary Education Haryana, Panchkula, on any working day after making prior appointment with him. It is, however, pointed out that only such documents will be shown to her as are in the possession of the Director, Secondary Education, Haryana, Panchkula, and as are strictly relevant to the case. If in the opinion of the Government, it is not desirable in the public interest, to allow her access to any document, such access shall be refused. If, Smt. Nirmal Dahiya wishes to consult any other relevant record, which is not in the custody of the Director General Secondary Education Haryana Panchkula it is for her to undertake its inspection. It is, however, made clear to Smt. Nirmal Dahiya that her failure to inspect the documents shall not constitute a valid ground for delay in the submission of her written statement and if the written statement is not received by the undersigned within the specified period, it shall be presumed that she has none to submit.

4 The written statement should be submitted direct to the undersigned.

Statement of allegation against Smt. Nirmal Dahiya [006645] the then Block Elementary Education Officer, Bhiwani [now Deputy District Education Officer office of District Education Office, Mahendergarh (4120)].

While being posted as Block Elementary Education Officer, Bhiwani from 16.06.2014 to 20.08.2020 having the additional charge of Block Education Officer, Bhiwani from 19.09.2019 to 20.08.2020, Smt Nirmal Dahiya committed following acts of omission and commission:-

That a committee of four members was constituted by the Director Secondary Education, Panchkula vide order no. 13/126-2021 HRME-I(3) dated 15.09.2021/20.09.2021 and Shri Surjeet Singh, Deputy District Attorney was appointed as chairman of said committee vide order no. 13/126-2021 HRME-I(3) dated 14.10.2021/18.10.2021. Further, said committee submitted its report dated 17.12.2021, wherein the following irregularities were found to be committed on her part i.e. Smt Nirmal Dahiya:-

That she i.e Smt Nirmal Dahiya extended the benefit of arrears amounting to Rupees 5,17,245/- of pay fixation to Shri Jai Bhagwan, Peon posted in the office of Block Education Office, Bhiwani w.e.f. 19.08.2014 on the basis of photocopy of order no. E-1/2019/6997-7052 dated 30.12.2019 though the aforesaid order was modified by passing order no. E-1/2019/7056-7131 dated 31.12.2019 whereby benefit of notional pay fixation was to be granted. Thus, payment of arrears of Rupees 5,17,245/- was released to Shri Jai Bhagwan, Peon which was not admissible to him. As such, she i.e. Smt Nirmal Dahiya implemented the photocopy of order dated 30.12.2019 though this order was modified vide order no. E-1/2019/7056-7131 dated 31.12.2019 and failed to ascertain the sanctity of photocopy of orders dated 30.12.2019.

In this way, she i.e. Smt Nirmal Dahiya performed her duty in a negligent and irresponsible manner and violated the provisions of rule 4(1)(i)(ii) and (iii) and (2) of the Haryana Civil Services (Government Employees Conduct) Rules, 2016. Thus, she i.e. Smt Nirmal Dahiya caused a total loss of rupees 5,17,245/- to the State Exchequer.

The lapses detailed above constitute grave misconduct on the part of Smt. Nirmal Dahiya [006645] the then Block Elementary Education Officer, Bhiwani [6820], Bhiwani (now posted at Deputy District Education Officer (4098), Mahendergarh), rendering her liable for strict disciplinary action under rule 7 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016.

Statement of charges against Smt. Nirmal Dahiya [006645] the then Block Elementary Education Officer, Bhiwani [now Deputy District Education Officer office of District Education Office, Mahendergarh (4120)].


While being posted as Block Elementary Education Officer, Bhiwani from 16.06.2014 to 20.08.2020 having the additional charge of Block Education Officer, Bhiwani from 19.09.2019 to 20.08.2020, Smt Nirmal Dahiya committed following acts of omission and commission for which she is charged as under:-

That a committee of four members was constituted by the Director Secondary Education, Panchkula vide order no. 13/126-2021 HRME-I(3) dated 15.09.2021/20.09.2021 and Shri Surjeet Singh, Deputy District Attorney was appointed as chairman of said committee vide order no. 13/126-2021 HRME-I(3) dated 14.10.2021/18.10.2021. Further, said committee submitted its report dated 17.12.2021, wherein the following irregularities were found to be committed on her part i.e. Smt Nirmal Dahiya:-

That she i.e Smt Nirmal Dahiya extended the benefit of arrears amounting to Rupees 5,17,245/- of pay fixation to Shri Jai Bhagwan, Peon posted in the office of Block Education Office, Bhiwani w.e.f. 19.08.2014 on the basis of photocopy of order no. E-1/2019/6997-7052 dated 30.12.2019 though the aforesaid order was modified by passing order no. E-1/2019/7056-7131 dated 31.12.2019 whereby benefit of notional pay fixation was to be granted. Thus, payment of arrears of rupees 5,17,245/- was released to Shri Jai Bhagwan, Peon which was not admissible to him. As such, she i.e. Smt Nirmal Dahiya implemented the photocopy of order dated 30.12.2019 though this order was modified vide order no. E-1/2019/7056-7131 dated 31.12.2019 and failed to ascertain the sanctity of photocopy of orders dated 30.12.2019.

In this way, she i.e. Smt Nirmal Dahiya performed her duty in a negligent and irresponsible manner and violated the provisions of rule 4(1)(i)(ii) and (iii) and (2) of the Haryana Civil Services (Government Employees Conduct) Rules, 2016. Inquiry report

That a CWP No. 16002 of 2021 was filed by Sumer Singh and others in the Hon'ble High Court praying herein for the issuance of a writ in the nature of certiorari quashing order dated 31.12.2019 (**Annexure P-5**), to the extent of converting the actual benefits to notional benefits despite the fact that the petitioners continuously worked with respondents and further seeking quashing of order dated 18.06.2021/30.07.2021 (**Annexure P-6**) vide which respondent no. 3 directed the respective Head of Schools to make recovery of arrears if any granted to any class IV employee.

This case was listed for hearing on 19.08.2021, on that day, the Hon'ble High Court was pleased to pass the following order:-


"Inter alia contends that vide order dated 30.12.2019 (Annexure P-2) benefits of regularization were given with all consequential benefits. On the very next day on 31.12.2019 (Annexure P-5) the matter was rectified to the extent that only notional benefits were to e given.

It is apparent in spite of that payment have been released to the petitioners and thus, now recovery is being effected vide impugned order (Annexures P-7 to P-11), which are now subject matter of challenge.

Notice of motion.

Mr. Harish Kumar Nain, AAG, Haryana accepts notice on behalf of the respondents.

This court is of the opinion that the matter needs to be looked into at a higher level by the competent authority as to how payments have been disbursed to the petitioners and similarly situated persons, in spite of the fact that the order was rectified on the very next day.



Let, appropriate affidavit be filed as to what action has been taken against the delinquent officers. Status report be filed by the next day of hearing.

In view of the apparent fraud with the State exchequer, this Court is of the opinion that it is not a fit case for granting stay."

After receipt of the aforesaid order, a Committee of following officers/officials was constituted by the Director Secondary Education, Haryana, Panchkula vide order dated 14.10.2021, the committee under the Chairmanship of Deputy District Attorney was constituted to inquire into the matter as to how payment has been disbursed to the petitioners and similarly situated persons in spite of the fact that the order was rectified on the very next day.

- i) Surjeet Singh, Dy. D.A., Chairman
- ii) Vinod Sharma, A.O, Member
- iii) Narender Dhattarwal, B.O, Member
- iv) Fakirchand, Asstt., Member

After receiving the order dated 14.10.2021, Inquiry Committee (hereinafter referred to as Committee) convened its first meeting on 18.10.2021 wherein it was decided to seek the information from the District Education Officer Bhiwani in prescribed format with regard to the payment made to the employees mentioned in (Annexure P-2) of the CWP NO. 16002 of 2021 through E-mail of the Department latest by 4:00 PM on 19.10.2021.

Thereafter, the second meeting of the Committee was held on 21.10.2021 to examine the report submitted by the District Education Officer, Bhiwani and after perusal of the report it was observed that information regarding 14 employees out of 39 has been provided which was also not satisfactory. Therefore, the District

Education Officer, Bhiwani was again requested to submit the record in respect of all the 39 employees through E-mail till 4:00 PM on 21.10.2021. The next meeting of the Committee was held on 22.10.2021 wherein Sh. Ajit Singh District Education Officer, Bhiwani alongwith Sh. Rajesh Assistant was present with record at the Headquarter. In the meeting the information (A-1) received from the DEO, Bhiwani was perused and examined. After perusal of the information, it was observed that the difference of amount which has been paid in excess i.e. beyond their admissibility has not been mentioned in the report. So, the District Education Officer, Bhiwani was requested to prepare the said calculation chart showing the difference of amount that was actually due and drawn by the DDOs of the concerned school/head of the institution regarding each employee. In the meeting, it was also decided by the Committee to visit the O/o District Education Officer, Bhiwani on 27.10.2021 to get the statement of members of District Level Committee, DDOs concerned, employees concerned and clerks of the school/office and also to examine the relevant record pertaining to these employees.

On 27.10.2021, the inquiry committee visited the O/o District Education Officer, Bhiwani. Firstly, the copy of dispatch register (A-2) and the noting of the District Level Committee (A-3) whereupon a decision to pass the order dated 30.12.2021 and 31.12.2021 was taken was received from the O/o District Education Officer, Bhiwani to check as to whether the said orders were dispatched to the concerned BEOs and DDOs of the schools or not.

As per the copy of dispatch register, the order dated 30.12.2019 was dispatched to the Director Secondary Education, BEO Bhiwani, Tosam, Bawanikhera, Loharu, Kairu, Behal, concerned head of the institutions,



Treasury Officer Loharu, Tosam, Siwani, Ch. Dadri and Bawanikhera bearing no. 6997-7052 and the order dated 31.12.2019 has been shown to be dispatched to all the officers mentioned herein before vide Dispatch No. 7056-7131.

As per noting dated 20.12.2019 of DEO as per noting dated 20.12.2019 DEO (A-3), it was decided to grant the benefit of regularization to the class (IV) employees with effect from the dates mentioned against their names (i.e. 19.08.2014). The DEO signed the proceeding on 26.12.2019 thereafter vide noting/order dated 30.12.2019 the benefit of arrear was decided to be given notionally. This proceeding does not bear the signature of District Education Officer, Bhiwani. The DEO recorded his comments on the proceeding on 31.12.2019 as under:-

"Notional benefits may be granted to all the aforesaid eligible Class (IV) employees as they have not actually worked from the entry date. It is appropriate to give ante-dated regularization after fixing their pay notionally."

This proceeding does not bear signature of any other official of office of District Education Officer, Bhiwani.

Before the Committee, the District Education Officer also submitted his statement (A-4) in response to the payment of arrears made by the DDOs to their Class IV employees. In his statement, he stated that Sh. Santosh Kumar, Asstt. has helped the employees in getting payment of arrears by receiving huge hush money. When the matter came to his notice, he made a complaint (A- 4/1) of Sh. Santosh Kumar, Asstt. to the Director Secondary Education, Haryana, Panchkula vide letter no. Steno-2021/564 dated 15.06.2021 on the basis of record sought from the concerned DDOs regarding making

payment illegally to class IV employees in compliance of CWP No. 16086 of 2019 titled as Puspa Devi Vs. State. He also annexed the copy of said complaint alongwith 80 enclosures containing order dated 30.12.2019 and 31.12.2019 (impugned order) the information of the DDOs regarding the payments made by them to the Class IV employees working under their control and treasury bills etc. Out of these some papers are not legible.

As is evident from the report dated 21.10.2021 and statement **(A-4)** o/o DEO that 14 employees out of 39 employees have been made the payment of arrear amounting to Rs. 71,34,625/- in view of the order dated 30.12.2019 by the concerned DDOs. In this regard, all the DDOs, Clerks and the beneficiary employees were also called upon to appear before the Inquiry Committee on 27.10.2021. Accordingly, all the said employees became present before the Committee and the statement of each DDO, Clerk and Employee was recorded. The schoolwise detail of their statements is as under:-

- (i) Sh. Sumer Singh, Peon posted at GGSSS Gagarwas in his statement **(B-1)** has stated that he got the letter of arrear from Sh. Santosh dealing clerk of the O/o District Education Officer, Bhiwani on 28.02.2020 and thereafter the same was submitted in the O/o GGSSS Gagarwas. Sh. Jaibir Singh Principal/DDO GGSSS Gagarwas in his statement **(B-2)** has stated that he got the letter on 28.02.2020 through his Peon Sh. Sumer Singh. Thereafter, arrear of Rs. 418857 was drawn by him. He has started recovery of arrear from September. The letter dated 31.12.2019 was received by him on 15.10.2020 through E-mail of BEO, Loharu.
- (ii) Smt. Ramesh Devi, Sweeper posted at GSSS Roopgarh, Bhiwani has stated in her statement

(C-1) that the copy of order was received by Vinit Kaushik, Clerk from the O/o District Education Officer, Bhiwani. There was no demand of money from her in this regard. She was paid arrear on 19.03.2020 by the school.

Smt. Shakuntla the then Principal GSSS Roopgarh, Bhiwani has stated in her statement (C-2) that the letter of District Education Officer, Bhiwani was provided by the employee herself. She drew the arrear amounting to Rs. 527817/- on 17.03.2020 after getting it verified by Section Officer. There was no demand of money in this regard.

Sh. Vinit Clerk O/o GSSS Rajgarh Bhiwani stated in his statement (C-3) that he received the copy of letter regarding arrear from O/o DEO in March 2020 on the basis of that letter the payment of amount was made after getting the pay fixed as on 17.03.2020. NO amount was taken for this letter. They have not received the second letter through email.

- (iii) Sh. Sawaran Kumar Sweeper posted at GSSS Kirawar stated in his statement (D-1) that he got the letter of his salary arrear of Rs. 517245 by hand from Sh. Santosh Kumar of District Education Officer, Bhiwani.

Sh. Omparkash Peon, posted at GSSS Kirawar stated in his (D-2) that the copy of orders was received from Sh. Santosh Kumar, Asstt. by hand and he has got an amount of Rs. 56655 as arrear.

Sh. Virender Kumar PGT, Geography/DDO GSSS kirawar in his statement (D-3) has stated that he was DDO from 09.09.2020 to 13.10.2021. The arrear of Class IV employee was drawn by Sh. Rajmal Principal (Now BEO Matanhail) he has

issued notice of recovery of arrear to the Class IV employee.

Sh. Krishan Kumar Clerk of GSSS Kirawar stated in his statement (D-4) that he received the letter of District Education Officer, Bhiwani from Sh. Omparkash Peon and Sh. Sawaran Kumar Sweeper by hand which was handed over by him to the DDO in April, 2020. On the direction of DDO he drew the arrear of these employees with effect from 19.08.2014.

- (iv) Sh. Jaibhagwan Peon posted at DEO, Bhiwani stated in his statement (E-1) that he went to collect Dak from the O/o District Education Officer, Bhiwani and Sh. Santosh Clerk has called him and give him service book and orders.

Sh. Amit Kumar Clerk, O/o BEO, Bhiwani stated in his statement (E-2) that regarding withdrawal of arrears of Sh. Jaibhagwan Peon, Sh. Sanjay Clerk (Establishment Branch) had given copy of order and pay fixation asked to draw the arrears. Then he had withdrawn the arrears of Sh. Jaibhagwan Peon.

Smt. Nirmal Dahiya, the then BEO, Bhiwani now Dy. DEO in the O/o DEEO, Bhiwani stated in her statement (E-3) that after verification from Section officer O/o DEO, Bhiwani, the arrear were withdrawn. The matter was submitted before her by the then dealing.

- (v) Sh. Naresh Kumar, Peon posted at GSSS Baganwala stated in his statement (F-1) that he has got the letter of arrear on 08.03.2020 from Sh. Santosh Clerk, O/o DEO, Bhiwani and which was given by him to ESHM. Thereafter, pay was fixed and second letter dated 31.12.2019 was received through E-mail from BEO, Tosam to the

Head Master. He has further submitted that the amount of arrear Rs. 586926 will be deposited through challan with a week.

Sh. Mandeep ESHM GMS, Baganwala stated in his statement **(F-2)** that an amount of arrear of Rs. 586926 in respect of Sh. Naresh Kumar was withdrawn in compliance of letter dated 30.12.2019 of DEO, Bhiwani which was provided by Sh. Naresh Kumar in the month of March, 2020. Later on pay was fixed and verified by Section Officer on 15.05.2020 and arrear was drawn. The letter no. E-1-2019/7056-7131 dated 31.12.2019 was received from the E-mail of BEO, Tosham on 20.10.2020.

- (vi) Sh. Satyavir Singh, Peon posted at GSSS, Chahar Kalan Bhiwani stated in this statement **(G-I)** that he had filed a court case. His counsel has handed over the copy of judgment to him and had directed to submit his service book in the O/o District Education Officer, Bhiwani. He handed over his service book to the concerned dealing in March, 2020 then after getting his pay fixation verified from Section Officer he submitted his service book in GSSS Chahar Kalan. Thereafter, the Principal had drawn his salary and arrear.

Principal of GSSS Chahar Kalan submitted his office order no. 26/20 dated 18.03.2020 and his statement **(G-2)** wherein he stated that in compliance with District Education Officer Bhiwani order no. E-1-2019/6997 - 7052 dated 30.12.2019 and as per direction issued by Hon'ble High Court in CWP No. 16086 of 2016 the ante dated benefit of regularization of service with effect from the date of regularization of his Junior counterpart has been granted to Sh. Satyavir

Singh, Peon i.e. with effect from 19.08.2014 instead of 25.04.2017. During the course of hearing, he also been submitted a letter dated 26.10.2021 wherein he has stated that the pay fixation documents duly verified by Section Officer were provided to him by the employee himself. Thereafter, his arrear has been drawn.

- (vii) Sh. Ramkishan Peon posted at GHS, Bidhnoi in his statement **(H-1)** that on 09.03.2020 after collective his service book from the school record submitted the same on the O/o DEO, Bhiwani with Sh. Santosh Clerk to complete the same in order to draw the arrear. His service book was given to him from DEO, Bhiwani on 15.03.2021 after fixation of the pay which was deposited the school. The arrear was withdrawn.

Sh. Sunil Kumar, Clerk, GSSS Bidhnoi stated in his statement **(H-2)** that he has joined on 15.08.2020 in the said school. The copy of the letter of DEO, Bhiwani no. E-1-2019/7056-7131 dated 31.12.2019 was received through E-mail on 15.10.2020 and he had informed regarding the same to the incharge of the school Sh. Pardeep kumar, PGT Sanskrit intimated to the DDO that action may be taken by granting notional benefits to him. On 15.03.2021 Sh. Ramkishan Peon of the school has given service book alongwith pay fixation orders. Thereafter, he was asked to draw the arrears of Sh. Ram Kishan Peon but he denied that he has been granted the benefit of notional benefits. But DDO verbally told him that all the schools have drawn the arrears so he may submit the bill for his signatures and deposit the same in the treasury. An amount of Rs. 498573 was drawn



by the orders of Department and DDO Sh. Pardeep Kumar, PGT Sanskrit.

Sh. Jagdish Kajal, Principal GSSS, Bidhnoi stated in his statement **(H-3)** that Sh. Ramkishan Peon is working with effect from 22.04.2017 in GSSS Bidhnoi on 22.05.2020 the pay of the said employee was refixed from the Section Officer in the O/o DEO, Bhiwani with reference to DDO Bhiwani order no. E-1-2019/6997-7052 dated 30.12.2019. The said record was deposited by Sh. Ramkishan Peon in the office on 19.03.2021 arrear was drawn. DEO, Bhiwani letter no. E-1-2019/7056-7131 dated 31.12.2019 was received on 15.10.2020 through E-mail.

- (viii) Sh. Dayanand Peon posted at GSSS Gohlpura in his statement **(I-1)** stated that the copy of letter was received in February/March, 2020 the copy of sanction of DEO, Bhiwani. He went to the O/o DEO, Bhiwani and the orders was given to him by the employee of DEO, Office whose name and dated he did not photocopy of the orders was given to the school.

Sh. Nanu Singh Clerk, GSSS Gohlpura Bhiwani stated in his statement **(I-2)** that in compliance of letter no. E-1-2019/6997-7052 dated 30.12.2019 arrear was withdrawn amounting to Rs. 611618. The letter of recovery no. E-4-2021/948-960 dated 30.07.2021 was received through E-mail and the recovery is being made from the month of September.

Smt. Mitesh PGT, Sanskrit GSSS Gohlpura stated in her statement **(I-3)** that an amount of Rs. 611618 was withdrawn in compliance of DEO, Bhiwani letter dated 30.12.2019. Later on after

receipt of E-mail dated 30.07.2021 arrear is being recovered from the month of September.

- (ix) Sh. Ajmer Peon, posted at GSSS Ratera stated in his statement **(J-1)** that letter was given to him by hand by Sh. Santosh Clerk, Bhiwani which was given to Sh. Vikash Mehta Principal on 08.03.2020. The second letter dated 31.12.2019 was given by Sh. Santosh Clerk O/o DEO, Bhiwani in August, 2020 which was given to Sh. Vikash Mehta Principal.

Sh. Surender Singh, Clerk GSSS Ratera stated in his statement **(J-2)** that arrear of Rs. 431490 was drawn with reference to letter dated 30.12.2019 he went to DEO, Bhiwani to collect second letter alongwith Sh. Ajmer Singh, Peon.

Sh. Vikash Mehta, Principal GSSS Ratera stated in his statement **(J-3)** an arrear of Rs. 431490 of Sh. Ajmer Singh was withdrawn. The letter dated 30.12.2019 was provided by Sh. Ajmer Singh on 08.03.2020. Thereafter pay was fixed on 12.03.2020 through Section Officer of DEO, Bhiwani. The Bill of arrears was deposited on 17.07.2020 in the treasury on which Treasury Officer raised objection. Then second letter dated 31.12.2019 was collected by Sh. Surender Singh, Clerk and Sh. Ajmer Peon in the month of August, 2020. The Budget was demanded from DEO, Bhiwani on 15.05.2020. DEO, Bhiwani allotted the budget on 15.05.2020. The recovery of Rs. 6000 per month has been started from August, 2020 from the concerned employees. The balance amount will be deposited within 7 days by way of challan.

- (x) Sh. Umed Singh Principal, GSSS Miran, Bhiwani stated in his statement **(K-1)** that Sh. Sandeep

Clerk of the school in compliance of letter dated 30.12.2019 of DEO, Bhiwani withdrawn amount of Rs. 550938 on 27.05.2021 in respect of Sh. Sawaran Kumar, Peon. Now, the letter regarding recovery was received from DEO, Bhiwani vide no. E-4-2021/948-960 dated 30.07.2021 but they have already recovered the amount on 30.06.2021 and deposited in SBI through challan.

- (xi) Smt. Neelam Peon posted at GHS, Simli stated in her statement (L-1) that the arrear of pay was withdrawn by the Head Master of the school and the letter of directions in this regard was given by hand by Sh. Santosh of the O/o DEO, Bhiwani which was issued on 30.12.2021.

Sh. Satish Kumar Head Master GHS Simli stated in his statement (L-2) that the letter regarding withdrawal of arrear of Smt. Neelam Devi Class (IV) was given by her to him and as per her statement the said letter was collected by her from the then clerk Sh. Santosh after fixation of pay by Section Officer of the O/o DEO, Bhiwani arrear was withdrawn. Excess amount of arrear alongwith interest was deposited on 31.01.2021.

- (xii) Smt. Gindo Devi, Peon posted at GGSSS Dighawa Jatan stated in her statement (M-1) that letter of arrear was collected from DEO, Office in May, 2020 by her and given to DDO of the school. DDO handed over him letter to fixation on 20.05.2020 and she after fixation of pay by Section Officer Bhiwani given letter to DDO. DDO on 09.10.2020 deposited amount of arrear Rs. 361853 in her account.


Anil Kumar Clerk, GGSSS Dighawa Jatan stated in his statement (M-2) that the letter of arrear was given to him by Smt. Gindo Devi. DDO gave him

the documents of pay fixation of Smt. Gindo Devi on 20.05.2020 for Section Officer Bhiwani. Thereafter Smt. Gindo Devi give him the letter of pay fixation after verification by Section Officer. DDO has asked him to draw the arrear and bill was prepared on 07.10.2020 by him as per his orders. After preparation of arrear bill on 15.10.2020/16.10.2020 an E-mail of letter dated 31.12.2019 was received and a copy of E-mail has been attached.

Smt. Richa Sangwan PGT, Chemistry /DDO, GGSSS Dighawa Jatan stated in here statement **(M-3)** that Smt. Gindo Devi has given letter on 07.02.2020 after collecting the same from the office later on she got service book and letter of arrear and submitted to her. Thereafter, on 20.05.2020 same was forwarded to Section Officer of pay fixation on receipt of pay fixation from Section Officer the Bill of arrear amounting to Rs. 361853 was prepared and on 09.10.2020 the same was got by the employee. The copy of letter of recovery was received through E-mail on 15.10.2020/16.10.2020. In compliance of the same orders in written were issued regarding recovery of the same.

- (xiii) Sh. Bhoop Singh, Mali posted at GHS, Kikral stated in his statement **(N-1)** that copy of letter dated 30.12.2019 was received from Sh. Santosh Asstt., DEO, Bhiwani on the basis of this letter on 20.05.2020, the pay was personally got fixed and an arrear of Rs. 64875 was withdrawn.

Sh. Ranbir Singh, Head Master GHS Kikral stated in his statement **(N-2)** that arrear was withdrawn by DDO Sh. Iqbal Singh, PGT Hindi GHS, Kikral. The copy of letter dated 30.12.2021 of DEO



Bhiwani was collected by Sh. Bhoop Singh from Sh. Santosh Asstt. O/o DEO, Bhiwani. The copy of letter dated 31.12.2019 of DEO, Bhiwani was received on 15.10.2020 through E-mail of BEO, Siwani. An amount of Rs. 64875 was withdrawn.

During the course of enquiry on 27.10.2021, Sh. Santosh Kumar, Asstt. (Suspended) O/o DEO, Bhiwani also submitted his statement (O) mentioning therein that he was dealing hand of regularization matter of part time Class (IV) employees in the year 2019. In compliance of the order passed by Hon'ble High Court in Puspa Devi's case, a Committee of five members was constituted at district level and all the eligible employees were granted the benefit of regularization from the date of their juniors vide order dated 30.12.2019 which was dispatched on the same day i.e. Monday. On the next day 31.12.2019, Tuesday, it was ordered to pay the arrear with effect from the actual date of joining. These orders were also sent according to the first letter/order. He stated in response to the allegation leveled upon him that he did not dispatch letter dated 30.12.2019 and 31.12.2019 rather he handed over the said letters to the employees after calling them personally in his office. He claimed that he may be made aware of that on which date and time he handed over the said letters to the beneficiary employees. He also pointed out that in both the matters there are signature of Section Officer and no question of withdrawal of money from the Treasury arises without his verification. In addition to the above, he stated that in his district the part time class (IV) employees have been granted the benefit of regularization and arrear with effect from 01.04.2011 on the basis of the example of other districts whereas they are not entitled to regularization with effect from 01.04.2011. It should also be enquired into that no employee has been de-

regularized. He also annexed a list of 35 employees who have been granted the same benefit.

During the course of enquiry, the Section Officer of the office of District Education Officer, Bhiwani was not present. He has submitted his statement (P) through letter dated 29.10.2021 as under:-


" On the subject cited above, it is humbly submitted that I could not attend the enquiry conducted on dated 27.10.2021 due to unavoidable circumstances, which has already been intimated vide my letter dated 26.10.2021 to DEO, Bhiwani (Photocopy attached).

In this regard, it is further submitted that I was working as Section Officer in the O/o DEO, Bhiwani with additional charge of the O/o DEO, Ch. Dadri & DEEO, Ch. Dadri (Three Offices). There is no assistant/clerk was deputed with SO's Branch in both the district. It is brought to your kind notice that the S.O of any office is only verified the pay as proposed by the concerned DDO alongwith relevant record.

So in this case, I have only verified the initial pay in accordance with speaking order passed by the authority and the same submitted by the DDO alongwith pay fixation so as to comply the directions of the Hon'ble Court. However, the matter regarding to draw the arrear for which the DDO is the competent authority to do so as his own level as per directions. No calculation of arrear has been verified by me.

It is also brought to your kind notice that with the verification of the pay of petitioner etc. no revised speaking orders were issued by the competent authority to S.O's Branch. There is no intimation is given regarding passing of speaking order to S.O.'s Branch.

Therefore, I have only to verify the initial pay of the post on the basis of pay fixation statement submitted by the DDO in the light of directions issue by the Hon'ble



Court/Speaking order passed by the competent authority so that directions of the Hon'ble Court may be complied with fully. The copy of speaking order was received from the DDO's with the pay fixation order.

It is therefore prayed to consider the facts stated above as there no fault of mine because no revise speaking order was issued by the competent authority on the above cited case till my retirement i.e. 31.05.2020 so far as my knowledge is concerned."

Principal/DDO GSSS, Ratera, Bhiwani through vide letter dated 28.10.2021 BEO Bawani Khera has intimated that he has deposited amount of Rs. 3,90,704/- vide challan No. 008365308 dated 28.10.2021 which was inadvertently paid as arrear to Sh. Ajmer Singh Class (IV) employee. He also assured that such mistake will not be repeated in future (Q).

After perusal of record and statements of the DEO, Bhiwani, Sh. Santosh Kumar, Asstt., DDOs, Clerks and the beneficiary class (IV) employees, this committee has come to the following conclusions:-

- (i) That as per the noting of the office of District Education Officer, Bhiwani (A-3), the order of granting the benefit of ante-dated regularization with consequential benefit was passed on 20.12.2019 which was signed by the DEO on 26.12.2019 and further shown to be dispatched on 30.12.2019. The head of the institutions (i.e. Headmaster, Principal etc.) were also directed to take necessary steps to enter the date of ante-dated regularization services of the concerned employees in the service record and also draw the benefit of to the concerned employees.

Another order dated 31.12.2019 of the DEO, Bhiwani whereby the benefit of regularization of ante-dated was granted in notional manner was

passed and the same has also been shown to be dispatched on 31.12.2019 to the concerned officers/officials/head of institutions.

The order dated 30.12.2019 was dispatched on 30.12.2019 (as per dispatch register) and on the same date the DEO office realized that a wrong order has been passed and the same needs some rectification then the earlier order dated 30.12.2019 could easily be stopped by the dispatch branch to avoid its circulation to the field offices and the modified order dated 31.12.2019 was actually to be circulated to the concerned officers/officials/head of institutions but the District Education Officer did not act in a careful and vigilant manner and failed to stop the circulation of letter dated 30.12.2019. Both the orders dated 30.12.2019 and 31.12.2019 were dispatched but during the course of enquiry none from the DDOs/Principals/Headmasters admitted that these letters were received by them.

The beneficiary Class (IV) employees somehow managed to collect the photocopy of letter dated 30.12.2019 by hand from the office of DEO, Bhiwani or from their other counterparts. The way, the beneficiary employees managed to collect the photocopy of order dated 30.12.2019 it seems that the said order might not have been actually dispatched by the officials of DEO, Bhiwani.

The orders of DEO, Bhiwani are generally circulated to all the concerned officials at their own level and to the field offices but order dated 30.12.2019 was not circulated to the Section Officer who was sitting at his next door (as per statement "P" of Section Officer). Resultantly, the Section Officer being unaware of the modified

order dated 31.12.2019 continued to verify the pay fixation and arrear of the part time Class (IV) employees of various schools of District Bhiwani.

Due to the negligence and connivance of the DEO, Bhiwani and his officials a loss of amount of Rs. 71,34,625/- has been caused to the State Exchequer which has been paid to the ineligible Class (IV) employees. When DEO, Bhiwani observed that the matter can be more serious, he collected the details of the payment from the DDOs and made a complaint to the Director Secondary Education Haryana, Panchkula on 15.06.2021 for taking action against Sh. Santosh Asstt. posted in his office for helping in making payment of arrears to class (IV) employees after a lapse of 1.5 years after the passage of order dated 31.12.2019 as stated/shown to be dispatched by his office but it was too late. If the statement of some DDOs (B-2, F-2, H-3, M-2, M-3 and N-2) is taken into consideration whereby they are claiming that they have received the said order in the month of October, 2020 through e-mail then it seems that the order dated 31.12.2019 might have been passed later on to cover up the gap.

The contention of Sh. Santosh Kumar, Asstt. O/o DEO, Bhiwani that both the matters were in the knowledge of Section Officer and no question of withdrawal of money from the treasury arises without the verification of Section Officer is not trustworthy. The real fact is that the said orders were not circulated to Section Officer by the officials of DEO, Bhiwani due to the reason best known to them. Moreover, the Section Officer in his letter dated 29.10.2021 (P) has clarified that no revised speaking orders were issued by the

competent authority to the S.O's Branch and he was not intimated regarding the passing of speaking orders. Thus, the dealing assistant has shown his gross negligence in circulating the orders passed by the DEO in time to the concerned officials/principals/head of institutions and accelerated the financial loss to the State Exchequer.

- (ii) It is therefore strongly recommended that strict disciplinary action may be taken against DEO, Bhiwani, all the Committee Members and dealing Assistant Sh. Santosh Kumar who prepared the second order dated 31.12.2019 by showing it of the same date which does not seem to be actual date of this letter as the same was e-mailed to various Head of Institutions/Block Education Officers by the office of DEO, Bhiwani in October, 2020 and due to their negligence a loss to the State Exchequer amounting to Rs. 71,34,625/- has been caused with their connivance with the beneficiaries for the reason best known to them.

The DDOs of the schools who are considered to be the supervisory officers of their respective institutions, have also shown sheer negligence and dereliction in duty and drawn the amount of arrear of Class (IV) employees on the basis of photocopy of order dated 30.12.2019 provided by the Class (IV) employees themselves and bills prepared by their clerks without verifying its contents from the office of DEO, Bhiwani. They could also verify it in the meetings held with DEO as it is unbelievable that no such meeting was ever held in the O/o DEO during this period. On asking, some DDOs stated that the speaking orders were typed in English language so they could not understand the contents of orders. Strict disciplinary action under the



relevant rules against all such DDOs who have made payment of arrears to the ineligible Class (IV) employees is also required to be taken. However, the DDOs of GSSS, Miran (K-1) and GSSS, Ratera, Bhiwani (Q) have deposited the amount in the Treasury which was paid by them to their Class (IV) employees.

Whereas Smt. Pushpa Devi & others (i.e. class IV Employees) have filed a Civil Writ Petition No. 16086 of 2019 in the Hon'ble High Court for claiming anti-dated regularization of services w.e.f. the date of regularization of their junior counter-part employees respectively alongwith back-wages and consequential benefits (i.e. seniority & pay fixation etc) However, many other similar situated class IV employees had also filed various writ petition claiming similar relief (i.e. CWP No. 18431 of 2019, 18906, 18495, 18595, 19398, 19425, 19401 of 2019) Resultantly, all these writ petition clubbed/tagged with and disposed of/decided the same by passing a common order vide dated 19.07.2019, by way of giving direction to the competent authority (i.e. District Education Officers) to consider the case of all employees (including petitioners and non-petitioners) as per seniority list and decide the same accordingly. The relevant part of the same is reproduced below:-

"Accordingly, the writ petitioners are disposed of with direction to the competent authority headed by District Education Officer in all the Districts, to consider the case of all the employees/petitioners including the persons, whose writ are pending or have not approach this court so far, but represented or received representation and decide the same in term of the policy dated 11.11.2003, by maintaining seniority as well as observation herein above, with in a period of five months from the date of receipt of

In-compliance of the direction given by the Hon'ble High Court vide order dated 19.07.2019, the case of claimant/employees has been duly considered in term of policy dated 11.11.2003. After examine the cases and facts of the claimant/ employees has also been considered accordingly.

The benefit of antedated regularization of the services w.e.f. the date of regularization of their/his/her counterpart juniors is here by granted as per seniority list.

It is necessary to clear that the claimant/employees, who have possessed the qualification of Middle Examination having seniority number 784 or below are hereby deemed to be regularized w.e.f. 19.08.2014 and having seniority number 820 or below (in the case of passing Middle Standard Examination) their services are hereby deemed to be regularized w.e.f. 12.04.2017. Similarly, the claimant/employees (passed Middle Standard Examination) having seniority number No. 1110A or below are hereby deemed to be regularized w.e.f. 10.09.2019 with all consequential benefit (i.e. Pay fixation & seniority)

It is also significant to mention here that the class IV employees, who has not possessed the essential and required qualification for the post of Peon & Chowkidar (i.e. Middle Standard Examination) having seniority No. 398 & 456 or below, their services are hereby deemed to

be regularized w.e.f. 19.08.2014, 10.09.2019 respectively along with all consequential benefits etc.

It is necessary to clear here that the District Bhiwani was bifurcated in to two segments namely District Bhiwani & District Dadri. Thus District Dadri had come-in-to existence in the months of November - 2016.

Thereafter, option was also asked from the class IV part-time employees to insert his/her name in the seniority of District Dadri & Bhiwani. But none of the class IV part-time employees did not give his/her option. Then it is presumed that they do not want to insert his/her name in the seniority list of separated District, i.e. District Bhiwani.

It is also clarified that on dated 12.04.2017 regularization of class IV part-time employees has been named by the DEO Bhiwani including the earlier consolidated seniority list of both the Districts (i.e. District Bhiwani & Ch Dadri). However, later on in the year 2019 the regularization of class IV part-time employees has also been made as per jurisdiction of respective Districts on the basis of the separate seniority list of part-time class IV employees as well as on the availability of sanctioned vacant posts.

Resultantly, the class IV part-time employees belonging to District Bhiwani having seniority No. 456 or below in the case of

seniority No 1110A or below in the case passing Middle standard examination have been regularized w.e.f. 10.09.2019 accordingly.

In-view of the above-discussion, it is hereby ordered that benefit of antedated regularization of services is hereby granted to all the eligible employees in their respective categories (i.e. Middle & non Middle pass examination) along-with all consequential benefit with the observation as mentioned above. The Head of the institution (i.e. Headmaster, Principal etc) will take necessary steps to enter the date of antedated regularization of services of the concerned employee in the service record and also draw the benefit admissible to the concerned employee according to rules & law. As such the issue/claim of anti-dated regularization of services of class IV employees is hereby disposed of according to rules & policy as applicable in the instant matter.

In-continuation of this office memo No. :- E-1-2019/6997-7052

Dated 30.12.2019 vide-which, the services of 39 class-IV part-time employees had been regularized w.e.f. the date as mentioned in it.

However, the services of some ineligible part-time Class-IV employees had also been regularized due to over-sight of factual position/facts inadvertently, which had been made, in violation of the regularization policy.

Therefore, a partial modification in the above-mentioned order is necessary to be made according to rules & law. It is well settled law that "Undue benefit, which had been granted to any employee, can be withdrawn at any stage. No one has legal right to draw/get the undue benefit continuously in future. Thus, wrong precedent is not be continued, even which has been granted to him/her erroneously."

Now, the matter of granting undue benefit pertaining to the ante-dated regularization of the services of part-time Class-IV employees has come to the knowledge of department, then the cases of all the 39 Class-IV employees including the employee of District Charkhi Dadri (as mentioned in the earlier order) has been reconsidered/re-examined by the constituted District Level Committee headed by District Education Officer and found that out of above-mentioned 39
