Whereas, Smt. Omwati D/o Sh. Chand Ram W/o Sh. Ravinder Singh resident of Village Faridpur (Panipat) presently working as Guest Post Graduate Teacher Hindi, Govt. Sr. Sec. School, Dacher [1855], (Karnal). She was appointed to the post of Guest Post Graduate Teacher in Hindi at Govt. Sr. Sec. School Khot Pura [2103], Panipat by the Principal concerned in August, 2006 after the approval of the then Block Education Officer, Panipat.

That the School Education Department issued guidelines/criteria to engage Guest Teachers vide memo No. 15/59-2005 Co(3) dated 26.05.2006 which provide as under:-

"... The Principal/ Headmaster/ DDO will process all the applications received. If the Principal/Headmaster/DDO receives applications more than the vacancies for that academic session, then he/she shall give preference to the applicants having higher academic merit. First priority for engaging guest faculty in a particular school should be to a candidate of same village/ town. The merit be made of such candidates. If required candidate of same village/town is not available, then merit be made of candidates belonging to same block. Second priority for engaging guest Faculty should be from amongst candidates belonging to the block. Third priority should be of candidates belonging to the same district."

That during your appointment, the Principal concerned did not follow the departmental instruction issued for engaging the Guest Teachers and offered appointment to the candidate belonging to other village/town despite the fact candidate of same village/town, namely Sh. Brijesh Sharma S/o Sh. Ram Singh residence of Village Khot Pura (Panipat) fulfilled the criteria for appointment to the post of PGT Hindi, which was unfair and violation of departmental instruction.

That Sh. Brijesh Sharma filed a complaint before the District Grievance Redressal Committee regarding your appointment beyond the departmental instructions and it was concluded by the Committee on 09.07.2007 that Smt. Omwati D/o Sh. Chand Ram W/o Sh. Ravinder of Village Faridpur (Panipat) is appointed to the post of Guest Post Graduate Teacher Hindi in violations of departmental instructions.

That the matter was also inquired by Sh. B.R. Vats, Joint Director O/o Director Secondary Education and he submitted his enquiry report dated 08.10.2012 with the conclusion that the appointment of Smt. Omwati as Guest Teacher against the post of Post Graduate Teacher Hindi is wrong and smacks of vested interest.

That Sh. Brijesh Sharma also filed complaint No. 186 of 2012 before the Lokayukta, Haryana with the prayer to enquire the matter regarding illegal appointment of Smt. Omwati D/o Sh. Chand Ram W/o Sh. Ravinder and the said complaint was disposed of by the Hon'ble Lokayukta vide order dated 20.02.2014

and recommended the disciplinary action against Smt. Saroj Bala Gur the then Block Education Officer, Panipat being faulty officer in accordance with law.

In view of the above observation, it is very clear that your appointment to the post of Post Graduate Teacher Hindi as Guest Faculty^{is} in violation of departmental guidelines/criteria issued vide memo No. 15/59-2005 Co.(3) dated 26.05.2006 to engage Guest Teachers. Before any action is taken against you as per provision provided in clause 6(1) of Haryana Guest Teachers Service Act, 2019, a show cause notice is hereby served upon you, as to why you should not be removed from service. Reply, if any, to this notice be filed in the office of Director Secondary Education, Haryana, Panchkula not later than 15 days from the date of the receipt of this notice. In case you fail to file reply to the notice within the stipulated period, it shall be presumed that you have nothing to say/submit in this regard and decision will be taken ex-parte.

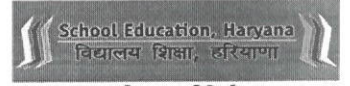

Smt. Nirmal Dahiya [006645], Deputy District Education Officer is hereby informed that it is proposed by the Governor of Haryana to take action against her under rule 7 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016, on the grounds set out in the enclosed statement of charges. The charges are based on the statement of allegations appended thereto.

2 Smt. Nirmal Dahiya is hereby required to state in writing within a period of 15 days from the receipt of this memorandum by her whether she admits the truth of all, or any, of the charges, what explanation or defence, if any, she has to offer and whether she desires to be heard in person.

3 Smt. Nirmal Dahiya is hereby further informed that if for the purpose of preparing her written statement, she wishes to have access to the relevant official records, she should inspect the same in the office of the Director General Secondary Education Haryana, Panchkula, on any working day after making prior appointment with him. It is, however, pointed out that only such documents will be shown to her as are in the possession of the Director, Secondary Education, Haryana, Panchkula, and as are strictly relevant to the case. If in the opinion of the Government, it is not desirable in the public interest, to allow her access to any document, such access shall be refused. If, Smt. Nirmal Dahiya wishes to consult any other relevant record, which is not in the custody of the Director General Secondary Education Haryana Panchkula it is for her to undertake its inspection. It is, however, made clear to Smt. Nirmal Dahiya that her failure to inspect the documents shall not constitute a valid ground for delay in the submission of her written statement and if the written statement is not received by the undersigned within the specified period, it shall be presumed that she has none to submit.

4 The written statement should be submitted direct to the undersigned.

Statement of allegation against Smt. Nirmal Dahiya [006645] the then Block Elementary Education Officer, Bhiwani [now Deputy District Education Officer office of District Education Office, Mahendergarh (4120)].


While being posted as Block Elementary Education Officer, Bhiwani from 16.06.2014 to 20.08.2020 having the additional charge of Block Education Officer, Bhiwani from 19.09.2019 to 20.08.2020, Smt Nirmal Dahiya committed following acts of omission and commission:-

That a committee of four members was constituted by the Director Secondary Education, Panchkula vide order no. 13/126-2021 HRME-I(3) dated 15.09.2021/20.09.2021 and Shri Surjeet Singh, Deputy District Attorney was appointed as chairman of said committee vide order no. 13/126-2021 HRME-I(3) dated 14.10.2021/18.10.2021. Further, said committee submitted its report dated 17.12.2021, wherein the following irregularities were found to be committed on her part i.e. Smt Nirmal Dahiya:-

That she i.e. Smt Nirmal Dahiya extended the benefit of arrears amounting to Rupees 5,17,245/- of pay fixation to Shri Jai Bhagwan, Peon posted in the office of Block Education Office, Bhiwani w.e.f. 19.08.2014 on the basis of photocopy of order no. E-1/2019/6997-7052 dated 30.12.2019 though the aforesaid order was modified by passing order no. E-1/2019/7056-7131 dated 31.12.2019 whereby benefit of notional pay fixation was to be granted. Thus, payment of arrears of Rupees 5,17,245/- was released to Shri Jai Bhagwan, Peon which was not admissible to him. As such, she i.e. Smt Nirmal Dahiya implemented the photocopy of order dated 30.12.2019 though this order was modified vide order no. E-1/2019/7056-7131 dated 31.12.2019 and failed to ascertain the sanctity of photocopy of orders dated 30.12.2019.

In this way, she i.e. Smt Nirmal Dahiya performed her duty in a negligent and irresponsible manner and violated the provisions of rule 4(1)(i)(ii) and (iii) and (2) of the Haryana Civil Services (Government Employees Conduct) Rules, 2016. Thus, she i.e. Smt Nirmal Dahiya caused a total loss of rupees 5,17,245/- to the State Exchequer.

The lapses detailed above constitute grave misconduct on the part of Smt. Nirmal Dahiya [006645] the then Block Elementary Education Officer, Bhiwani [6820], Bhiwani (now posted at Deputy District Education Officer (4098), Mahendergarh), rendering her liable for strict disciplinary action under rule 7 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016.

While being posted as Block Elementary Education Officer, Bhiwani from 16.06.2014 to 20.08.2020 having the additional charge of Block Education Officer, Bhiwani from 19.09.2019 to 20.08.2020, Smt Nirmal Dahiya committed following acts of omission and commission for which she is charged as under:-

That a committee of four members was constituted by the Director Secondary Education, Panchkula vide order no. 13/126-2021 HRME-I(3) dated 15.09.2021/20.09.2021 and Shri Surjeet Singh, Deputy District Attorney was appointed as chairman of said committee vide order no. 13/126-2021 HRME-I(3) dated 14.10.2021/18.10.2021. Further, said committee submitted its report dated 17.12.2021, wherein the following irregularities were found to be committed on her part i.e. Smt Nirmal Dahiya:-

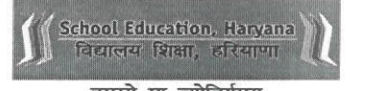

ORDER

Order No. 13/73-2022 PGT-II (7)

Dated, Chandigarh, the 19/09/2022

Whereas, Sanjay Malik (Emp. ID 042363) PGT Economics has filed CWP No. 20974 of 2022 titled as Sanjay Malik v/s State of Haryana and others, for issuance of a writ in the nature of certiorari to set aside the Transfer order dated 06.09.2022 as the merit of the petitioner has been ignored and no fair play was in existence during the transfer drive.

The aforesaid writ petition came up for hearing before this Hon'ble Court on 14.09.2022 and on that day Hon'ble Court was pleased to disposed of with direction to respondents. The operative part of the order dated 14.09.2022 is as under:-

Notice of motion.

Mr. Harish Nain, AAG, Haryana accepts notice on behalf of the respondent-State and submits that in case, the petitioner has any grievance qua the transfer of respondent No. 4 or petitioner claim the transfer to the said place, the petitioner is at liberty to move appropriate representation raising the said grievance within a period of two days from today and in case, any such grievance is raised, the same shall be decided within a period of 10 days thereafter by passing an appropriate speaking order. Till then, the petitioner shall not be relieved from the present place of posting or in case relieved, will not be forced to join the new place of posting till the decision of the said representation.

Ordered accordingly.

Whereas, the Government of Haryana has framed **Teachers Transfer Policy, 2016** dated 29.06.2016 and the same was amended on

01.06.2017. Thereupon, transfers were made under this amended policy of 2017 to ensure equitable, demand-based distribution of teachers/Heads to protect academic interests of students and optimize job satisfaction amongst its employees in a fair and transparent manner. Under this policy all government schools have been categorized into seven zones for the purpose of transfer of teachers and the teacher is eligible to opt any number of schools across the zones available to him in the State. She/He is free to give preferences in order of their suitability. For the purpose of Transfer Drive, the teachers who have already completed a period of 1 year service in a particular zone may seek transfer to some other station, on the other hand following categories of teachers have been asked to participate in the transfer drive compulsorily:

- a. A post of any cadre held by a teacher previously or presently in the school education department in a regular capacity for a period of 5 years or more on the qualifying date in the present zone of posting, shall be taken as a deemed vacancy and such teacher shall participate compulsorily in the transfer drive.
- b. Teachers declared surplus from a station as a part of rationalization/Normalization shall also participate compulsorily in the transfer drive.
- c. Teachers who have been given temporary manual posting previously due to non-availability of online transfer drive or technical problem or compulsion

That in compliance of the Hon'ble High Court order dated 14.09.2022, the petitioner submitted his representation on 20.09.2022 which has been examined in view of the provisions of the policy and it has been found that the petitioner Sanjay Malik (Emp.ID 042363) PGT Economics was required to compulsorily participate in the transfer drive due to completion of 5 years stay in present Zone-2. He has filled 26 preferences, but all of his preferences

were allocated to other employees having high points and he was marked for round 2nd. During round 2nd he filed 16 preferences and got 1st choice on the basis of his merit points i.e. 49.8 and transferred to Government Senior Secondary School Balewa(686), Gurugram from Government Senior Secondary School Bhadani,(3226) Jhajjar. As reference given by the petitioner of respondents no. 4 Mukesh Kumar PGT Economics is allocated school under anywhere category in round 3rd. So, he has been transferred as per provisions of the transfer policy. Now, he is directed to join his present place of posting i.e. Government Senior Secondary School Balewa(686), Gurugram.

It is further submitted that earlier some schools were merged by Department including GSSS Baniani [2756], therefore, no post were allocated to this school during rationalization, hence, not offered to anyone during 1st two round of drive. Later on this school was demerged by the Department and the Department and rationalization exercise was again executed for this school and sanctioned posts were allocated based on student strength. During round-3 (anywhere category) of allocation, posts of this school were allocated to some teachers by the system order of which has been cancelled by the Department vide order dated 14.09.2022 and not allocated to anyone even after completion of transfer drive for Guest teachers as well.

In view of the submissions made above, the contention of the petitioner in the representation dated 20.09.2022 is not tenable as the transfer of the petitioner is done as per the provisions of the transfer policy and as per reasons cited supra. Therefore, there is no merit in the representation of the petitioner and the same is liable to be rejected.

I order accordingly.
