The Governor of Haryana is hereby pleased to grant proforma promotion in the light of Rule 47 of HCS (Pay) Rules, 2016 to Sh. Ramphal Sharma [5021460], Elementary School Headmaster to the post of High School Headmaster (Rest of Haryana Cadre), as per Haryana State Education School Cadre (Group B) Service rules 2012 in HES-II Cadre with effect from 06.04.2021 i.e. the date of promotion of his junior as such, in FPL-9 of HCS (Pay) Rule, 2016 ranging from Rs.15600-39100 plus grade pay of Rs. 5400/- on provisional basis with immediate effect subject to the following terms and conditions:-

**Terms and Conditions:-**

1. He will be entitled for benefits of promotion i.e. pay and seniority w.e.f. 06.04.2021 notionally and actually from the date of joining duty to the post of Headmaster High School.
2. The inter-se-seniority of the promotee is subject to the claim of their seniors, who have not been promoted in this order due to unknown/various reasons.

4. If at any stage, it is found that the official promoted in these orders inadvertently was otherwise actually not fit or eligible for promotion or has concealed true facts of his service, he would be reverted to feeder cadre post without any notice.
5. That this promotion is subject to the condition that all the particulars and data supplied by the concerned candidate and by the field offices are correct. Eventually, it is found that information is found factually incorrect, erroneous or mis-represented, the promotion so granted shall be withdrawn forthwith without affording any further opportunity.
6. That if the seniority of any official is fixed later on in accordance with the instructions contained in Govt. letter No. 22/73/92-3GS-III, dated 14.10.1999, he/she would be entitled to seniority accordingly.



**Dated, Chandigarh, the 27<sup>th</sup> 0<sup>9</sup> 2022**

Whereas, the petitioner, Gian Singh (Emp.Id-011830), PGT History has filed CWP No.20513 of 2022 titled as Gian Singh V/s State of Haryana and others, for issuance of a writ in the nature of certiorari for quashing the transfer order dated 28.08.2022 whereby the petitioner has been forcefully transferred from Government Senior Secondary School, Hasanpur to Government Senior Secondary School Subaseri.

That the writ petition came up for hearing before this Hon'ble Court on 09.09.2022 and the Hon'ble Court disposed of the same with the direction to respondents to decide the representation of the petitioner. The operative part of the order dated 09.09.2022 is as under:-

***Notice of motion.***

***Mr. Harish Nain, AAG, Haryana accepts notice on behalf of the respondent-State and submits that in case, representation dated 02.09.2022 (Annexure P-7), if not already decided then the same will be decided within a period of 10 days from the receipt of copy of this judgment by passing an appropriate speaking order. In case, the petitioner has not been relieved so far from the present place of posting then he will be allowed to continue at the present place till the decision of the said representation.***

***Learned counsel for the petitioner submits that keeping in view the statement of the learned State counsel, no further grievance of the petitioner survives at this stage and the present petition may kindly be disposed of having been not pressed any further.***

***Ordered accordingly.***

The Government of Haryana framed Teachers Transfer Policy dated 29.06.2016 and the same was amended from time to time. The vision of the policy of 2017 is to ensure equitable, demand based distribution of teachers/heads to protect academic interest of the students and to optimize job satisfaction among its



employees in a fair and transparent manner. As per provision of this policy, a teacher has given right to compete against a vacancy of his choice and the teacher earning highest points shall be entitled to be transferred against a particular vacancy through transfer drive and then he/she will be protected for five years. The main object of the policy is to grant protection of 5 years only to those teachers who got posting by competing with other teachers. Since, a right has been given to every teacher to compete against every vacancy if he/she has not already completed 5 years stay against that very vacancy and if protection of 5 years is granted to a teacher of manual posting, then the right of a teacher to compete against that vacancy will be frustrated. Further if a teacher who has already completed 5 years stay in a zone and he has been transferred again that very zone through manual posting, then the very purpose of creating zones will also be frustrated. Therefore, if the government decided to protect to those teachers who have been transferred through manual mode between two transfer drive then the right of other teacher to compete against that very post and creating of zones will be frustrated and this action will be against the vision of this policy and which is not the intention of the framer of the policy. Online transfer is more fair and transparent than the manual posting as there is no human interference and hence the protection of 5 years stay has been granted to teacher who got posting after competing with other employees. Further the power of manual posting between two transfer drives has been provided with some check and balances. Further the provisions of the mandatory participation of manual posting in next transfer drive regulate the discretionary power of the authority to which the power is provided within the provisions of the policy for manual postings. There is a rational nexus to the object which is to be achieved. Further in order to discourage the practices of the teachers seeking manual posting, the condition for mandatory participation in the next transfer drive is imposed in cases of manual transfer order.

That under this policy all Government Schools have been categorized into seven zones for the purpose of transfer of teachers and the teacher is eligible to

opt any number of schools across the zones available to him, across the districts in the state. He is free to give preferences in order of his suitability. Following categories teachers have been asked to participate in transfer drive compulsorily:-

- A. Post of any cadre held by a teacher previously or presently in the school education department in a regular capacity for a period of 5 years or more on the qualifying date in present zone of posting, shall be taken as a deemed vacancy and such teacher shall compulsorily participate in the transfer drive.
- B. Teachers declared surplus from a station as a part of rationalization shall also compulsorily in the transfer drive.
- C. Teachers who have been given temporary manual posting previously due to non-availability of online transfer drive or technical problem or compulsion of administrative or litigational nature.

That the petitioner previously working in Zone-5 and he has completed more than 5 years in said Zone. In this regard, it is clarified that the persons who were completed 5 years in particular Zone is liable to be compulsorily participated in the drive and the same has been provided in the Policy itself at Para 8 clause (i)b(i) read with Para 9(iv) for Zone. Relevant portion of the same is reiterated herewith for the ready reference of this Hon'ble Court:-

**8(1)(b) Deemed Vacancy:** (i) Involuntary deemed vacancy: A post of any cadre (whether teaching or non-teaching), held by a teacher previously or presently in the school education department in a regular capacity for a period of five years or more on the qualifying date in present zone of posting; or A post occupied by a teacher given temporary manual posting due to non-availability of online transfer drive or technical problems or compulsions of administrative or litigational nature. **That Para 2 of 8(1)(b) have been further clarified by the issuance of corrigendum vide Memo No. 8/2-2020 CO-1 (2) dated**

25.08.2021 (Annexure R-1). Relevant portion of the same is reproduced as follow:-

*“Involuntary deemed vacancy: A post of any cadre (whether teaching or non-teaching), held by a teacher previously or presently in the School Education Department in a regular capacity for a period of five years of more on the qualifying date in the present zone of posting; or*

*A post occupied by a teacher given temporary manual posting due to non-availability of online transfer drive or technical problems or compulsion of administrative or litigational nature or on new appointment or on promotion or otherwise.”*

It is further clarified in interpretation of clauses of Teacher Transfer Policy as follows:-

“Any posting updated manually between two General Transfer drives would be the criteria to identify a teacher for forceful participation in the GTD (General Transfer Drive)”.

**Para 9 (iv) (Teachers Transfer Policy):-** Normally an employee has a service career of 35 years, so a teacher is supposed to serve zone for maximum 5 years during his service career. In case of Zone-1, Zone-2, Zone-3 and Zone-4, if a teacher has completed five years of stay then such zone shall not be made available to him giving option of stations whether in online transfer drive or offline manual/temporary allocation. But in case of Zone-5, Zone-6 and Zone-7, the stations shall be made available to the teachers regardless of their stay in these zones as these three zones comprise of rural as well as far off areas from urban centres.

It has been further clarified by the competent authority i.e. Additional Chief Secretary to Govt. Haryana, School Education in interpretation of clauses of Teachers Transfer Policy and the same as follows:-

**If a Teacher completing tenure of 5 years in the zone 5/6/7 is participating in GTD compulsorily, and opts and**

follows:-

**If a Teacher completing tenure of 5 years in the zone 5/6/7 is participating in GTD compulsorily, and opts and transferred in a school of any of the zone 5,6 or 7 (i.e. zone 5 to 5, zone 5 to 6, zone 5 to 7, zone 6 to 5, zone 6 to 6, zone 6 to 7, zone 7 to 5, zone 7 to 6 and zone 7 to 7) will only be entitled to be protected in the said school for next five years unless he is willing to participate or forced to participate as per provisions of other clauses of the policy.”**

It is clear to mention here that the petitioner was transferred from Zone 5 to Zone 6 so as per the Teacher Transfer Policy; he is not protected under Para 9(4). Therefore, the petitioner had to compulsorily participate in teacher transfer drive, 2022.

That in compliance of the Hon'ble High Court order dated 09.09.2022; the petitioner has submitted his representation on 02.09.2022, which has been examined in view of the provisions of the Teacher Transfer Policy. As per MIS profile of the petitioner, he was initially appointed in Government Senior Secondary School, Patherheri, Gurugram (865) (Zone-4), on dated 01.10.2003. Thereafter, the petitioner was transferred at Government Model Sanskriti Senior Secondary School Taoru, Nuh Mewat, (866) (Zone 3) vide order 19/53-2004-EH (3) dated 13.08.2004. Further, it is submitted that the petitioner on promotion as PGT History was temporarily adjusted in Government Senior Secondary School tapkan, Nuh Mewat (6031) (Zone-2) vide order 2/140-2016-PGT-II (1) dated 09.08.2016. Thereafter, the petitioner had been temporarily adjusted to GSSS Hasanpur Taoru, Nuh Mewat (Zone-5) on 07.04.2017 on administrative ground. Further, the petitioner was transferred to Government Senior Secondary School Tapkan, Nuh Mewat (6031) (Zone-2) on 09.08.2017. Again, he was transferred at GSSS Hasanpur Taoru (867), Nuh Mewat (Zone-5) on administrative ground vide order dated 16.11.2017. Since, petitioner completed 5 years tenure in Zone-5 from 07.04.2017 to 09.08.2017 and 16.11.2017 to till date so as per the Teacher Transfer Policy, he is not protected under Para 9(4) read with

(867) Nuh Mewat, Zone-5 to GSSS Subaseri (914) Nuh Mewat, Zone-6.  
Since petitioner has completed 5 years in a zone he has to participate in the transfer drive although he can opt for Zone 5, 6 and 7 again as per policy.

In view of the submissions made above, the contention of the petitioner in the representation dated 02.09.2022 is not tenable as the transfer of petitioner is done as per the provisions of the transfer policy and as per reasons cited supra. Therefore, there is no merit in representation of the petitioner and the same is liable to be rejected. He is directed to join the allocated station.

I order accordingly.

Whereas, a complaint was filed by the staff of Government Model Sanskriti Sr. Sec. School, Tauru [866], Nuh on dated 19.06.2021 and some other complaints were also received on 23.07.2021 against Smt. Sabina Sehrawat [5000406], Guest PGT Hindi, Government Model Sanskriti Sr. Sec. School, Taoru [866] (Nuh) and her husband Sh. Ajit Singh working as Principal in the same school alleging therein grave misconduct and harassment of school staff by both of them. Smt. Sabina Sehrawat being wife of Sh. Ajit Singh, Principal harassed the school staff. Based upon the numerous complaint and report of the Sub-Divisional Magistrate, Nuh dated 20.07.2021, the matter was examined and the service of Smt. Sabina Sehrawat was terminated vide Government order dated 14.03.2022. Consequently, aggrieved with the said order, Smt. Sabina Sehrawat filed review application against her termination on dated 11.05.2022 before the Government stating that she was not heard before passing the said order of her termination from service.

Whereas, the review application filed by the Smt. Sabina Sehrawat was taken on record and she was accorded personal hearing on dated 09.09.2022 with opportunity to submit documentary proof in her defense. The official was heard on 09.09.2022 through video conference and during the course of hearing, she stated that she became victim of circumstances due to quarrel between her husband (the then principal) and the school staff. She had nothing to do with the complaint filed against them. The whole school staff was against her due to the fact that she was the wife of the then Principal of said school. However, Smt. Sabina Sehrawat failed to submit any concrete proof that she was not involved in harassing the other school staff alongwith her husband. Smt. Sabina Sehrawat cannot be absolved from her liability by merely stating that she was not part of it, rather to hostile environment was created by her alongwith her husband. The same has been proved from the report of Sub Divisional Magistrate, Nuh with regard to complaint received against Smt. Sabina Sehrawat and her husband vide letter dated 20.07.2021.

Keeping in view of the above said facts and circumstances, contentions made, documents submitted by Smt. Sabina Sehrawat during the course of hearing, it is observed that the allegations regarding which she was found guilty, are quite serious in nature considering the duties to be discharged by her. Further, she failed to prove her case beyond doubt w.r.t. her involvement in harassing the other school staff as well as creating nuisance

and hostile environment while putting at stake the interest of the students & teachers fraternity at large.

Therefore, considering the facts enunciated above and the seriousness of matter, the review application filed by the Smt. Sabina Sehrawat [5000406], Guest PGT Hindi is hereby rejected being devoid of merits. However, if she is aggrieved of this orders, she may approach the Hon'ble Governor by way of filing memorandum.

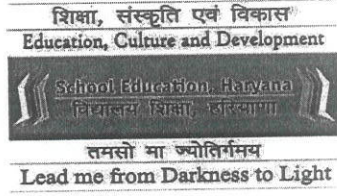

Whereas, Sh. Surender Kumar, PGT Physics at GSSS Banwasa, Sonipat has filed CWP No. 17023 of 2018 titled as Surender Kumar & another Vs State of Haryana with a prayer to consider the claim of the petitioner for step up at par with his junior counterparts Sh. Ravinder Kumar, PGT Chemistry.

Whereas, petitioner was initially appointed as a Science Master on regular basis and joined on 29.12.2008, later on, he was appointed as a PGT Physics through proper channel on recommendation from the Haryana School Teacher Selection Board, Panchkula. The petitioner has submitted the documents/records with regards to step-up at par with his junior. The particulars of the petitioners and junior is as under:-

Whereas on the examination it is found that Sh. Ravinder Singh was promoted as a PGT on 17.06.2016 and joined on 23-06-2016. After his promotion to the post of PGT Chemistry. On promotion an additional increment was granted to him and his pay was fix as Rs 49000 as on 23-06-2016. That seniority number of the petitioner was 14243 and Sh Ravinder Singh seniority was 14985. The petitioner was senior in the master cadre seniority.

Whereas on the examination it is found that Sh. Surender kumar Govt. Sen. Sec. School Banwasa has been granted the benefit of pay protection vide

Order no 18/38-2016 PGT-I (2) dated 15-06-2017 w.e.f. 14-12-2013 under rule 4.4 (b) (iii) of Punjab civil service rules volume 1 part-1.

It is pertinent to mention here that petitioner Sh. Surender Kumar is PGT Physics having qualification of M.sc in Physics, whereas Sh. Ravinder Singh is PGT in Chemistry having qualification of M.sc in Chemistry. The main basis of their appointment or promotion is acquiring of qualification in the respective subject with atleast 50% marks, so the petitioner cannot claim this benefit of step up of his pay at par with his junior who is of different subject and having different qualification. Moreover, the case of the petitioner is not covered as per 57(e) and 58(a) of the Haryana Civil Services (Pay) Rules, 2016.

After going through relevant records of the case it has been found that the claim of the petitioner regards benefit of step up at par with his junior Sh. Ravinder Singh is not tenable on subsequent appointment there is no provision in any rules to grant the benefit of promotional increment.

I therefore, pass an order to reject the claim of the petitioner accordingly.
