

5. That he/she will not extend leave from abroad in any circumstances.

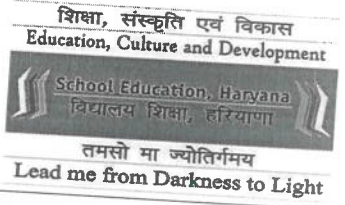
