6. All District Education Officers in the State of Haryana to ensure the relieving and joining of the PGTs as per the guidelines of State Election Commission i.e. they shall not be relieved from the existing place of posting and join the new place of posting till the completion of the election process.
7. As the Panchayat Election is going on and two more phases are yet to be completed. Hence, the teachers who have been assigned the election duty shall be relieved only after the completion of election process in that respective districts.
8. All the Head of the Institutions concerned to ensure the relieving and joining of all the officials who are engaged in election duty within one week i.e. 7 days after the completion of the election process under the intimation of the District Education Officer concerned at your own level and update on the MIS.
9. All the concerned officials to join the stations as per the above directions without fail.
10. Aarohi Cell with request to update of orders on MIS of the above concerned candidates.
11. Superintendent PGT branches with direction to take necessary action in respect of allotment of stations to the PGTs relieved from the schools mentioned in this list.
12. IT Cell for uploading this order on the web portal.
13. The candidates have to compulsorily serve at the allotted station for three years and the joining at the station is compulsory.
14. If any adjustment have been done by concerned DEO at district due to any reason that will be nullified w.e.f order date.
15. The candidates of Mewat cadre are directed to join in Mewat district only.
16. All the School Heads are directed to ensure that the employees are allowed to join in their new stations allocated to them as mentioned in the above order. If there is no clear vacancy in the school due to non updation of MIS even than the employee posted against these orders shall be allowed to join. The employee whose MIS is not updated resulting in showing vacancy on MIS shall report to the office of the concerned District Education Officers. In such

cases District Education Officers are directed to adjust such employee in any school in their district with condition to compulsorily participate in the next transfer drive. It is also clarified that the validity of the test of such candidates remains intact. Hence, they are eligible to apply to fill choices for postings in GMSSSS in future.

17. The concerned employee, before joining the new station of posting, shall be liable for updating the Court orders/ vacating the stay within 10 days from date of issuance of this order, else he/she shall be liable for disciplinary action.
18. If any employee is unable to join at the new station due to non-vacancy of the post (because of court case), in such case the employee will be given choice of whether to choose the other station in future or to wait for the decision of the court. 8. All the Head of the Institutions concerned to ensure the relieving and joining of all the officials who are engaged in election duty within one week i.e. 7 days after the completion of the election process under the intimation of the District Education Officer concerned at your own level and update on the MIS.
9. All the concerned officials to join the stations as per the above directions without fail.
10. Aarohi Cell with request to update of orders on MIS of the above concerned candidates.
11. Superintendent PGT branches with direction to take necessary action in respect of allotment of stations to the PGTs relieved from the schools mentioned in this list.
12. IT Cell for uploading this order on the web portal.
13. The candidates have to compulsorily serve at the allotted station for three years and the joining at the station is compulsory.
14. If any adjustment have been done by concerned DEO at district due to any reason that will be nullified w.e.f order date.
15. The candidates of Mewat cadre are directed to join in Mewat district only.
16. All the School Heads are directed to ensure that the employees are allowed to join in their new stations allocated to them as mentioned in the above order. If there is no clear vacancy in the school due to non updation of MIS even than the employee posted against these orders shall be allowed to join. The employee whose MIS is not updated resulting in showing vacancy on MIS shall report to the office of the concerned District Education Officers. In such cases District Education Officers are directed to adjust such employee in any school in their district with condition to compulsorily participate in the next



transfer drive. It is also clarified that the validity of the test of such candidates remains intact. Hence, they are eligible to apply to fill choices for postings in GMSSSS in future.

17. The concerned employee, before joining the new station of posting, shall be liable for updating the Court orders/ vacating the stay within 10 days from date of issuance of this order, else he/she shall be liable for disciplinary action.
18. If any employee is unable to join at the new station due to non-vacancy of the post (because of court case), in such case the employee will be given choice of whether to choose the other station in future or to wait for the decision of the court. The relieving of such employee will be nullified till further orders.
