Whereas Smt. Saveeta Rani has filed Civil Writ Petition No. 8720 of 2017 titled as Saveeta Rani Vs. State of Haryana and others in the Hon'ble High Court of Punjab and Haryana at Chandigarh with the following prayer:-

“For issuance of a writ of mandamus directing the respondents to grant the benefit of one increment w.e.f 13.01.1994 for higher responsibility under rule 4.4(A)(i) of the Punjab Civil Services Rules Vol.-I, Part-I on her promotion to post of S.S. Mistress and in terms of judgment dated 21.02.2002 (Annexure P-2) passed by this Hon'ble Court in CWP No.17301 of 2000 titled as Swaran Singh & Ors. Vs. State of Haryana and other grant her all arrears with market rate of interest.

Further, directing the respondent to grant first higher standard pay scale w.e.f. 01.01.1994 in terms of the Govt. Notificatin dated 08.02.1994 (Annexure P/1) and grant her all arrears at par with market rate of interest.

Further, directing the respondent to grant the 2nd ACP and 3rd ACP on completion of 20 and 30 years of regular satisfactory service in terms of the ACP Rules,1998 & 2000 w.e.f. 01.01.1996 and 01.01.2006.”

The Hon'ble High Court passed the order dated 27.04.2017. The operative part is as under:-

Notice of motion for 2.8.2017.

On the asking of the Court, Mr. Keshav Gupta, A.A.G. Haryana, who is present in Court, accepts notice on behalf of the respondents-State.

The official respondents are directed to pass a speaking order relating to whether the petitioner is entitled for increment on account of his promotion to the next higher cadre or not?

Learned counsel for the petitioner is directed to furnish three sets of writ papers to the learned State counsel during the course of the day.

The matter was examined by the department and it has been found that as per service book Smt. Saveeta Rani was engaged as Drawing Teacher on contract for six months basis in grade of Rs. 480-760/- on 15.12.1979 and thereafter her services were regularized w.e.f. 16.09.1982 in the same grade pay. As per the Haryana Civil Services

(Revised Pay) Rules, 1987 pay of the post of Drawing Teacher revised to scale of Rs. 1200-2040 w.e.f.01.01 1986. Further, pay scale has been revised as per H.C.S. (Revised Pay) Rules, 1998 and H.C.S. (Revised Pay) Rules, 2008 of the same post of Rs. 4500-700 and 9300-34800+4200 Grade Pay respectively. As per pay scale mentioned the corresponding Standard Scale/ ACP scale are Rs. 1400-2600 (1st Higher Standard Pay Scale), Rs. 5500-9000 (2nd ACP) and 9300-34800+5400 G.P. (3rd ACP) of the post of Drawing Teacher.

Whereas, it is also mention here that Smt. Saveeta Rani was awarded of JST grade of Rs. 525-1050/-w.e.f 07.06.1981 in CWP No.83 of 1998-Ajit Singh and Others vs. State of Haryana & Ors. And as per D.S.E Haryana order No.1798-98-E-II (3) dated 24.02.1998 due to Higher qualification as personal measure which is Master Grade.

Whereas, the petitioner was promoted from the post of Drawing Teacher to the post of S. S. Mistress on 13.01.1994 in the grade of pay Rs.1400-2600 JST grade from Drawing Teacher, therefore, she is not eligible for one increment on her promotion from post of Drawing Teacher to the post of S. S. Mistress on 13.01.1994 as per Rule 4.13(2) of Punjab Civil Services Rules Vol.-1, Part-1 which is reproduced as under:-

PAY OF OFFICIATING GOVERNMENT EMPLOYEES

4.13. (1) Subject to the provisions of rules 4.22 to 4.24, a Government employee who is appointed to officiate in a post shall not draw pay higher than his substantive pay in respect of a permanent post, other than a tenure post, unless the post in which he is appointed to officiate is one enumerated in the schedule to this rule or unless the officiating appointment involves the assumption of duties and responsibilities of greater importance than those attaching to the post, other than a tenure post on which he holds a lien: Provided that the competent authority may exempt from the operation of this rule, any service which is not organised on a time-scale basis and in which a system of acting promotions from grade to grade is in force at the time of the coming into force of these rules:

Provided further that the competent authority may specify posts outside the ordinary line of a service the holders of which may, notwithstanding the provisions of this rule and subject to such conditions as the competent authority may prescribe, be given any officiating promotion in the cadre of the service which the authority competent to order promotion may decide and may thereupon be granted the same pay

(whether with or without any special pay, if any, attached to such posts) as they would have received if still in the ordinary line.

(2) For the purpose of this rule, the officiating appointment shall not be deemed to involve the assumption of duties or responsibilities of greater importance if the post to which it is made is on the same scale of pay as the permanent post, other than a tenure post, on which he holds a lien, or on a scale of pay identical therewith.

Further, it is submitted that the petitioner has already granted as JST scale which is 1400-2600 & revised 5500-9000.

Whereas, as per ACP Rules, 2006 and F.D. letter dated 04.03.2014, she has been granted 3rd ACP in scale of Rs. 9300-34800+5400 G.P. w.e.f. 04.03.2014 as Drawing Teacher after completion of 24 years services vide DSE Haryana order No.18/922-18 PGT-1(6) dated 25.01.2018. She was working as Drawing Teacher on regular basis from 16.09.1982 to 19.10.1994. As per HCS (ACP) Rules, 2008 3rd ACP Grade is Rs.5400/- of Drawing Teacher which has already been granted to her.

Therefore, the petitioner in present writ petition is not entitled for grant of additional increment on her promotion as her claim is not maintainable as per the Haryana Civil Service Rules. Hence, the claim of petitioner is hereby rejected as per service rules.

I order accordingly.
