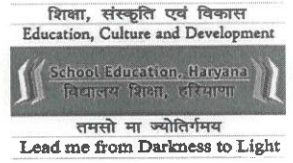

Order No. 13/62-2019 PGT-I (1) **Dated, Chandigarh, the 11/11/2022**

Whereas Sh. Mahesh Kumar & others had filed a Civil Writ Petition No. 6832 of 2016 titled as Mahesh Kumar & others vs. State of Haryana & another before the Hon'ble Punjab and Haryana High Court praying therein to direct the respondents to rectify the seniority list of Masters finalized in the year 2006 and Lecturers issued in the year 2005 and allow all other service benefits at par with their juniors.

The Hon'ble Punjab and Haryana High Court disposed of said petition on dated 11.04.2016 with the following orders:-

"In view of above, without commenting on the merits of the case, this petition is disposed of with a direction to the respondents to decide the legal notice dated 01.01.2016 (P-7) of the petitioners by passing a speaking order, in accordance with law, preferably within a period of four months from the date of receipt of certified copy of this order."

In compliance of above said order, the legal notice dated 01.01.2016 of Mahesh Kumar & others, has been examined and it is found that the incumbents were initially appointed as TGT Science & Math Master on 29.01.1990 and 31.10.1991 and later on, promoted to the post of PGT Mathematics.

Besides that, the claim of Sh. Mahesh Kumar & others regarding rectifying the seniority of Masters, the Director Elementary Education, Haryana has already rejected the claim of the incumbents vide speaking order bearing no. 17/2-2021 HRM-1 (1) dated 08.02.2021. The claim regarding rectifying the seniority of Lecturers is not maintainable due to reason that the claim of masters has already been rejected by the Director Elementary Education, Haryana. So, the seniority w.r.t. Lecturers of Sh. Mahesh Kumar & others is as per rules.

However, the benefits of Step-up has been awarded to Sh. Mahesh Kumar and others at par with their junior Sh. Jai Prakash, PGT Mathematics belonging to SC Category except Sh. Jitender Kumar as he himself gave up the claim of Step-up at par with his junior vide Order No. 13/9-2020 PGT-IV (3) dated 09.09.2022.

Keeping in view the facts enunciated above and documents on record, the claim of Sh. Mahesh Kumar & others regarding rectifying the seniority of Lecturers is not tenable & hereby rejected being devoid of merits.




