ORDER

The instant Order is being passed in compliance with the directions dated 04.08.2022 passed by the Hon'ble Punjab & Haryana High Court in CWP No. 12162 of 2022 - Parveen Kumar & Others Vs. State of Haryana.

- working on the post of Clerk in Field Cadre of Education Department, with the prayer to fix the designation as per their duties and responsibilities performed by them and to fix their pay scale as per 10 points fixed by Hon'ble Supreme Court vide judgment dated 20.02.1992 (Annexure P-4), which has been duly accepted by the Haryana Government on dated 20.04.2001. Further, they have requested to direct the respondents to decide the Legal Notice dated 21.10.2021 [Annexure P-8].
- 3. Whereas, ibid CWP was disposed of by the Court vide orders dated 04.08.2022 with following directions to Respondent No. 1 i.e. Finance Department:-

"In view of the request made, without expressing any opinion of the merits of the case or the claim being made by the petitioners in their legal notice, respondent No. 1 is directed to decide the legal notice dated 21.10.2021 (Annexure P/8) by passing a speaking order within a period of eight weeks from the date of receipt of copy of this order."

- Whereas, vide legal notice dated 21.10.2021, the Clerks in Field Cadre of Education Department have submitted/demanded, that the designation of Clerks may kindly be fixed as per the responsibilities given and are to be given by their officers and different designations are there in all the three level of schools (Middle, High, Senior Secondary) and their pay scale may kindly be fixed on the basis of 10 points fixed by Hon'ble Supreme Court which has been duly accepted by the Haryana Government on 20.04.2001.
- 5. Whereas, the petitioners were issued appointment letters to the post of Clerks in view of statuary provisions of the Haryana Education Department Sub-offices, Ministerial (Group-C) Services Rules, 1983, as amended from time to time. There is nothing on record which may establish that the petitioners have ever impugned these Service Rules 1983 before any Hon'ble Court of Justice, therefore, the petitioners have to peruse and obey these statuary service rules before issuing a legal notice. As per the Service Rules, for promotion, existence of vacancies in the promotional cadre and fulfilment of eligibility in the feeder cadre are mandatorily required. Fulfilment of any one of these two requirements is not sufficient.

- the government departments and having the same pay scales across the State. Therefore, it is factually wrong to say that the Clerks in the other departments are being paid salary much more than what is being paid to the Petitioners. Though, there is a possibility that Clerks in other departments may have got promotions on to the higher posts at a date earlier than that of the petitioners, but the same is purely due to the availability of the vacant promotional posts at a particular time in a particular department. On promotion, one gets entitled for higher pay scale meant for the promotional post. However, such clerks like the petitioners, who could not be promoted due to lack of vacancies, are being granted benefit of ACP scheme, which was specifically designed to eater for the situation, in which the petitioners are finding themselves.
- 7. Whereas, the clerks perform multifarious duties but their duties are limited to initial level. However final decision is to be taken at the level of DDO or Head of office. Moreover, it is always kept in mind that their work load always remains at uniform level.
- 8. Whereas, despite of same designation and pay scale, an Accounts Officer of SAS cadre is posted in different offices like field offices at district level, Head quarter level or at Finance Department level. In some offices, the Accounts Officer is given DDO Powers, but not in all offices. In different offices an Accounts Officer has to work in different manner as the nature of duties and level of responsibility in different departments are totally different. For example, an Accounts Officer posted in the District Offices, handles the work of a single office. On the other hand an Accounts Officer posted in the Directorate office, handles all the works of the District Offices including the work of headquarter. An Accounts Officer working as DDO performs different nature of duties. As such the nature of duties, level of responsibility and quantum of work in different offices is very much different, whereas the pay scale and designation remains the same, irrespective of their place of posting.
- 9. Whereas, likewise, an ADA posted in the District Court and any other DDA/ ADA posted in the Directorate office, perform different duties. Even the ADAs posted in different districts have varying work load. However, the pay scale of the post of DDA/ADA is same in the Prosecution Department irrespective of their place of posting
- 10. Whereas, for smooth functioning of the government work, some officers have been given additional charge of other post/office in addition to their present work; even then they are getting pay in their existing pay scale without any additional incentive.

Whereas, to tackle the situation of stagnation on one post, ACP scheme was introduced w.e.f 01.01.1996 vide notification dated 07.01.1998 namely Harvana Civil Services (Assured Carcer Progression) Rules 1998. Later on, the same has been extended vide Haryana Civil Services (Assured Carcer Progression) Rules. 2008/2016. The objective of these rules is to remove stagnation in service. Accordingly two schemes in the form of a general ACP and Cadre Specific ACP scheme have been formulated. The scheme seeks to ensure that all government servants get at least three financial up-gradations, including financial up-gradation availed by such government servants as a consequence of functional promotion during their entire career. It also seeks to ensure that no government servant stagnates without any financial up-gradation for more than eight years (fen years before 4.3.2014). However, in any case, an employee who has been granted ACP under the Haryana Civil Services (Assured Carcer Progression) Rules is also entitled for promotion in due course as per his seniority, eligibility and availability of promotional post.

Whereas, the Functional pay scale of the post of Clerk was PB-1, Rs. 5200-20200+1900 Grade pay and next available functional grade pay(s) under the HCS (RP) Rules. 2008 are 1950, 2000, 2400, 2500, 2800, 3200, 3300 & 3600. On the other hand, the Clerks were granted the 1st, 2nd & 3nd ACP of Rs. 2400, 3200 & 3600 Grade pay(s) respectively under the HCS (ACP) Rules, 2008. It is clear that Clerks have already been granted 1st / 2nd / 3nd ACP accelerated grade pay(s) of Rs. 2400/3200/3600 on completion of regular satisfactory service 10/20/30 years, while ignoring grade pays of Rs. 1950, 2000, 2500, 2800 & 3300 as provided under HCS (Revised Pay) Rules, 2008. The same was further modified vide order dated 04.03.2014 and the term of 10/20/30 years of service for grant of 1st / 2nd / 3rd ACP was reduced to 8/16/24 years respectively.

Whereas, their promotional channel/ avenues are different from one department to another, as per their Departmental Service Rules. Some Clerks get promotion directly from Clerk cadre to Assistant from GP 1900 (Level-2) to GP-4200(Level-6) like in Haryana Civil Secretariat, Raj Bhawan etc. whereas some Clerks in different departments have different line of promotion like Clerk to Head Clerk/ Accounts Clerk, Assistant Revenue Clerk, Sub Divisional Clerk, Sr. Divisional Clerk etc. in pay level between Level-2 and Level-4 like in Irrigation, Archaeology, Development & Panchayat Department etc. But their working conditions and workload is quite different in different departments.

14. Whereas, while considering the prescription of a pay scale for a particular post, the whole rationale has been explained by the Apex Court in

the case of Secretary, Finance Department Vs West Bengal Registration. Services Association, AIR 1992 SC 1203. The same has been circulated by the Finance Department vide Letter No. 8/6/2001-5PR (FD) dated 20.04.2001. The Hon'ble Supreme Court observed in this case as under:

"... it is well-settled that equation of posts and determination of pay scales is the primary function of the executive and not the judiciary and, therefore, ordinarily courts will not enter upon the task of job evaluation which is generally left to expert bodies like the Pay Commissions, etc. But that is not to say that the court has no jurisdiction and the aggrieved employees have no remedy if they are unjustly treated by arbitrary state action or inaction. Courts must, however, realise that job evaluation is both a difficult and time consuming task which even expert bodies having the assistance of staff with requisite expertise have found difficult to undertake sometimes on account of want of relevant data and scales for evaluating performances of different groups of employees. This would call for a constant study of the external comparisons and internal relativities on account of the changing nature of job requirements. The factors which may have to be kept in view for job evaluation may include (1) the work programme of his department (ii) the nature of contribution expected of him (iii) the extent of his responsibility and accountability in the discharge of his diverse duties and functions (iv) the extent and nature of freedoms/limitations available or imposed on him in the discharge of his duties (a) the extent of powers vested in him wij the extent of his dependence an superiors for the exercise of his powers (vii) the need to co-ordinate with other departments, etc. We have also referred to the history of the service and the effort of various bodies to reduce the total number of pay scales to a reasonable number. Such reduction in the number of pay scales has to be achieved by resorting to broad banding of posts by placing different posts having comparable job charts in a common scale. Substantial reduction in the number of pay scales must inevitably lead to clubbing of posts and grades which were earlier different and unequal. While doing so care must be taken to ensure that such rationalisation of the pay structure does not throw up anomalies. Ordinarily a pay structure is evolved keeping in mind several factors e.g., (i) method of recruitment, (ii) level at which recruitment is made, (iii) the hierarchy of minimum (iv) cadre, given CL in educational/technical qualifications required, (v) avenues duties of nature (vi) the promotion, and horizontal the responsibilities, (vii) relativities with similar jobs, (viii) public dealings, (ix) satisfaction level, (x) employer's capacity to pay, etc. We have referred to these matters in some detail only to emphasis that several factors have to be kept in view while evolving a pay structure and the horizontal and vertical relativities have to be mind the hierarchical keeping in balanced carefully arrangements, avenues for promotion, etc. Such a carefully evolved pay structure ought not to be ordinarily disturbed as it may upset the balance and cause avoidable ripples in other cadres as well There can, therefore, be no doubt that equation of posts and equation of salaries is a complex matter which is best left to an 'expert body unless there is cogent material on record to come to a firm conclusion that a grave error had crept in while fixing the pay scale for a given post and court's interference is absolutely necessary to undo the injustice

Another land-mark judgement elucidating the principles of pay revision and dealing with the subject of equivalence of posts is in the case of State of UP Vs J.P. Chaurasia (1989) 1 SCC, 121: JT 1988(4) SC 53:1989 Lab IC 1146."

Whereas, determination of pay scales for any existing post is carried out only when any amendment is proposed/ demanded by such categories of employees or any new post is to be created afresh. As such, the post of Clerk is a common cadre post, having same pay scale and existing in all the departments across the State. Such action is taken by the Finance Department on the proposal/ recommendations of the concerned department.

Whereas there is a set procedure for creation of a new post or for up gradation of an existing post depending on the work load and other parameters. New posts are got created by the Administrative Departments after the recommendation review / Analysis / proper work study by the Administrative Reforms Department and thereafter, approval of the Finance Department is sought.

Whereas as per Rule-9 of the Haryana Civil Services (ACP) Rules. 2008, the following provisions regarding responsibility has been mentioned:-

"On placement in the ACP pay structure, the Government servant shall continue to hold operational duties of his previous post held by him and will continue to hold the previous designation till such as he is actually promoted to the higher post on the occurrence of a vacancy."

Further, as per note below Rule 18 of Haryana Civil Services (ACP) Rules, 2008:-

"Note — The placement in the first, second or third ACP pay structure, as the case may be, does not amount to a functional promotion and therefore the presumption of higher responsibility cannot be taken in such placements in the ACP pay structure. However, still the benefit of fixation of pay corresponding to the placement in the higher pay structure as a consequence of promotion that is presuming the higher responsibility shall be extended at the stage of fixation of pay in the first, second or third ACP pay structure, as the case may be.

It is clear from above provision that benefit of fixation of pay in lieu of promotion is granted on grant of ACP even though an employee does not shoulder higher responsibility.

18. Whereas, Administrative department has been requested to explore the possibility of posting clerks in Elementary, Secondary and Senior Secondary schools as per their seniority i.e. clerks with higher seniority i.e.

having 3rd ACP be considered for posting in the bigger institutions like O/o, DEO, DEEO, BEO & Senior Secondary Schools and elerks with lower seniority i.e. having 2rd / 1st ACP, in middle school and Elementary schools respectively.

Thus, by and large the demand of the petitioners is devoid of merit and hence cannot be accepted. Only thing that merits considerations, is posting Clerks in different offices/schools, based on their semonty, the same has been referred to the Administrative Department.
