Whereas, Sh. Narender Kumar had filed the CWP No. 20189 of 2021 - *Narender Kumar Vs. State of Haryana & Others* in the Hon'ble Punjab & Haryana High Court, praying therein for issuance of a writ in the nature of certiorari for quashing the action of the respondents in not to granting the arrears of pay in view of judgment passed by the Hon'ble Supreme Court of India in case of KV Janakiraman, (Annexure P-14) as the petitioner was ready and willing to join the services and the principle of no work no pay cannot be applied herein as the other similar employee has already been granted the similar benefit vide order dated 10.09.2015 (Annexure P-11) and compliance of the orders had already been made during the pendency of contempt petition vide order dated 20.05.2016 (Annexure P-12) and as the similar claim of other similar employees of Development & Panchayat Department has been considered by this Hon'ble Court. Petitioner further, prayed for issuance of a writ in the nature of mandamus, directing the respondents to grant the arrears of pay after deducting the remuneration already drawn by the petitioner being guest faculty, as such benefit has already been granted to other similarly situated employee as the petitioner was kept away from regular employment.

The above mentioned writ petition came up for adjudication on 11.10.2021 and the Hon'ble Court disposed of the same vide order dated 11.10.2021. The operative part of the same is as under: -

".....Keeping in view the limited prayer addressed, facts and circumstances of the case but without expressing any opinion on the merits thereof, this writ petition is disposed of with a direction to the competent authority, to decide legal notice dated 10.10.2017, Annexure P-8, filed by the petitioner including the question of delay, if any, by passing a speaking order, within three months from the date of receipt of certified copy of this order."

In compliance of the above said order dated 11.10.2021 passed by the Hon'ble High Court, the legal notice dated 10.10.2017 (Annexure P-8) has been minutely examined. Whereas, Sh. Narender Kumar was applied for the post of Post Graduate Teacher (hereinafter referred to as 'PGT') - Physics against the advertisement no. 1/2012 under BC Category.

Whereas, the Department of School Education sent a requisition to the Haryana Staff Selection Commission, Panchkula (hereinafter referred as 'HSSC') for selection and recommendation of the names of eligible candidates for the post of PGT Physics and accordingly, HSSC advertised the said posts vide Advertisement No. 01/2012 dated 07.06.2012.

Furthermore, it is stated here that the whole selection process i.e. from issuing advertisement to the declaration of final result is carried out by the HSSC. But, the HSSC not recommended the name of the petitioner in the recommendation list being a eligible candidate in pursuance to the advertisement No. 01/2012. Thereafter, Sh. Narender Kumar filed *CWP No. 20857 of 2013 - Narender Kumar Vs. State of Haryana & Others*, which was allowed by the Hon'ble High Court vide judgement dated 01.05.2017. In compliance of the judgment dated 01.05.2017, the HSSC recommended the name of the petitioner vide recommendation bearing no. HSSC/Conf./Recomm./PGT/2017/656 dated 14.07.2017 and in pursuance to said recommendation, the office of undersigned after completing all administrative procedures/formalities, issued appointment to the petitioner vide this office order bearing no. 4/33-2017 PGT-I(4)/Physics dated 01.12.2017.

Whereas, the O/o undersigned immediately after getting the recommendation from HSSC issued appointment to the petitioner. However, the main accusation of the petitioner as per legal notice dated 10.10.2017 is with HSSC, which has already been resolved as referred *supra*. Forasmuch, it is germane to mention here that the department of undersigned do everything in a time bound frame and also in an adequate manner.

Whereas, the petitioner has already afforded the notional benefits of seniority and pay fixation at par with his junior. However, it is a settled

principle that the actual benefits are admissible w.e.f. the date of joining of every employee.

Whereas, the petitioner placed reliance upon the judgment passed by the Hon'ble Apex Court in KV Janakiraman's Case (Annexure P-14) in the captioned writ petition and stated that the said judgment is not applicable to him as he was ready and willing to join the services. But, it is ample clear from the prayer clause of the captioned writ petition that he served as Guest Teacher before joining a PGT. The intention of willingness of petitioner is itself cleared from this fact. If, there was a willingness of the petitioner to join as PGT, then why would he serve in continuity as a guest a teacher during the pendency of *CWP No. 20857 of 2013*?

Furthermore, by quoting the above observation the petitioner wants to grab an un-due advantage, which is totally against the principle of natural justice.

Whereas, the principle of 'NO WORK NO PAY' as per the judgment passed by the Hon'ble Apex Court in *KV Janakiraman's* case is applicable in the case of Sh. Sh. Narender Kumar due to the reasons stated *supra*.

In furtherance, petitioner placed reliance upon the benefits granted to one PGT namely Smt. Kavita Hooda, whereby, petitioner submitted that the Department has afforded the benefits of difference of pay (service rendered between Gust Teacher and Regular PGT) to Smt. Kavita Hooda. In pursuance to the said contention of the petitioner, the appointment related file of Smt. Kavita was examined and it has been found that the benefits of difference of pay as referred *supra* were afforded to Smt. Kavita Hooda erroneously. Accordingly, the Department has decided to withdraw the said benefits afforded to Smt. Kavita Hooda. Therefore, the petitioner is also not entitled for any arrear/difference of pay for which he didn't work.

In view of the above mentioned facts and official record, the claim of the petitioner demanded through Legal Notice dated 10.10.2017 (Annexure P - 8) has already been settled and is now rendered infructuous.

Further, the demand of the petitioner w.r.t. issuance of arrears of pay in view of judgment passed by the Hon'ble Apex Court in KV Janakiraman's case is also hereby rejected due to the reasons stated *supra* and being devoid of merits.

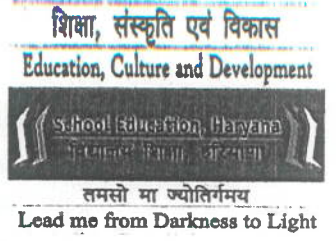

Terms and conditions:-

1. His appointment is against a purely temporary post which is liable to be abolished at anytime and carries no promise of subsequent permanent employment. 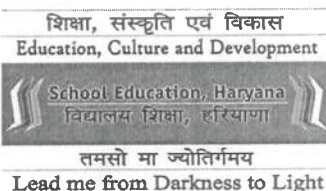



2. They are also directed to participate in next online transfer drive for taking permanent Station.

TERMS & CONDITIONS:-

1. Their appointment is against a purely temporary post which is liable to be abolished at anytime and carries no promise of subsequent permanent employment. No offer of permanent vacancy can be made to them at present. Their services can be terminated without any notice, whenever there is no vacancy against which they can be retained.
2. If at any stage they desire to resign their posts they will be required to give one month's notice or forfeit in lieu thereof, their salary including allowances for one month or for the period by which the notice falls short of one month.
