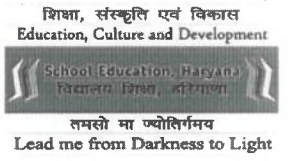

Whereas FIR No. 076 dated 12.03.2013 and FIR No. 0298 dated 11.09.2013 were lodged against Sh. Ramphal Sharma (Retd.) ESHM, GHS Siwada, Distt. Bhiwani for committing offences of domestic violence. Consequently, Sh. Ramphal Sharma (Retd.) ESHM was placed under suspension w.e.f. 19.10.2013 (deemed date of suspension) vide order dated 10.01.2014, however, the delinquent was placed in custody on 18.10.2013. Thereafter, the delinquent was reinstated in service with immediate effect without prejudice to the disciplinary/judicial action pending against him vide order dated 20.02.2014.

Subsequently, the delinquent was acquitted in both the abovementioned cases vide judgment dated 24.01.2018 and 19.08.2019 respectively by the Court of Judicial Magistrate First Class, Bhiwani. It is also stated here that no judicial proceeding is pending against the delinquent in above mentioned cases. Thereafter, the delinquent submitted his representation dated 24.09.2021 in Directorate of Elementary Education, Haryana, Panchkula stating therein that the delinquent was acquitted in the both the abovementioned cases vide judgment dated 24.01.2018 and 19.08.2019 by Trial Courts, Bhiwani and praying therein to treat the suspension period from 18.10.2013 to 20.02.2014 as duty period. The representation was duly considered by the undersigned in the light of Rule 89 of Haryana Civil Services (General) Rules, 2016. Also, no appeal against the judgment dated 24.01.2018 and 19.08.2019 had been filed.

Whereas, after examining all the facts and in light of the judgment dated 24.01.2018 and 19.08.2019 by District Courts, Bhiwani, it is evident that the delinquent is not guilty of above mentioned offences and also no judicial proceeding is pending against the delinquent in above mentioned cases.

Hence, in view of the above narrated facts, after having regard to the facts and circumstances of the case and in the light of Rule 89 of Haryana Civil Services (General) Rules, 2016. I, being the competent authority is of the considered view that the suspension period from 18.10.2013 to 20.02.2014 be treated as duty period of Sh. Ramphal Sharma (Retd.) ESHM, GHS Siwada, Distt. Bhiwani.
