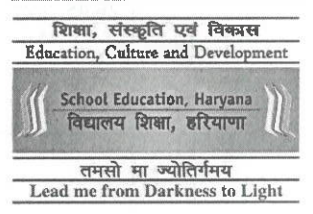

Terms & Conditions:-

1. In case the claim belonging to disability certificate of any TGTs is found false and fabricated at any stage later on, he/she would be reverted without any notice and without any prejudice to such further disciplinary action as may be initiated under the provisions of the Indian Penal Code for production of such false/fabricated documents.

2. The candidate is directed to provide latest disability certificate in accordance with the Government of Haryana Gazzette Notification No. 32/05/2019-6HB-I dated 05.08.2021 within 30 days of joining to promotional post, failing which, he/she would be reverted without serving upon a notice, if he is still in service.
3. The date of this Roaster/promotion can be changed/amended/alterd, if required on the basis of any legitimate claim of some other or any of the TGT in the cadre.
4. In addition to these candidates, if claim of another disabled TGT is found legitimate in respective category, the junior most would be reverted without a notice and concerned senior disabled TGT would be promoted.
5. The candidate would not claim any arrear of pay on account of his/her notional promotion and only notional benefits of pay fixation will be granted. He/She would be granted actual benefit of pay fixation from actual date of joining to promotional post.
6. If any discrepancy regarding not fulfilling the essential qualifications as prescribed in the Haryana State Education School Cadre (Group B) Service Rules, 1998 & 'Haryana State Education School Cadre (Group B) Service Rules, 2012 amended in 2014', the said incumbent(s) shall be reverted without issuing any notice.
7. The Promotee(s) will remain on probation for one year as per rule 27 of Haryana Civil Services (General) Rules, 2016.
8. After promotion, seniority of these employees will be determined as per instructions/rules issued or notified by the Govt. of Haryana, School Education Department from time to time.
9. The concerned District Education Officers will ensure before joining that no enquiry/charge sheet/embezzlement/punishment effect etc. is pending against the promottee. In case if such a matter come into the notice, the promotion will be withdrawn as per rules.
10. The candidate would have no claim of seniority over those who are otherwise senior to him/her but his/her case could not have been got considered for promotion due to one reason or the other.
11. In case any adverse remarks found in his/her ACRs, later on or any ACR is awaited/missing ACRs, he/she would be reverted without serving any notice.
12. He/She would be liable for reversion without giving any notice in case any other official emerges as senior most in the respective seniority list.
13. The promotion would be as per the respective pay scale issued by the Finance Department, Govt. of Haryana from time to time.
14. The newly promote Headmasters shall have to seek permanent posting through MIS portal by participating in Transfer Drive.
15. **The concerned District Education Officers will ensure to have an undertaking before joining from the newly promoted Headmasters to the effect that on having**

this promotion, he/she will leave the other promotion availed earlier being in general seniority.

16. He/ She has also not claim seniority above his/her senior on the basis of this promotion and he/she would be reverted to the post of TGT without serving any notice if any senior to him/her is/are found fit or entitled for promotion at later stage in the event of decision in the seniority position made by the department.
17. The promotions under these instructions have been granted to the persons with disabilities who may be junior to others in the seniority list. No benefit of stepping up of pay or pay scale shall be admissible to others who were/are senior to him/her in the TGT Cadre.


