It is, however, pointed out that only such documents will be shown to him as are in the possession of the Director Secondary Education, Haryana, Panchkula, and as are strictly relevant to the case. If in the opinion of the Government, it is not desirable in the public interest, to allow him access to any document, such access shall be refused. If, Shri Rajeev Vats, wishes to consult any other relevant record, which is not in the custody of the Director, Secondary Education, Haryana, Panchkula, it is for him to undertake its inspection. It is, however, made clear to Shri Rajeev Vats that his failure to inspect the documents shall not constitute a valid ground for delay in the submission of his written statement and if the written statement is not received by the undersigned within the specified period, it shall be presumed that he has none to submit.

**Statement of charges against Shri Rajeev Vats [031468] the then Post Graduate Teacher in Biology posted as Consultant in the office of Haryana School Shiksha Pariyojana Parishad [now posted as Principal at Government Senior Secondary School, Mundri (2278), Kaithal].**

While being posted as Post Graduate Teacher in Biology and posted as Consultant in the office of Haryana School Shiksha Pariyojana Parishad from 15.03.2011 to 17.01.2019, Shri Rajeev Vats committed following certain acts of omission and commission for which he is charged as under :-


That the Chief Vigilance Officer office of Director Secondary Education, Haryana, Panchkula afforded personal hearing to him i.e. Shri Rajeev Vats on 20.05.2022 to enquire the issue related to unauthorized working in Dodoma University, Tanzania and he i.e. Shri Rajeev Vats submitted his reply on dated 20.05.2022. On examination of the record, following irregularities were found to be committed by him i.e. Shri Rajeev Vats:-

1. That he i.e. Shri Rajeev Vats [031468] requested for extension of extra ordinary leave from 16.06.2012 to 15.06.2013 and 16.06.2013 to 15.06.2014 vide applications dated 12.05.2012 and 09.05.2013 respectively without any prescribed Performa in violation of the then prevalent rule 8.4 of Punjab Civil Service Rule Volume-I Part-I [now rule 22(1) of the Haryana Civil Services (Leave) Rules, 2016].
2. That he i.e. Shri Rajeev Vats availed extra ordinary leave from 16.06.2012 to 15.06.2014 without the prior approval of the competent authority and thus, violated the then prevalent rule 8.47(2) of Punjab Civil Service Rule Volume-I Part-I [now rule 19(1) of the Haryana Civil Services (Leave) Rules, 2016].
3. That he i.e. Shri Rajeev Vats applied for extra ordinary leave from 16.06.2013 to 15.06.2014 vide application dated 09.05.2013 though extraordinary leave was admissible only for the period of 24 months and thus violated the then prevalent rule 8.137(1) of Punjab Civil Service Rule Volume-I Part-I [now rule 41(iii) of the Haryana Civil Services (Leave) Rules, 2016].
4. That he i.e. Shri Rajeev Vats appeared for interview for selection with University of Dodoma Tanzania and requested vide application dated 25.05.2011 for extra ordinary leave for such appointment in violation of the then prevalent rule 8.41 of Punjab Civil Service Rule Volume-I Part-I and rule 15 of Government Employee (conduct) rules, 1966 [now rule 20 of the Haryana Civil Services (Leave) Rules, 2016]. Further, he i.e. Shri Rajeev Vats mislead the Government vide application dated 06.04.2011 for extra ordinary leave from 06.06.2011 to 05.06.2012 for domestic reasons but utilized these leave for working with University of Dodoma Tanzania.

In this way, he i.e. Shri Rajeev Vats committed an act unbecoming of a Government officer and violated the provisions of rule 4(1) and (2) of the Haryana Civil Services (Government Employees Conduct) Rules, 2016 and Government Employee (conduct) rules, 1966 and rule 8.4, 8.47(2), 8.137(1) & 8.41 of Punjab

Civil Service Rule Volume-I Part-I [now rule 20, 22(1), 19(1) 41(iii) of the Haryana Civil Services (Leave) Rules, 2016]

That the Chief Vigilance Officer office of Director Secondary Education, Haryana, Panchkula afforded personal hearing to him i.e. Shri Rajeev Vats on 20.05.2022 to enquire the issue related to unauthorized working in Dodoma University, Tanzania and he i.e. Shri Rajeev Vats submitted his reply on dated 20.05.2022. On examination of the record, following irregularities were found to be committed by him i.e. Shri Rajeev Vats:-


1.
