Terms and conditions:-

1. His appointment is against a purely temporary post which is liable to be abolished at anytime and carries no promise of subsequent permanent employment. No offer of permanent vacancy can be made to her at present. Her services can be terminated without any notice, whenever there is no vacancy against which she can be retained.
2. If at any stage her desire to resign her post she will be required to give one month's notice or forfeit in lieu thereof, her salary including allowances for one month or for the period by which the notice falls short of one month. 6. The candidate will has to qualify the State Eligibility Test in Computer Appreciation and applications (SETC) within the probation period of two years, extendable by one year in case of direct recruitment. The candidate appointed against the aforesaid categories of posts in the group 'C' shall not be entitled to earn any increment in his pay scale till he/she qualifies the said test failing which the services of such employee will be dispensed with.

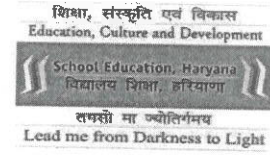

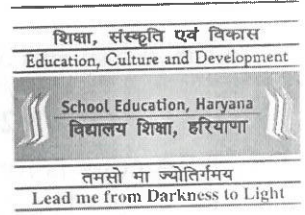

No. 13/52-2022 PGT-II (6)

Dated, Chandigarh, the 29.11.2022

Whereas, the petitioner, Smt. Jyoti Rani (Emp. Id 061171) PGT Hindi filed CWP No.17844 of 2022 titled as Jyoti Rani V/s State of Haryana and others, for issuance of a writ of certiorari for quashing the order dated 03.08.2022 (Annexure P-14) passed by respondent no.3 i.e. Director Secondary Education. Further prayed for issuing a writ of mandamus to direct the respondent No.1 to decide the recommendation of District Level Committee, Hisar dated 29.06.2021 (Annexure P-11) for exemption from participating in Transfer Drive as approved by the 'District Level Committee' w.r.t. petitioner, as such power is bestowed upon only respondent No.1 in view of clause 14 of whereby Administrative Secretary, School Education shall be competent to transfer any teacher in relaxation of any or all of the provisions thereof.

Whereas, the Hon'ble High Court disposed of the same with the directions to respondents to decide the representation of the petitioner. The operative part of the order dated 22.08.2022 is as under:-

Notice of motion.

On the asking of the court, Mr. Harish Nain, A.A.G., Haryana, accepts notice on behalf of the respondent-State.

He submits that in case any representation is filed, it will be considered in accordance with law and appropriate orders will be passed within a period of 03 weeks.

As prayed for by learned counsel for the petitioner, the present petition is disposed of with liberty as prayed for.

Whereas, in compliance of the above said order, the representation dated 19.09.2022 of petitioner alongwith the recommendation of the District level Committee has been examined and it is found that she sought exemption from transfer on the ground of Couple case and ill health of her mother-in-law. However, as per the teacher transfer policy decision for allotment of a vacancy shall be based on the composite score of merit points earned by a teacher. Merit points are the sole criteria alongwith other factors to be counted as given in Para No. 7 of the said policy. Ten points have been given for the special

factors such as diseases of self/spouse/unmarried children but not including the diseases of relatives. Five points have also been provided for couple case which can be availed by the petitioner.

Whereas, teachers himself/herself suffering from various ailments as mentioned in para no. 9 of the said policy are exempted from transfer subject to conditions. However, they cannot seek exemption in transfer on the basis of illness of their relatives. In the present matter, the recommendation of the District Level Committee is the basis of couple case and ill health of the mother-in-law of the petitioner for which she claims merit points. However, the recommendation of the District level Committee cannot be override the Teacher Transfer policy, 2016 (as amended).

Whereas, in the present matter, the petitioner was transferred from Zone 1 to Zone 7 so as per the provisions of Teacher Transfer Policy, 2016 (as amended) and she was is not entitled for relaxation under Teacher Transfer Policy. Resultantly, the petitioner had to compulsorily participate in teacher transfer drive, 2022.

Whereas, the petitioner submitted her representation on dated 19.09.2022 which has been examined in view of the provisions of the policy and it is found that as per MIS profile of the petitioner, she was initially appointed as in Government Girls Senior Secondary School, Adampur Mandi, Hisar (4071) (Zone-3), on dated 10.12.2004. Thereafter, the petitioner was transferred to Government Girls Senior Secondary School Kaimri Hisar, (1448) (Zone-1) dated 27.07.2005. Further, it is stated that the petitioner was transferred to Government Girls Senior Secondary School, District Hisar (1444) (Zone-1) on dated 02.08.2013. Thereafter, the petitioner was made compulsorily participant in the Teacher Transfer Drive, 2016, during which the petitioner transferred to GSSS Barwa, Bhiwani (4124) in Zone-5 on 21.12.2016. Again, she was manually transferred to GSSS Hisar (Patel Nagar) Hisar (1466) (Zone-1) on administrative ground vide order dated 27.06.2019. Since, petitioner had completed 14 years 6 months 29 days tenure in Zone-1

from 27.07.2005 to 24.12.2016 and 27.06.2019 to 31.08.2022 so as per the Teacher Transfer Policy, she cannot be entitled for protection under Para 9(4) read with 8(1)b(1), because every regular service rendered in the Department is counted towards their stay in Zone. Now, she herself participated in teacher transfer drive, 2022 wherein she filed 29 choices out of which 2nd choice of her was allocated to her during Round-1. Therefore, she was rightly transferred as per policy from GSSS Hisar Patel Nagar (1466) Hisar Zone-1 to GGSSS Balsamand Hisar, Zone-7 and she even has joined in the allocated school on 01.09.2022.

Keeping in view of the facts enunciated above and averments made in her representation dated 19.09.2022, petitioner's claim is not tenable at this stage as her transfer has been done as per the provisions of the transfer policy, 2016 (as amended) and station has been allotted to petitioner of her choice. Therefore, the claim of petitioner namely Smt. Jyoti Rani (Emp. Id 061171) PGT Hindi as prayed in her representation dated 19.09.2022 is hereby rejected being devoid of merits.
