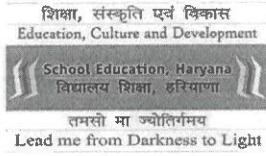

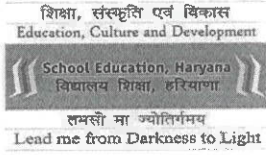

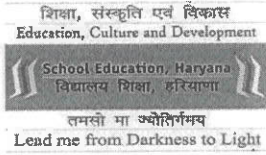

ORDER No. 13/51-2022 PGT-II (7) DATED, PANCHKULA, THE 12/12/2022

Whereas, Mr. Lakhbir Singh (Empl.Id 5020928), PGT Punjabi had filed the CWP No. 17703 of 2022 titled as Lakhbir Singh Vs State of Haryana and others, for issuance of a writ in the nature of mandamus to direct the respondent no.2 to consider candidature of the petitioner as protected at their present school for online transfer drive 2022 as per clause 6 of the teacher transfer policy, while the petitioner are not eligible for compulsory transfer, because the petitioner has not completed his 5 years stay/tenure in a particular school/zone of any District(s), as per Transfer Policy dated 01.06.2017 (Annexure P-2). That the tenure of the petitioner at presented posting station is less than 3 years, that option for voluntary participation should be obtained from the petitioners as per clause 6 of the teacher transfer policy.

That the writ petition came up for hearing before this Hon'ble Court on 10.08.2022 and Hon'ble High Court was pleased to dispose of the same with the directions to respondents as under:-

*"Vide this common order, three petitions, the details of which have been given in the heading, are being disposed of as common question of law arises in all of them.*

*Learned counsels for the petitioners submit that the petitioners have a genuine grievance with regard to the change of cut off date from 31.03.2022 to 31.08.2022 by the respondents as a lot of employees will be suffering their transfers due to this action of the respondents, despite the fact that as per the original Transfer Policy, the petitioners were not compulsorily supposed to participate in the said transfer drive.*

*Learned counsels for the petitioners further submit that even by taking a compassionate point of view, the hardship of the petitioners can be reviewed by the respondents, and therefore, the petitioners may kindly be given liberty to approach the respondents for redressal of their grievances by*

*way of filing the appropriate representations before the authorities concerned.*

*Notice of motion.*

*Mr. Harish Nain, AAG, Haryana, keeping in view the advance service of the copies of petitions, accepts notice on behalf of the State and submits that in case any such representations are filed by the petitioners before the authorities concerned, the same will be considered in accordance with law and after consideration, if the petitioners are found meritorious, the appropriate speaking orders will be passed within a period of ten days from the date of receipt of such representations.*

*At this stage, learned counsels for the petitioners submit that keeping in view the submissions of learned State counsel, as recorded hereinbefore, no further grievances of the petitioners survive in the present petitions at this stage and the same may kindly be disposed of as having been not pressed any further at this stage with the liberty as prayed for.*

*Ordered accordingly.*

*Photocopy of this order be placed on the files of other connected cases."*

In compliance of the Hon'ble High Court Order dated 10.08.2022, the case of the petitioner namely Lakhbir Singh (Empl.Id 5020928), PGT Punjabi has been examined by the department in view of the provisions of policy. Employees are contending that they are forced to participate in the General transfer Drive, 2022. That the Transfer Drive, 2022 was not concluded till 31.03.2022 because of the reason the stay granted by the Hon'ble Court in bunch of matters tagged along with CWP No. 15099 of 2021 titled as Ashish Bala and ors. Vs State of Haryana and ors., which was decided on 07.05.2022. Though the cut-off date for transfers in the transfer policy is mentioned as 31.03.2022, however due to interim stay orders of the Hon'ble High Court, the on line transfer drive could not be conducted on time and the Department vide order no. 4/33-2011- SE (4) dated 09.08.2022, the cut-off date has been considered as

31.08.2022 for online Teacher Transfer Drive, 2022. As per MIS profile of the petitioner, he was temporarily adjusted in Government High School, Udaipur, Ambala (169) on 13.09.2019 being new appointee as PGT Punjabi vide order no.6/34-2019 PGT-I(2). Being new appointment, the petitioner was made compulsorily participant in the Teacher Transfer Drive, 2022.

In view of the submissions made above, the claim of petitioner is not tenable as there is no merit in case of petitioner and the same is liable to be rejected.

I order accordingly.
