

Whereas, Smt. Nirmal Dahiya filed the present Civil Writ Petition no. 23215 of 2022 titled as Nirmal Dahiya v. State of Haryana and others with prayer to quash the promotion orders of her juniors dated 03.10.2022 and promote her to the post of Haryana Education Services (HES)-I officer.

The Hon'ble Punjab & Haryana Court, Chandigarh on dated 28.10.2022 issued directions as under:-

“Learned counsel for the State submits that representation of the petitioner raising the same grievance is already under consideration with regard to the claim of the promotion and a weeks' time be granted, so that, the concerned department would analyse whether, the petitioner's claim for promotion needs to be granted or not.

Adjourned to 04.11.2022.”

Whereas, in compliance of the above said orders, the legal notice dated 05.10.2022 of the petitioner was considered and it is found that a committee of four members was constituted by the Director Secondary Education, Panchkula vide order no. 13/126-2021 HRME-I (3) dated 15.09.2021/20.09.2021. The petitioner was also accorded with opportunity to participate in the enquiry process. The said committee submitted its final report dated 17.12.2021, wherein the irregularities were found to be committed by Smt Nirmal Dahiya, reason being that she extended the benefit of arrears of Rs.5,17,245/- of pay fixation to one, Sh. Jai Bhagwan, Peon posted in the office of BEO, Bhiwani w.e.f. 19.08.2014 on the basis of photocopy of order no. E-1/2019/6997-7052 dated 30.12.2019 though the above-said order was modified by passing order no. E-1/2019/7056-7131 dated 31.12.2019 whereby benefit of notional pay fixation was only to be granted. Thus, due to her act of omission, causing loss to the State Exchequer while disbursing arrears to class-IV

employees without seeking any clarification and approval from higher authorities.

Whereas, the competent authority granted approval to issue charge-sheet against the petitioner under Rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 prior to issuance of her promotion orders dated 03.10.2022/04.10.2022. Hence, she was rightly not promoted, as the disciplinary proceedings under Rule-7 were already contemplated against her before the issuance of promotion orders. Further, the petitioner has now also been served with the charge-sheet vide dated 21.10.2022.

Keeping in view of the facts enunciated above and documents on record, the claim of the petitioner is not tenable at this stage and the same is hereby rejected for the time being devoid of merits.

(c) **Medical Treatment Reimbursement Time Limit for preferring claims (12 Months).**

(Copy of H. D. Hr. No. 2/660/2003 - 1 HB - III dt. 11.12.03)

I am directed to invite your attention to this office circular No. 2/401-1 HB-III-80, dated 6.3.1980 on the subject cited above.

2. The matter regarding time limit for preferring claims for reimbursement of medical expenses incurred by the government employees/officers on their own treatment or on the treatment of their dependants has been further considered by the Government and it has been decided that the Secretary of the Administrative Department concerned shall be competent to sanction medical claims submitted after 6 months but within a period of 12 months from the date of completion of treatment without referring the same to the Health Department. The Medical claims submitted after a period of 12 months from the date of completion of treatment shall be referred to the Health Department in order to curb the tendency of unnecessary delay in submission of medical claims. The Health Department will entertain such medical claims only after strict scrutiny and in such exceptional cases where there are genuine mitigating circumstances i.e. like the death of the employee resulting in delay in submitting claims etc. These instructions shall come into force with immediate effect.
