Subject: - **Regarding Obtaining the Approval of Finance Department (HKRN Cell) for Engagement of Fresh Contractual Manpower.**

Sir/Madam,

I am directed to invite your attention towards the "Deployment of Contractual Persons' Policy 2022" dated 30.6.2022 issued by Human Resource Department, Chief Secretary Office. As per the provision contained in para 5.2 and 5.3 of the said policy it is clearly mentioned that indenting organizations shall quantify its requirement for contractual manpower and get the prior approval from Finance Department through their Administrative Secretary concerned and indenting organizations shall submit their requisitions with the copy of prior approval of Finance Department.

2. It has been observed that large number of cases are being received on the online portal of Haryana Kaushal Rojgar Nigam in Finance Department from Departments/Boards/Corporations/Universities for approval of fresh contractual manpower without obtaining the necessary approval from their Expenditure Controlling Branches concerned of the FD. Further, in number of cases, it has been noticed that Heads of Departments are not aware of the requisition of fresh contractual manpower uploaded on HKRN portal, rather uploaded at the level of DDO/Junior Level Officer of the Department.

3. Hence, Departments/Boards/Corporations/Universities are advised to obtain prior approval of Finance Department (Expenditure Controlling Branch) for engagement of fresh contractual manpower and approval should invariably be uploaded along with the requisition for engagement for fresh manpower through HKRN by Departments/Boards/Corporations. Also, data uploaded on the portal

should be verified/ submitted by HoD himself under his authority not by DDO/Junior Level Officer of the Department. In case, the aforementioned procedure is not adhered to by the Departments/Boards/Corporations/Universities their proposal on the portal will not be entertained by the FD (HKRN Cell).
