



However, she was not entitled for said benefit in view of the Rule 4.4 of Punjab Civil Service Rule Vol.-I Part-I read with Rule 1.2(i) Punjab Civil Service Rule Vol.-I Part-I wherein the benefit of pay protection was to be granted only those employees who have rendered previous service under Haryana Government, but Smt. Sushila Khokhar, Headmistress rendered her previous service under Kendriya Vidhalaya Sangathan which is Central Government Educational Institution. As per instruction No.1/2/77/87-2FR/IT dated 20.08.1988 also an employee, who has shifted from a Central Autonomous Body to Haryana Government Service will be entitled to the benefit of past service towards pensionary benefits only, subject to fulfilment of terms & conditions. Besides that Finance Department Haryana has also advised vide U.O. No. 1/54/2017-4PR (FD) dated 29.11.2017, that there is no provision in CSR Vol.-I (Part-I) to extend the benefit of past service in the

Order No. 13/237-2022 HRME-I (4) Dated, Panchkula the -09/01/23

Whereas the petitioner had the filed CWP No. 19878 of 2022 titled as Kailasho Devi versus State of Haryana and others before the Hon'ble Punjab and Haryana High Court praying therein for issuance of a writ in the nature of mandamus to regularize the services of petitioner as sweeper/water-carrier in view of policy dated 01.10.2003 (Annexure P-1) while treating the case of the petitioner at par with the other similar situated employee who have been regularised in view of this policy/instructions.

The above said writ petition came up for hearing on 05.09.2022 and the same was disposed of by the Hon'ble High Court with the direction to respondents No 02 to decide the legal notice dated 18.04.2022 (Annexure P-3). The operative part of the order dated 05.09.2022 of the Hon'ble High Court is as under:-

"Without commenting upon the merit of the case or about the entitlement of the petitioner for the relief which has been claimed by the her in the legal notice dated 18.04.2022 (Annexure P-3), present writ petition is disposed of with a direction to respondents No. 2 to decide the legal notice dated 18.04.2022 (Annexure P-3) within a period of 8 weeks from receipt of copy of this order"

In compliance of the above said orders of the Hon'ble High Court, the legal notice dated 18.04.2022 (Annexure P-3) of the petitioner alongwith her official was examined and found that the petitioner was engaged as a part-time water-carrier (Kahar) on 02.11.1996 in Government Primary School, Dhandheri (Hisar) at non-sanctioned post of Class-IV and she remained there till 24.12.2003. Thereafter, she voluntarily left her part-time job on 24.12.2003 due to the reasons best known to her.

Whereas, it is pertinent to mention here that the seniority of part time Class-IV employees was at institutional level as per the regularization policy dated 30.12.1998/25.02.1999 and according to this policy only those part time Class-IV employees were entitled for regularization of their services against vacant regular sanctioned post who had requisite experience mentioned in the said policy in the institutions where sanctioned posts of Class-IV were available. But, the petitioner could not be regularized as per policy dated 30.12.1998/25.02.1999 because she did not fulfil the terms and conditions of the said policy. Thereafter, the policy dated 30.12.1998/25.02.1999 was superseded by new departmental regularization policy dated 11.11.2003 & accordingly a common seniority of all the part time Class-IV employees was made at District level. But since the petitioner had voluntarily left her part time job of Class-IV, so she could not be regularized under the departmental regularization policy dated 11.11.2003. Thereafter, she again joined on 04.08.2014 as fresh entrant as part-time sweeper in Government Girls Senior Secondary School, Dhana Kalan (Hisar). Thus, there is long break in her part-time service of Class-IV w.e.f. 24.12.2003 to 03.08.2014. That's is why she could not be considered for regularization under the departmental regularization policy dated 11.11.2003.

Keeping in view, the facts and circumstances of the case, the claim of the petitioner demanded through legal notice dated 18.04.2022 is not tenable and hence rejected.

I order accordingly.
