Umesh Kumar** is hereby further informed that if for the purpose of preparing his written statement, he wishes to have access to the relevant official records, he should inspect the same in the office of the Director General, School Education, Haryana, Panchkula, on any working day after making prior appointment with him. It is, however, pointed out that only such documents will be shown to him as are in the possession of the Director General, School Education, Haryana, Panchkula and as are strictly relevant to the case. If in the opinion of the Government, it is not desirable in the public interest, to allow him access to any document, such access shall be refused. If, **Sh. Umesh Kumar** wishes to consult any other relevant record, which is not in the custody of the Director General, School Education, Haryana, Panchkula, it is for him to undertake its inspection. It is, however, made clear to **Sh. Umesh Kumar** that his failure to inspect the documents shall not constitute a valid ground for delay in the submission of his written statement and if the written statement is not received by the undersigned within the specified period, it shall be presumed that he has nothing to submit.

Whereas, Sh. Parmod Kumar has filed the Civil Writ Petition No.2152 of 2022 titled as Parmod Kumar vs. State of Haryana & Others in the Hon'ble Punjab & Haryana High Court prayed for fixation of pay of the petitioner at par with junior (Ishwar Singh) with releasing the arrears along with interest.

The aforesaid writ petition came up for hearing before the Hon'ble Punjab and Haryana High Court on 07.02.2022 and on that day Hon'ble Court was pleased to dispose of the same with directions to respondents. The operative part of the order dated 07.02.2022 is as under:-

Notice of motion.

Mr. Kiran Pal Singh, AAG., Haryana, accepts notice on behalf of the respondents. Advance copy of the writ petition stands supplied.

At this stage, learned counsel for the petitioner restricts the prayer for a decision on the petitioner's claim, in a time bound manner.

Learned counsel for the respondents does not raise any serious objection to the restricted prayer.

Keeping in view the limited prayer addressed, facts and circumstances of the case but without expressing any opinion on the merits thereof, this writ petition is disposed of with a direction to the competent authority, to decide petitioner's claim as has been forwarded by the Principal Government Girls Senior Secondary School, Siwani Mandi (Bhiwani) and the Block Education Officer, within a period of three months from the date of receipt of certified copy of this order. In case, the petitioner is found entitled to any of the benefits, the same be released within a period of four weeks thereafter.

Whereas in compliance of the said directions, the matter of the petitioner has been minutely examined by department and it has been found the petitioner namely sh. Parmod Kumar was initially appointed as JBT/PRT on 01.12.1997 and was promoted to the post of S.S.Master vide order no. 2/9-2008 HRM-1(4) dated 18.10.2010 and then promoted as PGT Sociology vide order no. 15/13-PGT-II (3) dated 24.04.2017. However, it is further submitted that the petitioner has cited one example i.e Ishwar Singh, S.S. Master at par claim. Furthermore, the service record of Ishwar Singh has been examined and found that the fixation of pay has been granted wrongly by the department. Hence, the show cause notice has been issued to Sh. Ishwar Singh for re-fixation of pay by the office of District Elementary Education Officer, Fatehabad vide Order No. E-I-22/44769-72 dated 16.11.2022.

Whereas, in compliance of said order, the Office of Headmaster, GHS, Kumharia has been examined the case of Sh. Ishwar Singh and found that he was initially appointed as JBT Teacher on 02.12.1997. Being a JBT of reserved category of Schedule Caste, he was promoted to the post of Head Teacher on 13.06.2003 after completion of 5 and half year service and then promoted to the post of SS Master vide order no. 2/9-2008 HRM-1(4) dated 18.10.2010. As per conditions in service rule, when a JBT Teacher got two promotion one is Head Teacher and 2nd is SS/TGT from feeder cadre i.e. JBT, then the post of Head Teacher shall be treated as Ex-Cadre post and the pay of the the employee is to be fixed as per Rule-13 of Haryana Civil Services (ACP) Rules, 2008 and 2016. In the case of Sh. Ishwar Singh, he had got two ACP from the post of Head Teacher instead of feeder cadre of JBT which was wrongly granted. Now, the pay of Sh. Ishwar Singh re-fixed at Rs.17690 as on 18.10.2010 after reviewing into the matter by District Elementary Education Officer, Fatehabad vide order no. E-I-22/44592-95 dated 8.12.2022. Due to re-fixation of pay on promotion of Ishwar Singh as S.S.Master by DDO, both employees namely Sh. Parmod Kumar and Sh. Ishwar Singh are equal in pay. Hence, there is not any entitlement of step-

up and claim of step-up with junior is not tenable. Resultantly, the claim of the petitioner is not tenable and hereby rejected.

Ordered accordingly.

Order No. 13/49-2022 PGT-II (5)

Dated, Panchkula, the 19.01.2023

Whereas, Ravinder Kumar (Emp.ID 079921) PGT Physics has filed CWP No.17560 of 2022 titled as Vikramjeet & Others V/s State of Haryana and others, for quashing the action of the respondents in effecting the transfer through online mode in mid session in total contravention of the Teacher Transfer Policy dated 09.06.2016 (P-1) and amended policy dated 05.06.2017 (P-2), writ of certiorari quashing the action of the respondents in keeping various posts blocked so as to exclude those posts from the Transfer Drive. Further, petitioner prayed for quashing the action of the respondents in not providing the option of YES or No to the petitioner in the Transfer Drive, 2022 as per cutoff date has been mandated by the Teacher Transfer Policy and petitioner prayed to issue writ of mandamus directing the respondents to rectify MIS profile of the petitioners including zones and to upload marks in question in accordance with the transfer policy.

The aforesaid writ petition came up for hearing before Hon'ble Punjab & Haryana High Court on 23.08.2022 and on that day Hon'ble Court was pleased to dispose of the same with directions to respondents. The operative part of the order dated 23.08.2022 is as under:-

Notice of the application to the counsel opposite.

Mr. Harish Nain, learned Assistant Advocate General, Haryana, who is present in Court, accepts notice on behalf of respondent-State and raises no objection for the grant of prayer as raised in the present application.

Keeping in view the above, application is allowed and the hearing of the main petition i.e. CWP No. 17560 of 2022 is preponed from 15.09.2022 to today.

Learned counsel for the petitioners submits that the petitioners have a grievance with regard to their compulsory participation in the transfer drive keeping in view the fact of each petitioner as stated

in the petition. Learned counsel submits that some of the petitioners have a grievance that as per the transfer policy they are entitled for the marks keeping in view the ailment being suffered either by them or their family members or on some other valid ground as permissible in the transfer policy.

Learned counsel for the petitioners further submits that five of the petitioners have a grievance that their zone has not been fixed properly, which is causing prejudice to them. Learned counsel for the petitioners submits that the petitioners have already raised the said grievance before the authorities concerned by filing representations and they will be satisfied, at this stage, in case a time bound direction is issued to decide the said plea of the petitioners.

Learned State counsel submits that though a reply has already been filed but he has instructions to submit that the representations filed by the petitioners Annexures P-8 to P-11 will be decided within a period of seven days from today and the transfer, if issued in the meanwhile, will only be implemented after the passing of the order on their representations.

Learned counsel for the petitioners submits that keeping in view the statement of learned State counsel; the present petition may kindly be disposed of having been not pressed any further.

Whereas, the Government of Haryana has framed **Teachers Transfer Policy, 2016** dated 29.06.2016 and the same was amended on 01.06.2017. Thereupon, transfers were made under this amended policy of 2017 to ensure equitable, demand based distribution of teachers/Heads to protect academic interests of students and optimize job satisfaction amongst its employees in a fair and transparent manner. Under this policy all government schools have been categorized into seven zones for the purpose of transfer of teachers and the teacher is eligible to opt any number of schools across the zones available to him in the State. She/He is free to give preferences in order of their suitability. For the purpose of Transfer Drive, the

teachers who have already completed a period of 1 year service in a particular zone may seek transfer to some other station, on the other hand following categories of teachers have been asked to participate in the transfer drive compulsorily:

- a. A post of any cadre held by a teacher previously or presently in the school education department in a regular capacity for a period of 5 years or more on the qualifying date in the present zone of posting, shall be taken as a deemed vacancy and such teacher shall participate compulsorily in the transfer drive.
- b. Teachers declared surplus from a station as a part of rationalization/Normalization shall also participate compulsorily in the transfer drive.
- c. Teachers who have been given temporary manual posting previously due to non-availability of online transfer drive or technical problem or compulsion

Whereas, in compliance of the Hon'ble High Court Order dated 23.08.2022, the representation of the petitioner Ravinder Kumar (Emp.ID 79921) PGT Physics dated 14.06.2021 has been examined by the department in view of the provisions of the teacher transfer policy and it has been found that Sh. Ravinder Kumar, PGT Physics, GSSS Karawari was temporarily adjusted at GSSS Mahra (Zone-7). The adjustment of the petitioner has been done by District Education Officer, Sonipat at his own level without seeking any approval from the competent authority and his adjustment has been not updated by DEO, Sonipat in his MIS Profile. However, the adjustment of the petitioner had done by violating of the provisions of Teacher Transfer Policy.

Furthermore, with regard to the second contention regarding change of zone of GSSS Karewari (3501) zone-2, it is stated that zone of school was changed on 23.06.2017, whereas he was posted in this school i.e. G.S.S.S Karewari on 06.08.2016 and the benefit under the revised zoning will be available prospectively, hence he is not eligible for benefit of revised zone. As per General Transfer Drive data, he has included in Transfer drive due to completion of 5

years in his present zone and he had filled 62 preferences in 1st round and got 40th choice out of his preferences filled by him. As per policy, he has been transferred to Government Senior Secondary School, Ujha (2125), Panipat in Zone-2 with 40.6767 points.

In view of the submissions made above, the grievance of the petitioner in the representation dated 14.06.2021 i.e. Annexure P-8 is not tenable and the transfer of petitioner is done as per the provisions of the transfer policy and as per reasons cited supra. Therefore, he is directed to join the allocated station.

Whereas, the petitioner namely Smt. Sudesh, PGT (History) approached to Hon'ble Punjab & Haryana High Court by way of filing CWP No. 28209 of 2019 titled as **Sudesh versus State of Haryana & others** praying therein for issuance of writ in the nature of certiorari for quashing the order dated 02.08.2019 whereby the petitioner is not being allowed to proceed on Child Care Leave for 224 days and has been granted only for 32 days. After considering the allegations in the writ petition, the Hon'ble High Court vide its order dated 18.07.2022 has observed and issued the directions to respondents as under:-

"Learned counsel for the petitioner submits that the petitioner had applied for the grant of child care leave for a period of 224 days and by an interim order dated 05.07.2019 passed by a Coordinate Bench of this

Court, the said benefit was granted but, the respondents have granted the petitioner benefit of child care leave for a period of three months only, which is not only contrary to the order passed by a Coordinate Bench of this Court but, is also illegal and arbitrary.

Learned counsel for the petitioner submits that the petitioner also intends to avail the remaining child care leave and respondents may kindly be directed to consider her claim.

Learned State counsel submits that in case the petitioner intends to avail the remaining child care leave available in her credit, let the petitioner apply for the

same and an appropriate order on the request of the petitioner will be passed by the respondents in accordance with law within a period of two weeks from the date of receipt of the said request of the petitioner.

Learned counsel for the petitioner submits that keeping in view the above, the present petition may kindly be disposed of having been not pressed any further with liberty as prayed for.

Writ petition stands disposed of.”

In pursuance of the above said order, the petitioner submitted her representation dated 28.07.2022. In compliance of the Hon'ble High Court order, the representation of the petitioner minutely examined as per provision of HCS (Leave) Rules, 2016 and found that earlier Child Care Leave was granted to the petitioner vide order No. 13/154-2019 PGT-II(5) dated 23.12.2019 from period 02.12.2019 to 29.02.2020 (3 months) as per the Finance Department instructions dated 05.02.2010 and 05.11.2012. But she availed child care leave from the period i.e. 27.12.2019 to 29.02.2020. As per service record of the petitioner, it has been found that the age of her daughter is above 20 years. There is no provision in the Haryana Civil Service (Leave) Rules, 2016 for granting Child Care Leave for children above the age of 20 years. Hence, it has been decided not to grant Child Care Leave for remaining days because of the case of the petitioner is not covered under rule 46(1) of HCS (Leave) Rules, 2016. As per the Haryana Civil Services (Leave) Rules, 2016 in Rule 46(2) it has been mentioned that “Child care leave shall not be demanded as a matter of right and no one can, under any circumstances, proceed on child care leave without prior proper sanction of the leave by the competent authority”.

Further, keeping in view the position explained above, the representation of the petitioner devoid of merits. Accordingly, the relief

claimed therein also deserves to be declined. Hence, the demand of the petitioner is hereby rejected.

I, order accordingly.


