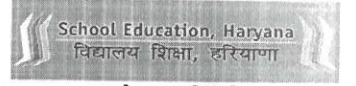

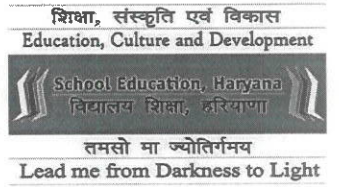

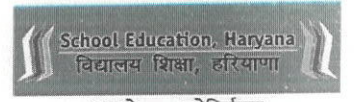

ORDER No. 13/118-2022 HRME-I (3) Dated, Panchkula, the 19/11/2023

Whereas the petitioner had filed the CWP No. 17905 of 2022 titled as Kuldeep Singh Vs State of Haryana & another, before the Hon'ble Punjab & Haryana High Court, praying therein for issuance of a writ in the nature of certiorari for quashing the impugned pay fixation vide which the pay and the pay scale of the petitioner was reduced by withdrawing the benefit of ACP Scheme granted in lieu of promotion vide order dated 03.03.2022 (Annexure P-5). The petitioner further prayed for direction to the respondents to continue to grant benefit of ACP Scale along with consequential benefits since the petitioner fulfilled the condition for grant of ACP in terms of Haryana Civil Services (ACP) Rules, 2016 and extended benefit of the law laid down in CWP No. 9755 of 2009 and CWP No. 8047 of 2010.

The above said Civil Writ Petition came up for the adjudication before the Hon'ble Court on 17.08.2022 and the same was disposed of by the Hon'ble High Court. The operative part of the aforesaid orders is reproduced here as under:-

"According to the petitioner, he had submitted a representation dated 14.7.2022 (Annexure P-6) addressed to Director of School Education, Panchkula but that has not evoked any response, as such he had to approached this Court by way of filing the present writ petition.

Learned State counsel appearing for respondents No. 1 and 2 states that though a detailed order in that regard has already been passed which is being impugned in this writ petition nonetheless the respondents would consider the representation of the petitioner in accordance with law and dispose it of.

Therefore, the writ petition is finally disposed of directing the respondents to consider the representation dated 14.7.2022 (Annexure P-6) of the petitioner in accordance with law, rules,

regulations and instructions on the subject within a period of two months from the date of receipt of copy of the order and if some action in the matter is warranted then the needful be done in accordance with law. A speaking order in that regard be passed, which be conveyed to the petitioner. If the petitioner feels dissatisfied after passing of the order then she may seek legal remedy in accordance with law."

In compliance of the above mentioned orders of the Hon'ble High Court, the representation dated 14.07.2022 (Annexure P-6) along with the official record of the petitioner was examined and found that the petitioner was appointed as a clerk in the Education Department on 07.03.1992 in the pay scale of 950-1150- (U.R.). He was allowed 1st ACP w.e.f. 01.04.2002 on completion of 10 year, followed by 2nd ACP w.e.f. 01.04.2012 on completion of 20 years and thereafter ACPL-7 w.e.f. 01.04.2016 on completion of 24 years of regular satisfactory service. After that the petitioner was promoted to the post of Assistant vide order No. 2/2-2016 HRME-I (4) dated 27.10.2021. But the petitioner made a request to the Department to forego his promotion, accordingly he was accorded permission to forego his promotion to the post of Assistant vide order No. 2/2-2016 HRME-I (4) dated 03.03.2022. Resultantly Rule 14 of Haryana Civil Services (ACP) Rules, 2016 is applicable to the petitioner, which is as follows:-

14. Ceasing of entitlement of ACP Level.-

(1) A Government employee who foregoes his promotion in the line of hierarchy or seeks reversion on his own accord to feeder post on any ground whatsoever, while drawing pay in:-

(a) 3rd ACP Level, the pay shall be re-fixed in 2nd ACP Level;

(b) 2nd ACP Level, the pay shall be re-fixed in the 1st ACP Level;

(c) 1st ACP Level, the pay shall be re-fixed in the Functional pay structure,

Equal to the presumptive pay which shall have been admissible had he not been granted 3rd/2nd/1st ACP Level, as the case may be.

(2) If such Government employee becomes ready to accept promotion, in such case the period of service between the date of foregoing promotion/reversion and date of application indicating readlines to accept the promotion, subject to minimum one year, shall be excluded from the regular satisfactory service for the purpose of grant of ACP Level. On assuming the charge of promotional post the pay shall be re-fixed equal to the pay drawn in ACP Pay Structure immediately before foregoing promotion or fixation of pay of the promotional post under normal rules, whichever is higher:

Provided that the request for seeking reversion or foregoing promotion once accepted by the competent authority shall not be withdrawn. Once a Government employee has foregone his promotion or sought reversion to a feeder post, such foregoing/reversion shall remain in force for a minimum period of one year or upto the period he gives in writing to re-consider his name for promotion, whichever is later."

Whereas the objective of the ACP Scheme is to remove the stagnation in the absence of promotion for certain years of service of an employee, who is otherwise fit to be promoted to a higher post in the regular hierarchy that means he/she is ready to shoulder the responsibility of a higher post but could not be promoted on account of non-availability of promotional avenues for the time being, that's why an employee is no longer entitled to enjoy the benefit of ACP Pay Scale, if he/she foregoes/declines a promotion offered to him/her in regular hierarchy. Therefore, as per the instructions issued vide U.O. No. 6/59/2016 PR (FD) dated 10/10/2017 of the Finance Department of Govt. of Haryana Rule-14 of HCS (ACP) Rules, 2008, is applicable to the petitioner which is as under:-

14. Ceasing of entitlement of ACP Pay Structure:-

In case the Government servant chooses to forego any functional promotion on any ground whatsoever, while drawing his pay in any ACP pay structure with reference to him, he shall cease to be entitled to draw his pay in the pay band and grade pay he was drawing before the grant of the last ACP grade pay from the date of such forgoing of promotion.

Keeping in view of the position explained above, it is crystal clear that as the request of the petitioner to forego his promotion as Assistant, due to his compelling medical and domestic circumstances, was accepted by the department vide order No. 2/2-2016 HRME-1 (4) dated 03.03.2022 with the condition that the petitioner will not be considered for further promotion at least for one year and the benefit of ACP if any, granted in lieu of promotion will be withdrawn; so the pay of the petitioner has been rightly re-fixed and 3rd ACP has been rightly withdrawn as per Haryana Civil Services (ACP) Rules, 2016.

In view of the fixation explained above, the claim of the petitioner demanded through the representation dated 14.07.2022 is hereby rejected, being devoid of merits in the interest of justice.

I, therefore pass an order, accordingly.
