Whereas, Sh. Dr. Shiv Kumar Gupta & others filed present Civil Writ Petition No. 23512 of 2022 titled as Dr. Shiv Kumar Gupta & others vs. State of Haryana & others before the Hon'ble Punjab and Haryana High Court praying therein for quashing the impugned seniority list of PGTs (rest of Haryana cadre), forming part of letter dated 17.03.2022 issued by Respondent No. 3, on the basis of which the Head Masters and Post Graduate Teachers are to be promoted to the post of Principal (rest of Haryana cadre) as the said seniority list has been prepared while overlooking the earlier seniority list dated 08.07.2019 prepared by Respondent No. 2 and also direct the Respondent No. 3 to correct the seniority list of PGTs (rest of Haryana cadre) forming part of letter dated 17.03.2022 issued by Respondent No. 3 as has been clearly brought out in the representation dated 31.03.2022 and legal notice dated 03.05.2022. Further, consider and pass speaking order on the representation dated 31.03.2022 and legal notice dated 03.05.2022 served upon them in a time bound manner.

The Hon'ble Punjab and Haryana High Court disposed of said petition on dated 14.10.2022 with the following orders:-

".....Without commenting upon the merits of the case or about the entitlement of the petitioners for the relief, which has been claimed by them in the legal notice dated 03.05.2022 (Annexure P-4) the present writ petition is disposed off with a direction to respondent No.3 to decide the legal notice dated 03.05.2022 (Annexure P-4) within a period of eight weeks from the receipt of copy of this order."

Whereas, in compliance of said order, the legal notice dated 03.05.2022 of Sh. Dr. Shiv Kumar Gupta & others, has been examined and it is found that the incumbents were initially appointed as PGTs vide dated 17.05.1999. The seniority list of various subjects was prepared as per the merit list by the Haryana School Teacher Selection Board (now Haryana Staff Selection Commission). Also, the seniority list dated 08.07.2019 was prepared and finalized as per the Haryana State Education School Cadre (Group- B) Service Rules, 2012. It is well settled law that a person is entitled to claim the seniority from the date he/she is appointed to the post. In the present case, Sh. Dr. Shiv Kumar Gupta & others were appointed in 1999 and the seniority of Sh. Dr. Shiv Kumar Gupta & others has already been fixed at appropriate number by the department as per seniority list of July, 2019 prepared strictly according to the Haryana State Education School Cadre (Group- B) Service Rules, 2012/instructions.

Whereas, seniority of the eligible employees who were appointed as PGT similar with Sh. Dr. Shiv Kumar Gupta & others of whom the incumbents gave examples has been re-fixed at appropriate number by the department vide order No. 13/82-2022 PGT-I (4) dated 21.12.2022.

Keeping in view the facts enunciated above and documents on record, it is observed that seniority of the similar situated employees of whom the incumbents gave example has already been rectified by the department as per the existing rules

and w.e.f. the date of their actual appointments. Hence, the incumbents cannot be entitled for the re-fixation of their seniority number as prayed in the legal notice dated 03.05.2022 submitted by them.

Therefore, the claim of Sh. Dr. Shiv Kumar Gupta & others in their legal notice dated 03.05.2022 regarding necessary corrections in the seniority list of Post Graduate Teachers is not tenable at this stage & hereby rejected being devoid of merits.

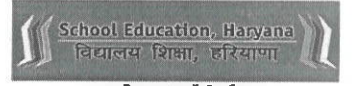

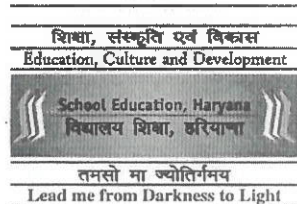

Whereas, Sh. Dr. Shiv Kumar Gupta & others filed present Civil Writ Petition No. 23512 of 2022 titled as Dr. Shiv Kumar Gupta & others vs. State of Haryana & others before the Hon'ble Punjab and Haryana High Court praying therein for quashing the impugned seniority list of PGTs (rest of Haryana cadre), forming part of letter dated 17.03.2022 issued by Respondent No. 3, on the basis of which the Head Masters and Post Graduate Teachers are to be promoted to the post of Principal (rest of Haryana cadre) as the said seniority list has been prepared while overlooking the earlier seniority list dated 08.07.2019 prepared by Respondent No. 2 and also direct the Respondent No. 3 to correct the seniority list of PGTs (rest of Haryana cadre) forming part of letter dated 17.03.2022 issued by Respondent No. 3 as has been clearly brought out in the representation dated 31.03.2022 and legal notice dated 03.05.2022. Further, consider and pass speaking order on the representation dated 31.03.2022 and legal notice dated 03.05.2022 served upon them in a time bound manner.

The Hon'ble Punjab and Haryana High Court disposed of said petition on dated 14.10.2022 with the following orders:-

".....Without commenting upon the merits of the case or about the entitlement of the petitioners for the relief, which has been claimed by them in the legal notice dated 03.05.2022 (Annexure P-4) the present writ petition is disposed off with a direction to respondent No.3 to decide the legal notice dated 03.05.2022 (Annexure P-4) within a period of eight weeks from the receipt of copy of this order."

Whereas, in compliance of said order, the legal notice dated 03.05.2022 of Sh. Dr. Shiv Kumar Gupta & others, has been examined and it is found that the incumbents were initially appointed as PGTs vide dated 17.05.1999. The seniority list of various subjects was prepared as per the merit list by the Haryana School Teacher Selection Board (now Haryana Staff Selection Commission). Also, the seniority list dated 08.07.2019 was prepared and finalized as per the Haryana State Education School Cadre (Group- B) Service Rules, 2012. It is well settled law that a person is entitled to claim the seniority from the date he/she is appointed to the post. In the present case, Sh. Dr. Shiv Kumar Gupta & others were appointed in 1999 and the seniority of Sh. Dr. Shiv Kumar Gupta & others has already been fixed at appropriate number by the department as per seniority list of July, 2019 prepared strictly according to the Haryana State Education School Cadre (Group- B) Service Rules, 2012/instructions.

Whereas, seniority of the eligible employees who were appointed as PGT similar with Sh. Dr. Shiv Kumar Gupta & others of whom the incumbents gave examples has been re-fixed at appropriate number by the department vide order No. 13/82-2022 PGT-I (4) dated 21.12.2022.

Keeping in view the facts enunciated above and documents on record, it is observed that seniority of the similar situated employees of whom the incumbents gave example has already been rectified by the department as per the existing rules

and w.e.f. the date of their actual appointments. Hence, the incumbents cannot be entitled for the re-fixation of their seniority number as prayed in the legal notice dated 03.05.2022 submitted by them.

Therefore, the claim of Sh. Dr. Shiv Kumar Gupta & others in their legal notice dated 03.05.2022 regarding necessary corrections in the seniority list of Post Graduate Teachers is not tenable at this stage & hereby rejected being devoid of merits.


