Subject: - The criteria of re-employment after superannuation of Government Employees-Clarification thereof.

Sir/Madam,

I am directed to refer to Rule-143 of Haryana Civil Services (General) Rules, 2016 and State Government Instructions No. 34/01/2004-4GSI, dated 20.06.2018 & 06.08.2018 on the subject and to say that the re-employment can only be given in exceptional circumstances after 58 years for a period of maximum two years to a government employee beyond the age of superannuation.


2. However, many departments are sending the proposals of re-employment beyond 2 years to Human Resources Department.

3. The State Government has taken a serious view in this regard and decided that in future no case of re-employment in service beyond two years be considered.

4. However, in such cases, if there is requirement of service of any retired employee beyond two years, only contractual engagement may be considered as per policy/guidelines, with the prior approval of Human Resources Department (in Human Resources-III Branch).

5. These instructions may be brought to the notice of all concerned.


