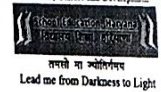

Subject: Extension/ provisional affiliation of one year to Private Schools for the academic session 2022-2023.

In continuation of this office memo No. 8/134-2019PS(1) dated 25.01.2023 on the subject cited above.

Vide above referred letter dated 25.01.2023, the Government has decided to granted provisional affiliation for another academic session i.e. 2022-23 only to such schools which were established before 30.04.2003, only if, the school concerned give affidavit that they will not take admission after the academic year 2022-23 for those classes, which the school is not permanently recognized till the permanent recognition for these classes is obtained from the Directorate through proper channel.

Now, the Government has re-considered the matter and after due deliberation has decided to grant provisional affiliation for another academic session i.e. 2022-23 to such schools which were established before 01.04.2007 and to whom the benefit of provisional recognition/affiliation was granted in the previous academic session 2021-22, only if, the school concerned give affidavit that they will not take admission after the academic year 2022-23 for those classes, which the school is not permanently recognized till the permanent recognition for these classes is obtained from the Directorate through proper channel. Draft affidavit is annexed as **Annexure-A**.

Therefore, you are hereby directed to inform all the concerned to submit their affidavits till 30.01.2023 in the office of concerned DEOs and the concerned District Education Officer prepare a consolidated list in Excel Sheet in the following format:

After preparing consolidated list, the concerned District Education Officer sent a soft copy of list with all the affidavits to this Directorate upto 01.02.2023 through e_mail i.e. **dseps13@gmail.com**, so that, the list of schools be forwarded to the Board of School Education Haryana for extension of temporary affiliation for the academic year 2022-23. The hard copy of list with all the affidavit may also be forwarded to the Directorate as early as possible.
