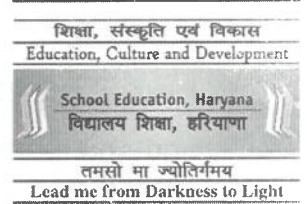

**Terms & Conditions:**

1. If any, disciplinary proceeding under Rule 7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 is found pending subsequently, the said incumbent(s) shall be reverted without issuing any notice.
2. If the currency of penalty of stoppage of grade increments with or without cumulative effect is still in operation, the candidate shall be reverted in view of the CS office instructions dated 31.05.2006, without issuing any notice.
3. The promotes will remain on probation for one year as per rule 27 of Haryana Civil Services (General) Rules, 2016
4. The promotion has been given on the basis of availability of 70 percent or more records falling in the category of good or better than that and in the eventuality of finding the integrity doubtful during the said period as well as remaining records, the incumbent(s) shall be reverted without issuing any notice.

5. If subsequently, it is found that any candidate has done Post Graduation or other qualifications in distance mode from deemed Universities from study centers located outside the campuses of the University, without seeking approval of UGC and the State Government, then such candidate shall be reverted in view of Division Bench judgment of Punjab and Haryana High Court in CWP no. 1640 of 2008 decided on 06.11.2012 titled as Kartar Singh Versus Union of India and others cited in 2013(1) RSJ 224.
6. If any discrepancy regarding not fulfilling the essential qualifications as prescribed in the 'Mewat District School Education (Group B) Service Rules, 2012', the said incumbent(s) shall be reverted without issuing any notice.
7. In the case of candidates whose inter se seniority as PGT/ Lecturer is not available in the database, then such candidates will be suitably placed by determining their inter se seniority as PGT/ Lecturer and will be assigned subsequent seniority in the corresponding Principal seniority list accordingly.
8. In case the promote(s) officer found ineligible for the feeder post or unsuitable for appointment as PGT on account of any reason e.g. B.ed/HTET etc., such officer shall stand reverted without any notice.
9. If subsequently any senior person becomes eligible for promotion due to availability of ACRs or other records, then in that eventuality, he/she shall be treated as senior to any promoted junior candidate, even if promoted later.
10. Needless to say, the present promotion is subject to the outcome of any court case pending in any court of law which might have any bearing on the present order.
11. That After joining at the station allotted herein they shall proceed on a School Leadership training to be imparted through *Teacher Education Institutions* controlled by the SCERT, Haryana. The detail programme in this respect shall be communicated to them by the SCERT, Haryana.
