- If there is no vacancy in the destination school for any reason the incumbent transferred shall re-join his/her previous place of posting and also inform to concerned branch/computer cell at HQ.  
If any discrepancy is noticed in this order or there is a violation of transfer policy, It should be brought to the notice of Computer Cell/Concerned branch within three days and the order be not implemented.
- Consent/affidavit of the official be taken that he is willing to loose his/her seniority in case of requested transfer orders.
- The condition that official has not been joined previous transfer place of posting is not implemented on Cancellation Order.
- The official will be update their profile in MIS Portal when he/she join/relieve from his present working station and also supply the information to the Directorate.
- Concerned DDO is also requested to update and approved MIS data of the official at your own level.

**ORDER**

**No: 13/40-2022 HRME-II(2)**

**Dated:- 19-01-23**

Whereas the petitioners had filed the CWP No. 10952 of 2022 in Hon'ble High Court of Punjab & Haryana titled as Bala Devi & others V/s State of Haryana & others praying therein for the issuance of a Writ in the nature of Mandamus directing the respondents to consider the period of part-time service rendered by the petitioners prior to the regularization for the purpose of pension, gratuity, arrear and other retiral benefits.

The above said Writ Petition was listed for hearing on 20.05.2022 and on that day, the Hon'ble High Court disposed of the same. The operative part of the order is reproduced as under:-

**“In view the request made, without expressing any opinion on the merits of the case or the claim being made by the petitioners in their legal notice, respondent no. 4 is directed to decide the legal notice dated 26.03.2022 (Annexure P/5) by passing a speaking order within a period of 08 weeks from receipt of copy of this order”**

In compliance of the Hon'ble High Court order dated 20.05.2022, while deciding the legal notice dated 26.03.2022 (Annexure P-5) served by the petitioners, the facts of the case were examined and it was found that the petitioner Nos. 1 and 2 were engaged as part-time Sweeper on 21.05.1986, 25.12.2002 whereas the petitioners no. 3 and 4 are the legal heirs of Late Sh. Bhira Singh and Smt. Mukesh Rani who were engaged on 01.08.1996 and 26.08.2002 respectively in GPS Pasina Kalan, GPS Namunda, GPS Diwana and GGMS Chajpur Khurd in district Panipat against unsanctioned post respectively only for 1.30 to 2.00 hours per day. After that, they were free to do job anywhere whereas it is pertinent to mention here that the seniority of part time class IV employees was at institutional level as per the regularization policy dated 30.12.1998/25.02.1999 and according to this policy on those part class IV were entitled for regularization of their services against vacant regular sanctioned post who had requisite experience mentioned in the policy in the institutions where sanctioned posts of Class-IV were available. But the petitioners could not be regularized as per the policy dated 30.12.1998/25.02.1999 because they did not fulfill the conditions of the said policy. Therefore, the policy dated 30.12.1998/25.02.1999 was superseded by the new departmental regularization policy dated 11.11.2003 which was framed by the education department in compliance of the directions of the

Hon'ble High Court order issued vide order dated 20.02.2002 passed in C.W.P. No. 5926/2001 titled as Vidya Devi & others V/s State of Haryana & others. Thus, as per the policy dated 11.11.2003, the seniority list was prepared at District level & accordingly the petitioner Nos. 1 and 2 stands at seniority no. 11, 204 and spouses of petitioner no. 3 (Sh. Bhira Singh) & 4 (Smt. Mukesh Rani) stood at seniority no. 65-A and 151. The Petitioner Nos. 1 & 2 were regularized w.e.f. 01.04.2011 and husband of petitioner no.3 and wife of petitioner no. 4 were regularized w.e.f. 01.04.2011 as per their seniority as well as their eligibility. Thereafter, Petitioner Nos. 1 & 2 were retired on 31.03.2020, 31.07.2021 respectively on attaining the age of superannuation whereas spouses of petitioner no. 3 & 4 was expired on 29.08.2012 and 22.03.2013.

As per the notification dated 18.08.2008 of Haryana Government Finance Department, Haryana New Pension Scheme Haryana, 2008 came into force applicable to all the Govt. Servants joining the service on or after 01.01.2006. The new pension scheme work on defined contributed basis and according to said notification it is specifically mentioned that general provident fund scheme is not applicable to those government servants who joined the Government Department on or after 1st January, 2006. The petitioners joined the service on regular basis w.e.f. 01.04.2011. Hence, the case of the petitioners is covered under new pension scheme, 2008.

Further, Rule 3.17A(g)(iii) of Punjab Civil Services Rules, Volume-II provides that the services rendered by an employee on part time basis can not be computed for retiral benefits, the same is reproduced as under:-

"The entire service rendered by an employee as work charge shall be reckoned towards retirement benefits provided:-

- (i) Such service is followed by regular employment.
- (ii) There is no interruption in the two or more spells of services or the interruption fall with -in condonable limits;
- (iii) And such service is a whole time employment and not part-time or portion of day.

Further, the petitioners cited the judgment dated 01.03.2019 passed by Hon'ble High Court of Punjab & Haryana in CWP No. 1048 of 2016 titled as Jai Bhagwan V/s State of Haryana & others wherein the petitioner was held entitled for the pensionary benefits under the old pension scheme. But the State of Haryana has challenged the judgement dated 01.03.2019 in LPA No. 1892 of 2019 titled as State of Haryana & others V/s Jai Bhagwan and the same is pending for adjudication by Hon'ble High Court. So, the recourse taken by the present petitioners is not tenable since the matter is still sub-judice before the

Hon'ble High Court of Punjab & Haryana. Moreover, Kesarchand's judgement is applicable to the employees of work-charge basis not to the employees of part time basis.

Therefore, in view of the above, the claim demanded through legal notice dated 26.03.2022 is not tenable and hence rejected.

I pass the orders accordingly.
