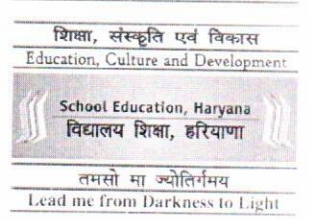

Terms & Conditions:

1. If any, disciplinary proceeding under Rule 7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 is found pending subsequently, the said incumbent(s) shall be reverted without issuing any notice.
2. **This promotion orders are subject to final outcome of Civil Writ Petition No. 19403 of 2019 titled as Baljit Singh and others V/s State of Haryana.**
3. The promote(s) will remain on probation for one year as per rule 27 of Haryana Civil Services (General) Rules, 2016.

4. If the currency of penalty of stoppage of grade increments with or without cumulative effect is still in operation, the candidate shall be reverted in view of the CS office instructions dated 31.05.2006, without issuing any notice.
5. The promotion has been given on the basis of availability of 70 percent or more records falling in the category of good or better than that and in the eventuality of finding the integrity doubtful during the said period as well as remaining records, the incumbent(s) shall be reverted without issuing any notice.
6. If subsequently, it is found that any candidate has done Post Graduation or other qualifications in distance mode from deemed Universities from study centers located outside the campuses of the University, without seeking approval of UGC and the State Government, then such candidate shall be reverted in view of Division Bench judgment of Punjab and Haryana High Court in CWP no. 1640 of 2008 decided on 06.11.2012 titled as Kartar Singh Versus Union of India and others cited in 2013(1) RSJ 224.
7. If any discrepancy regarding not fulfilling the essential qualifications as prescribed in the 'Haryana State Education School Cadre (Group B) Service Rules, 2012 amended in 2014, the said incumbent(s) shall be reverted without issuing any notice.
8. In case the promote(s) officer found ineligible for the feeder post or unsuitable for appointment/promotion as Post Graduate Teacher/Headmaster on account of any reason, such officer shall stand reverted without any notice.
9. In the case of candidates whose inter se seniority as PGT/ Headmaster is not available in the database, then such candidates will be suitably placed by determining their inter se seniority as PGT/ Headmaster and will be assigned subsequent seniority in the corresponding Principal seniority list accordingly.
10. If subsequently any senior person becomes eligible for promotion due to availability of ACRs/APARs or other records, then in that eventuality, he/she shall be treated as senior to any promoted junior candidate, even if promoted later.
11. After joining at the station allotted herein he/she shall proceed on a School Leadership training to be imparted through Teacher Education Institutions controlled by the SCERT, Haryana. The detail programme in this respect shall be communicated to her by the SCERT, Haryana.
12. These newly promote officers shall have to seek permanent posting through MIS portal by participating in Transfer Drive. This is purely initial temporary posting for stop gap arrangement till the next teacher transfer drive and all these officers will have to participate in the Teachers' Transfer Drive for obtaining permanent posting as per their entitlement.
13. The officer(s) will be relieved immediately and join at their new place of posting as per Rule 77 of HCS (General) Rules, 2016 falling which he/she will be liable for disciplinary action
14. Needless to say, the present promotion is subject to the outcome of any court case pending in any court of law which might have any bearing on the present order.

15. The District Education Officer(s) concerned shall ensure compliance of above conditions before letting the promoted Principal to join.

ORDER

Order No. 13/81-2018 PGT-II (5) **Dated, Chandigarh, the 03.02.2023**

Whereas, Uma Devi and other 50 petitioners approached the Hon'ble High Court by way of filing CWP No. 9137 of 2013 titled as Uma Devi and others vs. State of Haryana and others praying therein to direct the respondents to count of services rendered by them in privately managed Government Aided Schools towards the pension/pensionary benefits in view of the law laid down in CWP No. 6568 of 2008, Shyam Kumar vs. State of Haryana and others, decided on 24.07.2009.

That the writ petition came up for hearing before this Hon'ble Court on 24.07.2015 and the Hon'ble Court disposed of the same. The operative part of the order dated 24.07.2015 is as under:-

"There is no denial to the fact that the aforementioned order has also been implemented, which is evident from the perusal of order dated 31.10.2012 passed in COCP No.1592 of 2011 (Shyam Kumar Sharma Versus Surina Rajan, IAS and others), which reads thus:- Learned State counsel on instructions from Sh.Harminder Singh, Distt.Elementary Education Officer, Yamunanagar contends that the necessary benefits on account of ACP grade and other benefits shall be given to the petitioner positively within a period of two weeks from today. In view of the categoric stand taken by the respondents, instant petition is disposed of and rule against the respondents is discharged. However, in the eventuality of the respondents not releasing the necessary benefits to the petitioner within the stipulated period, the petitioner shall be at liberty to revive the instant petition."

Thus, there leaves no manner of doubt in the mind of the Court to grant the relief of ACP, pension and pensionary benefits to the petitioners by treating

That in compliance of the Hon'ble High Court Order 24.07.2015, the case of the petitioners has been examined as per service record by the department in the light of the rules and instructions. It has been found that the petitioners are as under:-

In this regard, the employees mentioned at serial no. 3 & 4 are not eligible. The relevant statutory provisions of Rule 4.19 & 4.23 of Punjab Civil Services, Volume-II are reproduced as under:-

B - RESIGNATIONS AND DISMISSALS 4.19 (a) Resignation from public service, dismissal or removal from it, either under proviso (c) to Article 311(2) of the Constitution for over anti-national activities such as sabotage, espionage etc. or for misconduct, insolvency, inefficiency not

due to age or failure to pass a prescribed examination, entails forfeiture of past service and no pension shall be granted in the aforementioned circumstances. Provided that in the case of those Government employees whose removal or dismissal results from participation in other objectionable activities affecting or endangering the security of the State, such proportionate pension may be granted as may be recommended by the Committee of the Advisors constituted under the Haryana Civil Services (Safe-guarding of National Security) Rules, 1971.

(b) Resignation of an appointment to take up, with proper permission, another appointment, whether permanent or temporary, service in which counts in full or in part, is not a resignation of public service. In cases where an interruption in service is inevitable due to the two appointments being at different stations, such interruptions, not exceeding the joining time permissible under the rules on transfer, shall be covered by grant of leave of any kind due to the Government employee on the date of relief or by formal condonation under Rule 4.23 to the extent to which the period is not covered by leave due to the Government employee. Note.— The previous service of a Government employee who is transferred to a temporary appointment is forfeited by his resigning the temporary appointment and taking up another temporary appointment of his own accord.

4.23 D - CONDONATION OF INTERRUPTIONS AND DEFICIENCIES 4.23

Interruption in service (either between two spells of permanent, or temporary service or between a spell of temporary service and permanent service or vice versa in the case of an officer retiring on or after the 5th January, 1961, may be condoned, subject to the following conditions, namely:- (1) The interruption should have been caused by reasons beyond the control of Government employee concerned.

2) Service preceding the interruption should not be less than five years' duration. In cases where there are two or more interruptions, the

total service, pensionary benefits in respect of which shall be lost if the interruptions are not condoned should not be less than five years.

(3) The interruption should not be of more than one year's duration.

In cases where there are two or more interruptions, the total period of all interruptions to be condoned should not exceed one year.

In view of the submissions made above, the claim of the petitioners at serial no. 1 & 2 is tenable and serial no. 3 & 4 are not tenable hence rejected.

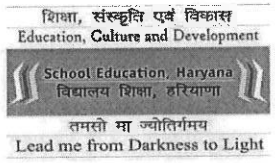
