Whereas the petitioner had filed the CWP No. 28394 of 2022 titled as Om Parkash Vs State of Haryana & others, before the Hon'ble Punjab & Haryana High Court, praying therein for issuance of an appropriate writ in the nature of Mandamus directing the respondents to allow the petitioner to join his duties to the post of Clerk in lieu of the provisions contained in Haryana Civil Services (General) Rules, 2016, alongwith all consequential benefits, including the continuity of service, seniority etc.

The above said Civil Writ Petition came up for the adjudication before the Hon'ble Court on 09.12.2022 and the same was disposed of by the Hon'ble High Court with the following orders:-

*"Learned counsel for the petitioner argues that the petitioner has been selected on the post of Clerk but he is not being allowed to join and that too without any valid justification. Learned counsel for the petitioner submits that once the petitioner has already been selected and the posts are available, there is no reason why the petitioner should be declined the benefit of joining the department.*

*Learned counsel for the petitioner submits that the petitioner has already raised the said grievance in the legal notice dated 06.04.2022 (Annexure P-15) but the same is still pending consideration with the respondents and the petitioner will be satisfied, at this stage, in case a direction is issued to respondent No. 2 to decide the same by passing an appropriate speaking order in a time bound manner.*

*Notice of motion.*

*On the asking of the Court, Mr. Harish Nain, learned Assistant Advocate General, Haryana, who is present in Court, accepts notice on behalf of the respondents and raises no objection in deciding the legal notice dated 06.04.2022 (Annexure P-15) in a time bound manner by passing an appropriate speaking order.*

*In view of the pleadings in the present petition, without expressing any opinion on the merits of the case or the claim being made by the petitioner in the demand notice, respondent No. 2 is directed to decide the legal notice dated 06.04.2022 (Annexure P-15), by passing a speaking order within a period of eight weeks from the receipt of copy of this order.*

***Present writ petition stands disposed of.***

In compliance of the above mentioned orders of the Hon'ble High Court, the legal notice dated 06.04.2022 of the petitioner has been examined by the Department and it has been found that the petitioner joined as a Peon in GHS Gulabad, Faridabad on 01.07.1991 and he was confirmed to the post of peon on 19.02.1994. After that he was promoted as Clerk on 04.06.2009.

Further, the petitioner had applied through proper channel for the post of Art and Craft Teacher as per advertisement No. 6/2006 dated 20.07.2006 issued by Haryana Staff Selection Commission, Panchkula and got selected to the post of Art and Craft Teacher joined in GSSS Hassanpur, Palwal on 05.05.2010. But his service had been dispensed in view of the order dated 20.02.2015 passed by the Hon'ble High Court in CWP No. 18482 of 2010 and the petitioner was relieved from GMS Narangabad Kanpur, Palwal (1060) on 11.02.2021. So, his services were not confirmed on his subsequent post.

Whereas Rule 30(b) of HCS (General) Rules, 2016 provides that a permanent Govt. Employee shall retain a lien on the regular post during the probation period on appointment to another post and the same is reproduced as under:-

Rule 30 Retention of Lien:

**"A permanent Government employee shall retain a lien on the regular post while:-**

**(a) performing duties of that post;**

**(b) during the probation period on appointment to another post."**

Thus, it is clear that petitioner joined as Art and Craft Teacher on 05.05.2010 and his services were terminated on 11.02.2021, so the probation period of two years as per the above mentioned Rules has already lapsed. Therefore, the petitioner's right to lien ceases to exist.

Further Rule 29 (2) of Haryana Civil Services (General) Rules, 2016 provides that on subsequent appointment of permanent Govt. employee to another post by direct recruitment or otherwise within the same or any other Department, he shall have to, at the time of eligibility for confirmation on that post, exercise an option either to opt his confirmation on the new post or to revert back to his post, within a period of three months from the date of issue of notice and in case of the petitioner such exercise has not taken place.

Therefore, keeping in view of the petition explained above, the claim of the petitioner demanded through legal notice dated 06.04.2022 is hereby rejected, being devoid of merits.

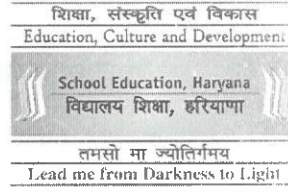
