

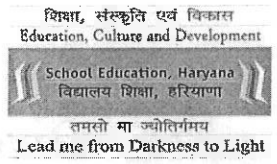

Whereas, appellant Smt. Kanta, the then Deputy Superintendent now Superintendent O/o District Education Officer, Rohtak was charge-sheeted under rule-8 of Haryana Civil Service (Punishment & Appeal) Rule, 2016 vide order no. 5/24-2021 HRME-I(3) dated 27.09.2021 with the allegation as mentioned below:-

“यह है कि आप द्वारा सिविल अपील न० 87 ऑफ 2017 सुरेश सिंह व अन्य बनाम स्टेट ऑफ़ हरियाणा व अन्य के मामले में कोर्ट केस की पैरवी सही ढंग से न करने के कारण माननीय कोर्ट रोहतक द्वारा दिनांक 16.11.2018 को अपीलकर्ता की स्वीकार कर ली गई, जिस कारण राज्य पर करोड़ों का वित्तीय बोझ पड़ा”

Thereafter, the appellant submitted her reply to the said charge-sheet on dated 14.10.2021 to the Director Secondary Education (appointing authority) and denied the allegations leveled against her. The appellant further prayed to drop the said charge-sheet against her. The reply submitted by the appellant was found un-satisfactory. Consequently the appellant was heard by competent authority on dated 11.02.2022. During the course of hearing, the appellant reiterated the facts similar as submitted by her in the reply to the said charge-sheet. After considering the version of the appellant officer and documents submitted by her, the competent authority (Director Secondary Education) passed final order, whereby punishment of stoppage of two annual increment without cumulative effect vide order no. 5/24-2021 HRME-I(3) dated 07.02.2022 was inflicted upon her. Operative part of the said order as under:-


“Therefore, after going through the official record of the delinquent, I am of the considered view that behavior of Smt. Kanta was indeed negligent, hence the penalty of stoppage of two annual increments without cumulative effect is hereby inflicted upon Smt. Kanta, Superintendent o/o District Education Officer, Rohtak”.

Whereas, aggrieved with the above said order of punishment, the appellant approached before the Government by filing the present appeal on dated 28.03.2022. The appeal filed by the appellant officer was taken on record and thereupon she was accorded with opportunity of personal hearing on dated 12.12.2022. During the course of hearing the appellant submitted that she was never remained as the nodal officer for the court cases pending in the District Education Office, Rohtak. One Sh. Suresh Kumar was assigned with duty to deal with litigation matters pertained to the District Education Office, Rohtak. She further submitted that she was only assigned with the duty of General

Branch (Administration) and not specifically directed to deal with the litigation matters till 10.05.2018. Lastly, she prayed for setting aside the order dated, 07.02.2022 passed by the Director Secondary Education by submitting that she always obliged with the directions issued by the higher authorities and did her duty with due diligence. Although if any administrative lapse seems too done on her part she tendered her apology and assured that she will remain more careful in future.

Keeping in view the above said facts & circumstances, contents of present appeal filed by the appellant and documents on record, it is observed that appellant cannot be made liable for the act or omission not done by her or of her involvement. Moreover, from the perusal of record, it is evident that the appellant got the charged of nodal officer (Court Cases) on dated 10.05.2018 and that time said court case already been attained finality. Hence, lose Caused to the state exchequer was not due to her sole default.

Therefore, considering the facts enunciated and taking a lenient view, the order dated 07.02.2022 passed by the Director Secondary Education is hereby modified and the same has been converted into punishment of 'Censure' against the appellant Smt. Kanta Devi, Superintendent O/o District Education Officer, Rohtak
