**TERMS & CONDITIONS:-**

1. Their appointment is against a purely temporary post which is liable to be abolished at anytime and carries no promise of subsequent permanent employment. No offer of permanent vacancy can be made to them at present. Their services can be terminated without any notice, whenever there is no vacancy against which they can be retained.
2. The candidate shall have to qualify the State Eligibility Test in Computer Appreciation and applications (SETC) within the probation period of two years, extendable by one year in case of direct recruitment. Whereas, Ravinder Singh Rana & others have filed the CWP No.22360 of 2022 in the Hon'ble High Court of Punjab & Haryana, Chandigarh and prayed for benefit of step-up of pay of the petitioners at par with their junior counterpart w.e.f. 01.01.2006 as notional and actual w.e.f. 01.06.2017 as per the pay fixation performa, as they are fully entitled for step-up of pay, with all consequential benefits and also make the payment of arrears with 12% interest per annum w.e.f. the due date till the date of actual payment.

The writ petition was came upon hearing on 27.09.2022 before the Hon'ble High Court and the same was disposed of vide order dated 27.09.2022. The operative part of the order is as under:-

***"Notice of motion.***

***Mr. Harish Nain, AAG, Haryana, who is present in Court, accepts notice on behalf of respondent-State and raises no objection in deciding the legal notice dated 11.06.2022 (Annexure P-9) in a time bound manner by passing an appropriate speaking order.***

***In view of the request made, without expressing any opinion on the merits of the case or the claim being made by the petitioners in their legal notice, respondent No.2 is directed to decide the legal notice dated 11.06.2022 (Annexure P-9) by passing a speaking order within a period of 08 weeks from the date of receipt of copy of this order.***

***Present writ petition stands disposed off.***

In compliance of the said directions, the legal notice dated 11.06.2022 has been examined and found that the petitioners namely Sh. Ravinder Singh Rana , Sh. Gurdiyal Singh, Sh. Pawan Kumar, Sh. Ramesh Kumar , Sh. Mukesh Kumar, Sh.Raj Kumar, Sh. Ram Karan, Sh. Rajbir Singh were appointed as Lecturers in different subjects and joined during



October, 1991 to January, 1992 and promoted as Principal vide order dated 24.04.2012.

It is found that Sh. Rajneesh Kumar, Principal whose example was given by the petitioners, was wrongly granted the benefit of Selection Grade w.e.f. 01.01.1996. Thereafter, the pay of Sh. Rajneesh Kumar, Principal has been re-fixed at Rs. 1,05,600/- as on 01.07.2021 after reviewing into the matter by the Office of District Education Officer, Fatehabad vide order dated 26.07.2021.

That the pay of the petitioner i.e. Sh. Ravinder Singh Rana is fixed as on 01.07.2021 at Rs. 1,08,800/-, whereas, the pay of Sh. Rajneesh Kumar is Rs. 1,05,600/-. Therefore, the pay of the petitioner is more than the pay of Sh. Rajneesh Kumar.

That the pay of Sh. Gurdiyal Singh is fixed at Rs. 1,08,800/- as on 01.07.2021, whereas, the pay of Sh. Rajneesh Kumar is Rs. 1,05,600/- as on 01.07.2021. Therefore, the pay of the petitioner is more than the pay of Sh. Rajneesh Kumar.

That the pay of Sh. Pawan Kumar is fixed at Rs. 1,02,800/- as on 01.07.2019 as he was retired on 31.08.2019, whereas, the pay of Sh. Rajneesh Kumar was Rs. 99,500/- as on 01.07.2019. Therefore, the pay of the petitioner was more than the pay of Sh. Rajneesh Kumar.

That the pay of Sh. Ramesh Kumar is fixed at Rs. 1,02,500/- as on 01.07.2021 and the petitioner has not applied for 2<sup>nd</sup> ACP. Therefore, his pay is less than his junior.

That the pay of Sh. Mukesh Kumar is fixed at Rs. 1,05,600/- as on 01.07.2021. Whereas, the pay of Sh. Rajneesh Kumar is Rs. 1,05,600/- as on 01.07.2021. Therefore, the pay of the petitioner is equal to the pay of Sh. Rajneesh Kumar.

That the pay of Sh. Raj Kumar is fixed at Rs. 1,08,800/- as on 01.07.2021; Whereas, the pay of Sh. Rajneesh Kumar is Rs. 1,05,600/- as on 01.07.2021. Therefore, the pay of the petitioner is more than the pay of Sh. Rajneesh Kumar.

That the pay of Sh. Ram Karan is fixed at Rs. 1,13,700/- as on 01.07.2022, Whereas, the pay of Sh. Rajneesh Kumar is Rs. 1,08,800/- as on 01.07.2022. Therefore, the pay of the petitioner is more than the pay of Sh. Rajneesh Kumar.

That the pay of Sh. Rajbir Singh is fixed at Rs.1, 13,700/- as on 01.07.2021. Whereas, the pay of Sh. Rajneesh Kumar is Rs. 1, 05,600/- as on 01.07.2021. Therefore, the pay of the petitioner is more than the pay of Sh. Rajneesh Kumar.

That the pay of the petitioners is more than junior or equal to the pay of their junior, Sh. Rajneesh Kumar. Hence, the claim of the petitioners is not tenable and hereby rejected.

I Ordered accordingly.

ORDER

NO. 16/201-2015 PGT-III (9)

Dated, Chandigarh the 3/2/23

Whereas, an FIR No. 386 against Sh. Sahib Ram, PGT English posted at BITE Jakhandadi, Fatehabad was lodged on dated 30.06.2015 under sections 147, 148, 149, 323, 307 & 341 read with sections 149 & 379 of Indian Penal Code, 1860 at Police Station, Ratia, Fatehabad alongwith other Co-accused. Thereupon, the incumbent was arrested by the Police Authorities on dated 19.08.2015. Consequently, the incumbent was suspended w.e.f. 19.08.2015 by the department vide order No. 16/201-2015 H.R.L.(1)/651 dated 23.11.2015/09.12.2015, based upon the report of the then Principal, BITE Jakhandadi Fatehabad vide his intimation letter dated 01.10.2015.

Whereas, later on, Additional Session's Judge, Fatehabad vide order dated 18.05.2018/22.05.2018, found the incumbent guilty and convicted him under sections 147, 148, 323, 341, 307 read with sections 149 & 379 of the Indian Penal Code, 1860 with rigorous imprisonment of five years and fine of Rs. 20,000/- upon him. Operative part of the gravity of punishments imposed upon the incumbent are mentioned as under:-

All the substantive sentences of convicts would run concurrently.

Whereas, aggrieved with the above said conviction a criminal appeal no. CRA-S-2438-SB of 2018 on dated 29.05.2018 was filed by the incumbent against orders of the Additional Session's Judge, Fatehabad before the Hon'ble High Court of Punjab & Haryana wherein the Hon'ble High Court only suspended the sentence of the incumbent pending adjudication of appeal while granting him regular bail in lieu of the one surety & bail bond of Rs. 50,000/- but the conviction of the incumbent was never set aside. Besides that the conviction of the incumbent under serious offence comes under the preview

of the moral turpitude. The Government instructions are very clear in this regard as reproduced herein below:-

“Instructions issued by the Chief Secretary to Government of Punjab vide letter No. 4819-G 11-57/11919, dated 08.07.1957 state that:-

2. Rule 7.6 of Punjab Civil Services Rules, Volume I, Part I, requires that a Government servant against whom a criminal charge is pending should be placed under suspension, if (i) the charge is connected with his position as a Government servant or (ii) is likely to prove embarrassing in the discharge of his duties as such, or (iii) involves moral turpitude. The implication of this rule is that if the criminal charge does not fall under any of these three categories, it will not be necessary to suspend the Government servant. It follows that on conviction in the case of such a charge, it will also not be necessary that the Government servant should be dismissed or removed from service. Thus rule 7.6 of the Punjab Civil Services Rules, Volume I, Part I had the effect of dividing cases in which Government servants have been convicted of criminal charges into two classes:-

(i) Cases in which dismissal or removal from service should follow automatically.

(ii) Cases in which it need not so follow.”

Whereas, the present matter and conduct of the incumbent is covered under these instructions. Besides that clause (a) of the provision of Article 311(2) of the Constitution of India also empowers the appointing authority to dismiss or reduce in rank without preliminary inquiry on the grounds of the proved mis-conduct of a Government Servant which led to his conviction on criminal charges as of the present matter. Operative part of the said provisions is reproduced as under:-

*311. Dismissal, removal or reduction in rank of persons employed in civil capacities under the Union or a State*

(1)\*\*\*\*\*

(2) No such person as aforesaid shall be dismissed or removed or reduced in rank except after an inquiry in which he has been informed of the charges against him and given a reasonable opportunity of being heard in respect of those charges Provided that where it is proposed after such inquiry, to impose upon him any such penalty, such penalty may be imposed on the basis of the evidence adduced during such inquiry and it shall not be necessary to give such person any opportunity of making representation on the penalty proposed: Provided further that this clause shall not apply

(a) where a person is dismissed or removed or reduced in rank on the ground of conduct which has led to his conviction on a criminal charge; or

(b) \*\*\*\*\*

Keeping in view of the above said facts and circumstances, it is observed that present matter involves the offence of moral turpitude of which the incumbent has been convicted by Hon'ble Court. Sh. Sahib Ram, PGT English has been convicted by the Hon'ble Court for the aforementioned serious offences & the said conviction is still in existence. Therefore, the teacher with such a conduct is dangerous for the Education fraternity as being a teacher, the incumbent should be a role model for the society & students especially to the young minds to whom he has responsibility to teach. The

incumbent as put stigma upon the pious institution, wherein everyone is expected to be a role model for young students.

Therefore, in view of the facts enunciated above Sh. Sahib Ram, the then PGT English, BITE Jakhandadi, Fatehabad (now suspended) is hereby dismissed from services with immediate effect by invoking the powers conferred under Article 311(2) of the Constitution of India.

It is ordered accordingly.
