

Whereas, the instant order are being passed in compliance of the directions of the Hon'ble High court dated 21.10.2022 passed in CWP no. 12386 of 2019 titled as Subhash Chander Dudeja and others v. State of Haryana and others to revise the pay scale in the pay grade of Rs. 2000-3200 with effect from 01.01.1986 instead of 01.05.1989 being an anomaly and grant the arrears accordingly .

Whereas, the Hon'ble High Court dispose of the said petition vide dated 21.10.2022.the operative part of the order is reproduced as under:

“Learned counsel for the petitioner submits that the petitioner has already Raised the said grievance before the respondents by way of serving a legal notice dated 02.05.2018 (Annexure p/2), which is still pending consideration with the respondents and the petitioner will be satisfied, at this stage , in case a time bound direction is issued to the respondents No.1 to decide the said legal notice by passing appropriate speaking order.

Learned State counsel submits that in case the legal notice dated 02.05.2018 (Annexure P/2) served by the petitioners is not already decided, the same will be decided by the respondents No. 1 in a time bound manner by passing speaking order within a period of four weeks from the receipt of copy of this order.

Learned counsel for the petitioner submits that keeping in view the statement made by the learned state counsel, the present writ petition may be disposed off having been not pressed any further. Ordered according.”

Whereas, in compliance of the above said order the legal notice dated 02.05.2018 (Annexure P-20) examined and it is found that petitioners requested to grant revised pay scale of Rs. 2000-32000 (instead of Rs.1640-2900) w.e.f 01.01.1986 on the post of Lecturer with all consequential benefits including pay fixation and arrears of difference of salary from 01.01.1986 to date and further their Pension and Arrears of difference of salary w.e.f 01.01.1986 to till date and their retrial benefits be also revised from due dates for all intents and purposes.

Whereas, the pay scale of both posts i.e Lecturer in Higher Secondary Schools and Headmaster /Headmasters/ B.E.O. were revised from time to time as under ;-

From the above tables, it is clear that there were two functional pay scales of the post of lecturer in GSSS school and only the pay scale of lecturer having M.A. in 1st and 2nd Division was equivalent to the post of

Headmaster /Headmistress meaning thereby the pay scale of Lecturer in GSSS's was not equivalent as a whole/in toto to the post of Headmaster/Headmistress as on 01.04.1979 & 01.01.1986 under HCS (Revised Scale of Pay) Rules, 1980 as well under HCS (Revised Pay) Rules,1987 respectively. The pay scales of both posts were modified to Rs.2000-3500 w.e.f 01.05.1990 vide FD's letter dated 23.08.1990. Accordingly, as per Finance Department letter dated 20.04.2021, neither there is any historic parity in their pay scales not there is anomaly between the pay scales of these two posts.

Whereas, it is stated that it is just a co-incidence that two different cadres carry identical pay scales at a given point of time due to pay revision, but that does not establish any ground to claim parity or equivalence between such posts. Moreover, nature of duties and level of responsibility of both posts are altogether different. However, no specific anomalies were observed by the pay anomalies commission constituted by the State Government.

Whereas, the issue of modification of pay scale vide orders dated 23.08.1990 has already been decided by the Hon'ble Punjab and Haryana High Court in case of **S.K Bishnoi and others v. State of Haryana,1993(3) Recent service Judgment , 444 as to what would constitute (anomaly) and the following five instances have been given therein:**

(a) when the pay scales are revised by the government through a general pay revision notification or all its employees and the revised scales are not prescribed in respect of some posts/departments on account of inadvertent omission

(b) when the functional pay scale prescribed for a promotion post is lower than the functional pay scale of the feeder post;

(c) where there is a loss of pay in the case of an employee on account of revision of pay scales;

(d) where, on promotion, an employee draws lower emoluments than what he was drawing prior to his promotion;

(e) where the pay of a senior employee gets fixed at a lower stage as a consequence of pay revision qua a similarly situated junior employee.

After, establishing above definition of anomaly, the Hon'ble High Court observed in its orders as follows;

"The petitioners are not correct in saying that the PAC or the officers' Committee had detected any anomaly in their pay scale. Even at the time of hearing, none was pointed out. The official record produced at the time of hearing does not point out that the PAC or the Officers' committee found any anomaly in the pay scale of the petitioners or other similarly situated employees. To us it appears that the respondent allowed them the higher pay scale of Rs. 2000-3500 keeping in view the nature of duties performed by them.

Whereas, this matter relates to 4th pay commission applicable w.e.f.01.01.1986 i.e more than 30 years old and the similar issue has already been decided by the Hon'ble High Court in CWP No.12483 of 1990-SK Bishnoi & others v. State of Haryana. Hence, the present writ is full of delay and laches.

Whereas, with reference to the concept of anomaly in matters of pay scales, it is important to mention that the expression is not clearly understood and is rather misconstrued by most of the employees. As a result, in all such cases, where the employees request, demand or agitate for grant of a higher pay scale for a particular post, they generally tend to represent that there is an anomaly and the same should be removed. In actual, judging by the definition of anomaly' as defined in Finance Department's letter dated 20.04.2001, there is no anomaly as such rather it is a demand for an upward revision of the pay scale.

Whereas during 6th CPC, pay scale of engineering cadre was further upgraded w.e.f. 01.09.2009 vide orders dated 19.08.2009. These orders were challenged by the engineering cadre vide CWP no. 16737 of 2013

titled as Subhash Chander Singla and others vs. State of Haryana and others and prayed for quashing the decision dated 19.08.2009, granting them the revised pay structure w.e.f.01.09.2009, but the same has been granted to HCMS doctors w.e.f.01.06.2006. Hence, they claim the release of actual benefit of upgraded pay scales w.e.f. 01.01.2006 instead of 01.09.2009.

Whereas, the Hon'ble High Court vide orders dated 02.08.2013 had dismissed the above said writ petitions, the operative part of the above said judgment is re-produced as under;-

The State Government had further modified the revised pay scale of HCMS doctors w.e.f 1.1.2006. The Government, on the recommendations of the pay anomaly committee, further improved the pay scales of the Engineers as well. Once these significant aspects of the matter are looked into, I find that it was not really a case of removal of anomaly, but grant of further revision and, therefore, the State had the prerogative to fix the date of 01.09.2009 from which this revision was to take effect and to bear the financial burden accordingly. Once the Court finds that the case does not come within the ambit of 'anomaly', and it was a case of further revision in the pay scale, the demand of the petitioners to give the further revised pay scale with effect from 01.01.2006 would not be appropriate. The writ petition is according dismissed."

Keeping in view of the detailed facts & circumstances mentioned above, the claim of petitioner is not tenable at this stage and is liable to be rejected being devoid of merits.
