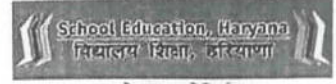

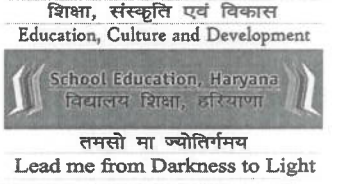



Smt. Shruti [202060], Post Graduate Teacher Home Science, Government Senior Secondary School, Jhansa [2401], Kurukshetra is hereby informed that it is proposed by the Governor of Haryana to take action against her under rule 7 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016, on the grounds set out in the enclosed statement of charges. The charges are based on the statement of allegations appended thereto.

2. **Smt. Shruti [202060]** is hereby required to state in writing within a period of 15 days from the receipt of this memorandum by her whether she admits the truth of all, or any, of the charges, what explanation or defence, if any, she has to offer and whether she desires to be heard in person.
3. **Smt. Shruti [202060]** is hereby further informed that if for the purpose of preparing her written statement, she wants to have an access to the relevant official records, she should inspect the same in the office of the Director, Secondary Education, Haryana, Panchkula, on any working day after making prior appointment with him. It is, however, pointed out that only such documents will be shown to her as are in the possession of the Director, Secondary Education, Haryana, Panchkula and as are strictly relevant to the case. If in the opinion of the Government, it is not desirable in the public interest, to allow her access to any document, such access shall be refused. If **Smt. Shruti [202060]**, wishes to consult any other relevant record, which is not in the custody of the Director, Secondary Education, Haryana, Panchkula, it is for her to undertake its inspection. It is, however, made clear to **Smt. Shruti [202060]** that her failure to inspect the documents shall not constitute a valid ground for delay in the submission of her written statement and if the written statement is not received by the undersigned within the specified period, it shall be presumed that she has none to submit.
4. The written statement should be submitted direct to the undersigned.
5. The receipt of this memorandum with enclosures may please be acknowledged.

Statements of charges against Smt. Shruti [202060], Post Graduate Teacher Home Science, Government Senior Secondary School, Jhansa [2401], Kurukshetra.

While being posted as Post Graduate Teacher Home Science in Government Senior Secondary School, Jhansa [2401], Kurukshetra from 18.12.2017 to date. Smt. Shruti [202060] committed certain acts of omission and commission for which she is being charged as under:-

“That she i.e. Smt. Shruti being Post Graduate Teacher Home Science was granted leave without pay for going abroad for the period from 15.08.2019 to 15.01.2020. After availing the sanctioned leave, she failed to join her duties even after lapse of more than 2 years and 11 Months. Thereafter, an application regarding extension of leave, was sent by her to the Principal, Government Senior Secondary School, Jhansa [2401], Kurukshetra through an e-mail which shows her i.e. Smt. Shruti being Post Graduate Teacher Home Science, insincerity towards official duties and clear violation of the condition No. 5 mentioned in the permission orders for going abroad issued by the Directorate. Resultantly, she was suspended vide order No. 14/62-2019 Post Graduate Teacher-II (5) dated 14.01.2021.”

In this way, she i.e. **Smt. Shruti** acted in an irresponsible manner and committed an act unbecoming of a Government Officer and violated the provisions of **rule 4(1) (ii) (iii) (iv) and 5 (vi) (viii) of the Haryana Civil Services (Government Employees Conduct) Rules, 2016.**

The lapses detailed above constitute grave misconduct on the part of *Smt. Shruti being Post Graduate Teacher Home Science* rendering her liable for strict disciplinary action under rule 7 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016.

Statements of allegations against Smt. Shruti [202060], Post Graduate Teacher Home Science, Government Senior Secondary School, Jhansa [2401], Kurukshetra.


While being posted as Post Graduate Teacher Home Science, Government Senior Secondary School, Jhansa [2401], Kurukshetra from 18.12.2017 to date, Smt. Shruti committed following acts of omission and commission:-

“That she i.e. Smt. Shruti being Post Graduate Teacher Home Science, Government Senior Secondary School, Jhansa [2401], Kurukshetra was granted permission for going abroad from 15.08.2019 to 15.01.2020 vide Directorate letter No. 14/62-2019 PGT-II (5) dated 17.07.2019. According to District Education Officer Kurukshetra letter No. E-2-2020/8733 dated 17.07.2020, she i.e. Smt. Shruti being Post Graduate Teacher Home Science went to abroad after taking prior sanction of without pay leave from 15.08.2019 to 15.01.2020 but she i.e. Smt. Shruti being Post Graduate Teacher Home Science failed to join her duties even after lapse of more than 2 years and 11 months. Thereafter, she i.e. Smt. Shruti being Post Graduate Teacher Home Science sent an application to the Principal, Government Senior Secondary School, Jhansa [2401], Kurukshetra through an e-mail regarding extension of leave during the said period which is clear violation of the condition No. 5 mentioned in the permission orders for going abroad issued by the Directorate. As per condition No.5, no employee can extend his/her leave during the leave period for going abroad. Accordingly, she i.e. Smt. Shruti being Post Graduate Teacher Home Science staying in abroad since last 2 years and 11 months without taking prior permission of the department which was a very serious lapse on her part. Resultantly, she i.e. Smt. Shruti being Post Graduate Teacher Home Science was suspended vide order No. 14/62-2019 PGT-II (5) dated 06.01.2021. ”

In this way, she i.e. Smt. Shruti being Post Graduate Teacher Home Science acted in an irresponsible manner and committed an act unbecoming of

a Government officer and violated the provisions of **rule 4(1) (ii) (iii) (iv) and 5 (vi) (viii) of the Haryana Civil Services (Government Employees Conduct) Rules, 2016.**


The lapses detailed above constitute grave misconduct on the part of Smt. Shruti being Post Graduate Teacher Home Science rendering her liable for strict disciplinary action under rule 7 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016







Whereas, Sh. Satender Pal & Others have filed the CWP No. 6853 of 2020 in the Hon'ble High Court of Punjab & Haryana, Chandigarh, with the prayer to step-up the pay of petitioners at par with their junior and re-fix their pay/pension in view of judgments of the Hon'ble Supreme Court in Commissioner and Secretary to Govt. of Haryana v. Ram Sarup Ganda, 2007(2) SCT 476 and K.C. Bhardwaj (SLP No. 13940/2002) and Government instructions issued from time to time (2006-2008), Annexure:P.10 (Colly) and release them all the consequential benefits like arrears of pay, pension and other benefits.

The present case was disposed of by the Hon'ble High Court vide order dated 19.09.2022. The operative part of the order is as under:-

“Without going into the merits of the case or the claim made by the petitioners in the present petition or in the legal notice dated 20.08.2019 (Annexure P-11), the respondent No.2 is directed to decide the legal notice dated 20.08.2019 (Annexure P-11) within a period of eight weeks by passing an appropriate speaking order from the receipt of copy of this order. In case, after the passing of the speaking order, it is found that the petitioners are entitled for any relief, the same be also released to the petitioners within four weeks thereafter.

Present writ petition stands disposed of.”

Keeping in view the above said directions, the legal notice dated 20.08.2019 has been minutely examined and found that all the petitioners have rendered services on different cadre of posts (i.e. cadre is not identical) under School Education Department.

That the petitioners have given the example of junior i.e. Sh. Ramesh Chander for step-up of pay. But, the additional increment of Sh. Ramesh Chander, retired Principal, GGSSS, Asaudha has been withdrawn and accordingly, the pay has been fixed at Rs. 91100/- as on 01.01.2016 by DEO, Jhajjar. Sh. Ramesh Chander retired on 31.08.2018.

That the petitioner namely Sh. Satender Pal, BEO, Salhawas (Jhajjar) retired on 31.03.2017 and the pay is fixed at Rs.94100/- as on 01.01.2016 and the pay of Sh. Ramesh Chander is Rs. 91100/- as on 01.01.2016 which is more than the pay of the Sh. Ramesh Chander.

That the petitioner namely Sh. Bhagat Singh, BEEO Salhawas (Jhajjar) retired on 30.06.2018 and the pay is fixed at Rs. 94100/- as on 01.01.2016. Whereas, the pay of Sh. Ramesh Chander is at Rs. 91100/- as on 01.01.2016 which is less than the petitioner.

That the petitioner namely Sh. Harpal Singh Dagar, Pricipal (Jhajjar) retired on 30.01.2016 and the pay is fixed at Rs. 93800/- as on 01.01.2016. Whereas, the pay of Sh. Ramesh Chander is at Rs. 91100/- as on 01.01.2016 which is less than the petitioner.

That the petitioner namely Sh. Om Prakash Jhakar, BEEO (Jhajjar) retired on 30.06.2016 and the pay is fixed at Rs. 95300/- as on 01.01.2016. Whereas, the pay of Sh. Ramesh Chander is at Rs. 91100/- as on 01.01.2016 which is less than the petitioner.

That the petitioner namely Sh. Virender Singh, BEO (Jhajjar) retired on 31.01.2020 and the pay is fixed at Rs. 91400/- as on 01.01.2016. Whereas, the pay of Sh. Ramesh Chander is at Rs. 91100/- as on 01.01.2016 which is less than the petitioner.

That the pay of the petitioner namely Sh. Surender Singh, retired DEEO, Jhajjar is fixed at Rs. 91400/- as on 01.01.2016. Whereas, the pay of Sh. Ramesh Chander is at Rs. 91100/- as on 01.01.2016 which is less than the petitioner.

That with regard to Sh. Hari krishan Dhankar, retd. Principal, Jhajjar on 31.03.2012, it is submitted that the service book of the petitioner is not traceable. It is further submitted that the claim of the petitioner will be considered when the service book of the petitioner would be traced.

That petitioner namely Sh. Ajit Singh, retired BEEO, Nuh, Mewat on 31.05.2014. The pay of the petitioner is fixed at Rs. 32,360/- as on

01.09.2013 whereas the pay of the Sh. Ramesh Chander as on 01.07.2013 is 32,040/- which is more than that of Sh. Ramesh Chander.

Keeping in view the above said facts, there is no merits in the legal notice dated 20.08.2019. Thus, the claim of the petitioners except petitioner namely Sh. Hari Krishan Dhankar as his service book is not traceable is rejected.
