Order No. 13/21-2007 PS(2)

Dated, Panchkula, the 29-02-2013

Whereas, the recognition was granted to Rattan Chand Jagdish Rai International School, Suraj Kund Road, Faridabad from Class 1 to 10th vide office order No. 13/21-07 PS(2) dated 30.06.2009 under the management of Sh. Rattan Chand Charitable Trust, 19 Golf Link Road, New Delhi.

Whereas, the managing committee Rattan Chand Jagdish Rai International School, Suraj Kund Road, Faridabad applied for NOC for the same of the movable & immovable of Rattan Chand Jagdish Rai International School to Trinity Educational Trust, New Delhi and the same was issued vide this office order no. 13/21-07 PS(4) dated 19.02.2010. Thereafter, the new management committee i.e. Trinity Education Trust, New Delhi, who purchased the said school got permission to change the name of school from Rattan Chand Jagdish Rai Sood International School, Suraj Kund Road, Faridabad to Manav Rachna International School, Vill. Chamwood, Faridabad vide this office order no. 13/21-2007 PS(4) dated 13.03.2010 with the condition that the trust follow the conditions imposed in the recognition letter No. 13/21-07 PS(2) dated 30.06.2009 given to the earlier management i.e. Sh. Rattan Chand Charitable Trust, 19 Golf Link Road, New Delhi.

Whereas, the permission was granted to Manav Rachna International School, Vill. Chamwood, Faridabad upto Senior Secondary level vide this office order no. 13/21-2007 PS(2) dated 28.04.2012 which was valid for next two academic sessions i.e. only upto the session of 2013-14.

Whereas, the Manav Rachna International School, Vill. Chamwood, Faridabad has not been applied for recognition upto Senior Secondary level, however, the school has been running the classes upto Senior Secondary level without recognition from the department. Furthermore, the management concerned did not provide the copy of recognition upto Senior Secondary level of the school even after various communications made with them.

Whereas, the school has violated Rule 36 read with Rule 3 of Haryana School Education Rules, 2003. The operative part of Rule 36 and Rule 3 of Haryana School Education Rule, 2003 are as under: -

Rule 3 (1): *No school in the state can function, establish or start classes without the prior approval or permission of the Director. Every school established by any individual or association of individuals or firm or society or trust or company. Shall follow the norms specified under these rules, any act or disobedience on the part of the school managing committee contrary to the provisions of these rules shall make its liable:*

- (i) XXX.....
- (ii) XXX.....
- (iii) XXX.....

Rule 36: *No recognized school without giving full justification and without prior approval of the appropriate authority, shall open any new class other than which have received approval from the appropriate authority.*

Thus, by doing so, the school has violated the provision of Rule 42(1) of Haryana School Education Rules 2003. The operative part of Rules 42(1) is reproduced here as under:

Rule 42 (1) *The appropriate authority may withdraw recognition/NOC of a school after giving a written notice, drawing the attention of acts of omission and commission contrary to the Acts/rules or directions issued their under to the managing committee either directly or through Principal/Head of the institution.*

Therefore, in the exercise of power conferred upon me under Rule 43 of The Haryana School Education Rules, 2003, a show cause notice is being issued to the school management as to why the recognition granted to their school up to 10th may not be withdrawn for running class 11th to 12th without any recognition from the department.

The reply, If any, the Management wants to submit, should be sent to this Department within a period of 15 days, failing which, it will be presumed that the Management has nothing to say in this regard and the appropriate order shall be passed in accordance with Rules.

No. 13/53-2021 PGT-I (3)

Dated, Panchkula, the 16.2.2023

Whereas, Sh. Sunil Kumar and others have filed CWP No. 5648 of 2019 titled as Sunil Kumar and others vs. State of Haryana & others before the Hon'ble Punjab and Haryana High Court praying therein for quashing the arbitrary action of respondents while issuing departmental order dated 04.12.2018 and further, directing the respondents to grant to the petitioners pay higher than the pay of the juniors from the day on which the juniors started getting the pay higher than the seniors alongwith the interest.

The Hon'ble Punjab & Haryana High Court disposed of said petition on dated 19.07.2022 with following orders:

".....Keeping in view the above, no further orders are required to be passed by this Court. However, in case, the petitioners still have any grievance, they can approach the respondents by filing an appropriate representation and in case any such representation is filed by the petitioners, the respondents are directed to dispose off the same in accordance with law by passing an appropriate speaking order within a period of three weeks from the date of receipt of such representation. Accordingly, the present petition is disposed of."

Whereas, in compliance of the above said order, the cases of the petitioners are examined and a promotion order has been issued vide No. 13/53-2021 PGT-I (3) dated 29.10.2021 vide which petitioners have been promoted w.e.f. 26.04.2016 (notionally). The concerned Section officer of Distance Elementary Education Officer had re-fixed pay of the petitioners by granting the benefit of ante-dated promotion w.e.f. 26.04.2016 (notionally) i.e. the date from which their junior was promoted.

Benefit for arrears of difference of salary is not considerable as well as tenable as per the prevailing rules, instructions and on the principle of "no work no pay". As per the instructions No. 1/15/2003-2PR(FD) dated 27.11.2006 held that "no arrears of salaries is payable to the employee for the period between the deemed date of promotion and the actual date of promotion", since they have not performed their duties as PGT uptill the orders of actual date of joining as PGT. These instructions were based upon the judgment passed by Hon'ble Apex Court in State of Haryana and others vs. O.P. Gupta 1996 (2) RSJ 194 wherein it is held that in case of notional promotion allowed from the deemed date, the concerned officials are not entitled for payment of arrears of salary as they had not worked during the period. Accordingly, payment should be made from the actual date of promotion.

Keeping in view of the facts mentioned above & documents on record, the claim of Sh. Sunil Kumar and others is not tenable & hereby rejected being devoid of merits.
