That if they got appointment on the basis of furnishing false/forged or fraudulent information/facts/documents which are detected later on to be false or forged or fraudulent, they would be liable for termination of their services without any notice besides such criminal action that may be taken as prescribed in the Indian Penal Code or any other Law enforce.

Whereas Smt. Sarita, PGT Political Science, Govt. Girls Sr. Sec. School, Kilo, Rohtak was charge sheeted under rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 on 14.01.2022/20.01.2022 and the following alligations were levelled against her:-

यह कि जिला शिक्षा अधिकारी, रोहतक के पत्र क्रमांक स्था/2/18/4851 दिनांक 21.09.2018 से संलग्न उप-जिला शिक्षा अधिकारी-सह-जिला परियोजना समन्वयक समग्र शिक्षा अभियान रोहतक द्वारा प्रस्तुत जांच रिपोर्ट के अनुसार पाया गया है कि श्रीमती सरिता ने रा0क0व0मा0वि0 किलोई, रोहतक में पीजीटी राजनीति शास्त्र के पद पर कार्यरत रहते हुए दिनांक 02.04.2018 से 19.05.2018 तक कक्षा 10+1 व 10+2 की छात्राओं को प्राचार्य की अनुमति के बिना विषय परिवर्तन करके अर्थात् राजनीति विज्ञान विषय पढ़ाने के स्थान पर लोक प्रशासन विषय पढ़ाना आरम्भ कर दिया जबकि न तो छात्राएं और न ही अभिभावक विषय परिवर्तन हेतु प्राध्यापिका के पास आए।

उक्त मामला प्राचार्य के सज्ञान में आया तो प्राचार्य द्वारा दिनांक 19.05.2018 को आदेश पंजिका के आदेश क्रमांक 154, 155 तथा 156 के माध्यम से आपको स्पष्ट आदेश दिए जाने के बाद आपने राजनीति विज्ञान विषय पढ़ाना बंद करके लोक प्रशासन विषय पढ़ाना आरम्भ कर दिया।

इस प्रकार उपरोक्त विषय परिवर्तन से विवाद बढ़ना आरम्भ हुआ और आप छात्राओं को राजनीति विज्ञान विषय पढ़ाने के लिए प्रेरित नहीं कर सकी चूंकि छात्राओं को लोक प्रशासन विषय पढ़ना एक आसान विषय लगने लगा जिस कारण छात्राएं हिंसक तथा उग्र प्रदर्शन पर विषय परिवर्तन हेतु उत्तारू हो गईं। आप अपने संबंधित विषय राजनीति विज्ञान के प्रति छात्राओं में रुचि पैदा करने में सर्वथा नाकाम रही और छात्राओं द्वारा लिखित में दिया कि उन्हें राजनीति विज्ञान समझ नहीं आता। छात्राओं द्वारा ऐसा लिखना आप की अध्यापन शैली तथा विषय ज्ञान पर प्रश्न चिन्ह खड़ा करता है।


आप द्वारा उपरोक्त अनियतमिता के कारण ग्रामीणों द्वारा दिनांक 14.09.2018 को राजनीति विज्ञान न पढ़ाकर लोक प्रशासन पढ़ाने के कारण रा0क0व0मा0व0 में ताला लगा दिया जिस कारण विद्यालय का वातावरण खराब हुआ और विभाग की छवि धूमिल हुई जिसके लिए आप दोषी बनती हैं।

Thereafter, the charged officer submitted her reply to the said charge sheet on dated 07.02.2022 in the Directorate and denied all the charges levelled against her. However, the charged officer failed to make any specific reply to the said charge sheet. The reply of the charged officer was found unsatisfactory. Resultantly, Sh. O.P Langyan, IAS (Retd.) was appointed as inquiry officer vide dated 13.05.2022 to conduct regular departmental inquiry against the charged officer. The regular inquiry officer submitted his final report on dated 10.06.2022, wherein, the charges leveled against her were un-proved.

Keeping in view of the above said facts and circumstances, report of the regular inquiry officer and documents on record it is observed that though, the act of charged officer was in contravention with the directions given by the Principal of said school but the same was done in the interest of students. Further, the students also never complained against the charged officer for teaching the public administration subject instead of political science and due to this act of her omission no prejudice caused to the students as well as the

education department. The same has also been proved from the final report of regular inquiry officer.

Therefore, considering the facts enunciated above and taking a lenient view, the present charge sheet against Smt. Sarita, PGT Political Science, Govt. Girls Sr. Sec. School, Kiloj, Rohtak is hereby "Filed".
