ORDER NO. 4/361-2012 Co (1) DATED CHANDIGARH THE

Whereas Sh. Manjeet and others had filed a C.W.P. No. 17432 of 2012 in the Hon'ble Punjab and Haryana High Court praying for issuance of a writ in the nature of certiorari for quashing the action of the respondent for not considering the petitioners as covered under the policy decision of the Govt. for Granting exemption from passing HTET/STET to those candidates who had worked for a minimum period of 4 years till 11.04.2012 in the privately managed Govt. Aided Schools/ Recognised Schools and Govt Schools and who are in service on 11.04.2012 as per the Advt no 1/2012, subject to their passing the HTET/STET not later than 01.04.2015 and as per note-2 given in the advertisement granting exemption in view of Govt.'s policy decision and further prayed for considering the candidature of petitioners for selection and appointment against the posts of PGT Mathematics vide advt. no 1/2012

That the said writ petition along with other similar bunch of writ petitions including CWP No. 18048 of 2012, 20082 of 2012 and 20833 of 2012 came up for hearing before the Hon'ble High Court on 27.07.2022 and the same has been disposed of with the directions mentioned as under:-

"The representation, if any filed by the petitioners, will be considered by the competent authority with an open mind and appropriate order will be passed within a period of three months from the receipt of any such representation.

Learned State counsel submits that in case, the petitioners file their representation within a period of next three weeks, the same will be decided within a period of three months and till the decision of their representation, no action will be taken for filling up the posts which were kept vacant under the orders of this Court in these petitions, but after the decision of their representation, the respondents be given the liberty to fill up those posts in accordance with law.

Ordered accordingly.

That in pursuant to the above direction of the Hon'ble High Court, the petitioners have submitted their representations on dated 12.08.2022, 7.08.2022 and 04.09.2022. In their representations the petitioners have mentioned that they are having the requisite experience which can be considered equal to the experience of PGT as they had taught 9th and 10th classes for a period of 4 years upto 11.04.2012 despite the

fact that their designation is as Master/Teacher and are presently also working as Guest Master/Teachers in the Govt. Schools of the State.

That the petitioners were appointed to the post of Guest Master/Teachers instead of PGT (Post Graduate Teacher), therefore, their teaching experience can only be treated as Master/ Teacher even if they had taught higher classes. Furthermore, it is the administrative power of the head of the institution to allot any class to any teacher on the basis of the need/ requirement of the students, so that, teacher can be provided to every student and their study may not suffer. Moreover, the relevant service rules were already in the knowledge of the petitioners when they joined their respective posts and hence, they cannot claim their experience equal to any other post as a matter of right now.

Further, in CWP No 19687 of 2012 the CORAM of Hon'ble Punjab and Haryana High Court has also given a finding that, **"Experience on a post on the basis of which exemption is being sought in the basic eligibility condition cannot be of some other post although may be as a teacher. It has thus got to be on the post of a Post Graduate Teacher and that too in the respective subject for the post applied. Note 2 cannot be read in isolation and has to be read in conjunction with clause (b) of eligibility condition common to all posts. The contention thus raised by the counsel for the petitioner cannot be accepted.**

Petitioner was required to possess the experience of a Post Graduate Teacher in the subject for which the application stands submitted and should be in service and working on the post applied for not only on 11.04.2012 but also on the date when application is submitted.

In the light of the above, the claim as made by the petitioner in the present writ petition cannot be accepted. The writ, therefore, stands dismissed."

Furthermore, an another similar writ petition i.e. CWP No. 18569 of 2012 had also been dismissed by the Hon'ble Division Bench of the Hon'ble High Court where the petitioner had also prayed to treat her teaching experience of TGT equal to the experience of PGT for appointment to the post of PGT and the Hon'ble Division Bench mentioned in its order dated 11.12.2012 as under:-

“...The petitioner does not have the experience of 4 years as PGT instead she possesses the experience as TGT. She, thus, submits that her experience as TGT be included to fulfill the aforesaid eligibility condition of 4 years as well.

We are afraid that such a contention of the petitioner cannot be accepted. There is a definite purpose for prescribing 4 years' experience of teaching the students in PGT which, for the posts now advertised, is the only material consideration.

We, therefore, do not find any merit in this writ petition which is accordingly dismissed.”

Keeping in view of aforementioned facts, the claim of the petitioners is not tenable and hence liable to be rejected.

I order accordingly.

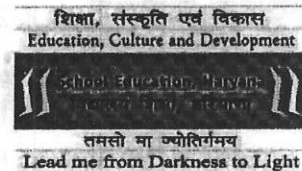




