Terms and conditions:-

1. The benefit of notional pay fixation and seniority will be admissible w.e.f. 05.03.2014 from the date when his/her juniors have been appointed and actual financial benefits will be admissible to him/her from the date when he/she joins duty as **PGT Hindi**.
2. He/She is appointed purely on temporary basis. This appointment is against temporary post and his/her confirmation against substantive post shall be considered on the basis of his/her seniority and record of service as and when such post is available.
3. He/She shall have to take an oath of allegiance to the Constitution of India.
4. In case he/she is married, he/she shall produce a certificate, before joining duty, to the effect that he/she has only one living spouse. If he/she has more than one living spouse, he/she shall be eligible for appointment to the post offered only after the Government is satisfied

that he/she has special ground for doing so, and exempt his/her from this condition.
