Terms and conditions:-

1. He/She is appointed purely on temporary basis. This appointment is against temporary post and his/her confirmation against substantive post shall be considered on the basis of his/her seniority and record of service as and when such post is available.
2. The appointment of aforesaid candidates shall be deemed notionally only for the purpose of pay fixation and seniority w.e.f. 17.12.2018 i.e. the date when their juniors have been appointed to the post of PGT Computer Science. However, the actual benefits will be admissible from the date of joining.
3. The actual allocation of station to the aforesaid candidate will be made after due course.
4. He/She shall have to take an oath of allegiance to the Constitution of India.
5. In case he/she is married, he/she shall produce a certificate, before joining duty, to the effect that he/she has only one living spouse. If he/she has more than one living spouse, he/she shall be eligible for appointment to the post offered only after the Government is satisfied that he/she has special ground for doing so, and exempt his/her from this condition.
6. He/She shall not claim seniority on the basis of this order. His/Her inter-se seniority will also be decided in accordance with the relevant service rules and instructions of the State Government issued from time to time later on.

7. He/She shall be on probation for a period of two years. The period of probation can be extended for a period not exceeding one year, if considered necessary.
8. In the matters, not specifically mentioned in this communication, he/she shall be governed by the Haryana Civil Services Rules-2016 as applicable to Haryana Government Employee and such orders/instructions as may be issued by the Government from time to time.
9. In case of reserved category candidate, the appointment is provisional and is subject to verification of the Scheduled Castes/Scheduled tribes/Backward Class and ESM Category Certificate. If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be is false then his/her service will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
10. Candidates are hereby directed to produce his/her original certificates of academic qualifications and other relevant certificate to the District Education Officer concerned alongwith photostatsself-attested copies. District Education Officers are directed to compare the photo copies with the original and thereafter original certificates and testimonials will be returned to the candidate.
11. Medical fitness certificate issued by the concerned Civil Surgeon will be produced before the joining.
12. He/She shall be governed by the Haryana State Education School Cadre (Group-B) Service Rules-2012.
13. If at any time during the course of his/her temporary appointment, he/she desires to resign, then in such eventuality, he/she shall be required to give one month's notice or forfeit, in lieu thereof, his/her one month's salary including allowances etc.
14. No TA/DA will be admissible to the candidate for joining as PGT.
15. If he/she gets an appointment as PGT on the basis of his/her furnishing ineligible/invalid qualifications, false/forged or fraudulent information/facts which are detected later on, he/she would be liable for termination of service without any notice.
16. The appointment will be subject to the condition of good moral character as the verification report is awaited from the District Magistrate, concerned and Superintendent of Police, concerned
17. If he/she is willing to accept this offer of appointment as PGT, HES-II (School Cadre) on the above terms and conditions, he/she should submit his/her joining report as per aforesaid directions.
18. The appointment will be subject to the final outcome of CWP No. 18514 of 2016 & connected petitions pending for adjudication in the Hon'ble High Court and SLP No 25184-25214 of 2018 titled as

Haryana Staff Selection Commission etc V/S Priyanka & Others pending for adjudication in the Hon'ble Supreme Court of India.

19. The appointment order is subject to the verification of the documents of the candidates who remain willfully absent before DVC or whose document verification have not been conducted so far.
20. The appointment order is subject to the equivalency from KUK/MDU and clarification from UGC of those candidates who passed their master degree from other state universities.



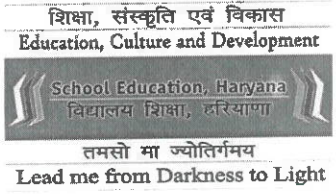

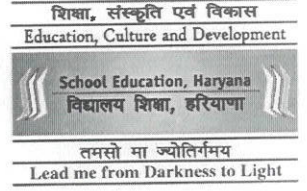
