

Whereas, Delhi Public School, Gurugram was granted NOC for upto 8th level under sub-rule(4) of Rule 12 of the Haryana State Right of Children to Free & Compulsory Education Rules, 2011.

Whereas, the petitioners had filed a Civil Writ petition titled as Deepak Jain and Others V/s. State of Haryana and Others alleging that the respondent school namely, Delhi Public School, DLF, Gurugram is running classes for class 9th to 12th without recognition from appropriate authority and that the school is not issuing SLC and other documents of the petitioners children.

Whereas, the civil writ petition was disposed of by the Hon'ble High Court on dated 02.11.2022. The operative part of the order dated 02.11.2022 is as under: -

This application has been filed for correction of order dated 28.10.2022 passed in the main case.

It has been stated that competent authority for deciding representation 26.9.2022 (Annexure P-10) is respondent No.2 and thus, necessary correction may be ordered.

For the aforementioned reason, the application is allowed. Order dated 28.10.2022 is corrected to read 'respondent No.2' instead of 'respondent No.3' as mentioned in the last paragraph of the order.

Whereas in the compliance of Hon'ble High Court orders dated 02.11.2022, the department examined the representation dated 26.09.2022 and issued a direction to the District Education Officer, Gurugram vide memo no. 7/82-2022 PS (1) on dated 30.11.2022, 05.12.2022 & 08.12.2022 to

comment and submit a report. Thereafter, District Education Officer, Gurugram vide a letter no. E-3/2022/1247 dated 13.12.2022 forwarded a letter no. DPSMK/ADMN/3122201 dated 02.12.2022 written by the Principal of Delhi Public School, Maruti Kunj, Gurugram. The principal in the letter stated that Delhi Public School, DLF Phase II, Gurugram is feeder school of Delhi Public School, Maruti Kunj, Gurugram and the respondent school namely, Delhi Public School, DLF Phase-11, Gurugram is recognized for running classes upto 8th Classes. The principal had also stated that the SLCS to aggrieved students for 9 to 12 classes had been issued from Delhi Public School, Maruti Kunj, Sohna Road, Gurugram and that the out of 13 petitioners, 11 petitioners had taken their SLCs.

Whereas a show cause notice was issued to the management of the school namely Delhi Public School, DLF, Gurugram on dated 15.12.2022. Whereas the school management submits its reply to above mentioned show cause notice. In its reply the school management submitted that Delhi Public Schools DLF has made all the necessary efforts to address the concerns of the parents, who made the Representation referenced in the civil writ petition no. 24172 of 2022 and has issued them school leaving certificates, thereby, ensuring that no prejudice is caused to the interest of these parents and their wards. It was further submitted by the school management that under the advice of DEO Gurugram office vide Direction No. E-3/2020/1221 dated 06.12.2022, they had submitted reply dated 07.12.2022 in reference to SLCs and other details. Further that SLCS related to DPS Maruti Kunj students had been issued and delivered on dated 02.12.2022 vide their letter no. DPSMK/ADMIN/071222/01 dated 07.12.2022. That in response to advice of DEEO Gurugram office vide memo no: G-II/2022/4-5 dated 12.12.2022, they had submitted reply along with SLCs and other details, SLCs related to DPS DLF City students had been issued and delivered on dated 13.12.2022, vide their letter no: DPSMK/ADMIN/131222/02 dated 12.12.2022. The school management also submitted that keeping in view the huge financial losses as mentioned in Annexure 9 they have decided to shut down the DPS DLF from

coming Academic Year. That in this regard application for Closure of DPS DLF had been already filed in the office of DEEO, Gurugram. In view of the above, it is requested that the Show Cause Notice may kindly be withdrawn with no further action.

Whereas a personal hearing was granted to the petitioners and the management of the school on dated 16.02.2023. In the course of personal hearing the petitioners alleged that the school namely Delhi Public School, DLF Phase II, Gurugram has only been granted recognition upto 8th level by the appropriate authority. However, school has been conducting classes for 9th to 12th level. The petitioners further prayed that a strict action be taken against the school. On the other hand, Sh. Anil Chauhan, appearing on the behalf of Delhi Public School stated that the school management has decided to shut down the DPS DLF from coming Academic Year 2023-2024. It was further submitted by him that the school management had already issued SLC and other relevant documents to the concerned aggrieved students. On behalf of school management, it was also submitted that some of these students were given admissions in Delhi Public School, Maruti Kunj, Gurugram, however due to administrative exigencies, their classes were conducted in Delhi Public School, Maruti Kunj, Gurugram for one year. It was further alleged by the school management that real reason for dispute between management and the petitioner is the fee charged by the school.

Whereas memo No. 23/1-2023 PS(E2)dated19.01.2023 has been placed on record . Whereas vide this memo school management has been allowed to shut down the school from academic session 2023-2024 subject to the condition that school shall submit its relevant record in the O/o Block Education Officer, Gurugram.

It is apparent from the facts mentioned above, pleading and official record that some of these students were admitted in Delhi Public School, Maruti Kunj, Gurugram for 9th to 12th level. However, their classes were conducted in building of Delhi Public School, DLF Phase II, Gurugram for one

year. The Delhi Public School, DLF Phase II Gurugram has been permitted to be closed down from the next academic session 2023-2024. SLC and other relevant documents have been issued to the concerned students. So the matter has been appropriately resolved and nothing remains to be decided.

His pay will be fixed in the grade according to rules. He will also draw the usual allowances admissible to Government Servants of their categories from time to time.

His appointment in the Directorate of School Education Haryana, Panchkula will be on the following terms and conditions :-

- (i) His appointment is against purely temporary post, which is liable to be abolished at any time and carries no promise of subsequent permanent employment. As such, as and when there will be no vacancy against which he could continue to officiate in the Directorate of School Education Haryana, he will be sent to his parent office. It is, thus made clear to him that at present he has been offered temporary post.
- (ii) In case at any stage, while he remains in temporary capacity and desire to resign his post he will be required to give one month's notice or forfeit in lieu thereof his salary including allowances for one month or the period by which the notice falls short of one month. He will give such a notice also in case, it is proposed to terminated his services for the reason other than that mentioned in clause (1) above.
- (iii) His seniority amongst peons will be determined from the date he resume duty in the office.
- (iv) He will not undertake higher studies of any kind without prior permission of the competent authority. Consequently no leave of any kind will be granted for perusing the higher studies.
- (v) In case any Chowkidar of the office goes on leave he can be assigned the duties of the Chowkidar.
- (vi) He will remain on probation for a period of two years from the date of joining in the Department. The period of probation can be extended in accordance with the existing rules on the subject. For assessing his performance during the period of probation his work and conduct will be taken into consideration. If his work and conduct during the probation is not found satisfactory, his services will be terminated without much also.
- (vii) No TA/DA or joining time will be paid to him for joining this post.

If he is willing to accept the offer made on the above mentioned conditions, he may get himself be relieved and report for duty to the office of Director Secondary Education, Haryana, Shiksha Sadan, Sector-5, Panchkula within a period of 15 days from the issue of this letter.





Whereas J.S Bedi High School, Harbanspura, Yamunanagar was granted permanent recognition upto 8th class by the then Sub Divisional Education Officer, Yamunanagar vide order dated 31.08.2001. Thereafter the school was granted temporary recognition upto 10th class vide order No. A- 1/2001/531/1276 dated 22.10.2001 for one academic session i.e. 2001-02 with certain terms and conditions by the then Sub Divisional Education Officer, Jagadhri, Yamunanagar.

Whereas complaints dated 10.08.2016 and dated 24.01.2017 were received against the aforesaid school on CM Window Portal in the office of Director Secondary Education Haryana, Panchkula whereby the complainant Sh. Virender Kamboj, resident of Yamunanagar leveled the allegations on the school management that the school was being run at a place which is different from the place for which recognition was granted to the school. He has also stated that the school is being run in violation of rules and appropriate action may be taken against the school.

Whereas earlier on the Complaint of Sh. Virender Kamboj to Block Education Officer, Yamunanagar has enquired into the matter. Enquiry officer in its report dated 25.05.2016 submitted that:-

- d
- (i) The school was having permanent recognition upto 8th class granted by District Education Officer, Yamunanagar and the school was having temporary recognition for class 9th to 10th.
 - (ii) The school was being operated at some other place instead of its original/permanent place. Therefore, the school was being run in violation of Haryana School Education Rules, 2003.

Whereas a show cause notice dated 11.09.2018 was served upon to the school management as to why the recognition granted to their school

may not be withdrawn from academic session 2019-20 for violating of Haryana School Education Rules 2003.

Whereas school management in its reply to show cause notice dated 15.11.2018 submitted that the school building was shifted to different place due to some family dispute. It was further stated that the building of the school was the joint property of the two brothers and that families agreed to divide the property as per their respective shares. That a wall was constructed to demarcate the respective shares in the middle of school and condition of the school building was also depleting. So application dated 24.11.2014 was made to District Education Officer Yamunanagar seeking permission to shift the school. However no decision was taken by District Education Officer, Yamunanagar so school was shifted in the interest of students.

Whereas a personal hearing was granted to the complainant and school management on dated 09.07.2021. Whereas after hearing the school, it was decided to grant one more opportunity to school and a committee was constituted to inspect the new school premises as per recognition norms.

Whereas a fresh enquiry was conducted under the chairmanship of Sh. Dilbag Singh the then Joint Director by team consisting of District Education Officer, Yamunanagar & Principal, Saraswati Senior Secondary, Bilaspur, Yamunanagar. After the enquiry, the committee submitted their report with the following remarks:-

1. Venue of school has been changed, all norms of new school are applicable in this school which have not been fulfilled.
2. School has 300 square yard area, which is not as per norms, ownership of land exists on individual name i.e. Smt. Sushma Rani instead of society.
3. All rooms are having single door and the rooms of first floor have asbestos sheet in place of R.C.C. Building structure certificate is only for ground floor and all the rooms of first floor are without varanda. No ramps. Stair size is not as per norms.

4. Teachers are not qualified except one.
5. Fire certificate is not renewed after 2017. Financial statement is not submitted after 2019. Certificate of playground has not been issued by competent authority.

Whereas another personal hearing was granted to the school on dated 31.01.2023. Smt. Sushma Rani appeared on the behalf of J.S. Bedi School Yamunanagar. Whereas Smt. Sushma Rani reiterated her submissions made earlier in reply to show cause notice..

Whereas Rule 42 of Haryana School Education Rules, 2003 provides that a school may not be transferred to a different building/locality without approval of competent authority. Rule 42 is reproduced here as under:-

"Rule 42- Lapse of recognition in other cases.

- (1) *The appropriate authority may withdraw recognition/NOC of a school after giving a written notice, drawing the attention of acts of omission and commission contrary to the Acts/rules or directions issued thereunder to the managing committee either directly or through Principal/ Head of the institution.*
- (2) *The recognition/ NOC of the school shall lapse if the school:-*
 - (a) *xxxxxxxxxxxx*
 - (b) *xxxxxxxxxxxx*
 - (c) *without the approval of appropriate authority.*
 - (i) *Transferred to a different building or locality,*
 - (i) *xxxxxxxxxxxx.*
 - (iii) *xxxxxxxxxxxx.*
 - (d) *where two or more schools running in the same building/premises affiliated with two different boards/council.*
 - (e) *has not complied with one or more of the conditions of recognition, specified in these rules.*
- (3) *Branches opened by the managing committee of a school already recognized shall be treated as new schools for the purpose of recognition i.e. no managing committee is allowed to run two schools affiliated with different Boards/Council in the same building/premises.*
- (4) *If the school authority fails to satisfy the appropriate authority of the lapse within thirty days from the date of service of such notice the recognition/ NOC shall stand lapsed.*
- (5) *The schools referred to in sub-rule (2)(c) above shall apply to the appropriate authority in an application along with documents such as resolution of managing committee, ownership of land, approved plan and an undertaking regarding any consequent liability/dispute*
- (6)(a) *There shall be a committee for processing and recommending the case consisting of following members, namely:-*

- (i) Joint Director school - Chairman
(ii) District Education Officer - Member
(iii) Member of Recognized - Schools Member
- (b) The committee shall submit its report within a period of one month and may visit the concerned school and inspect/ call for any record relevant for making recommendations.

Whereas the school failed to give a satisfactory reply. Whereas, all the relevant record and the inspection report dated 09.11.2021 has been perused. After due consideration, it has been found that the action on the part of school in shifting of the building without permission was against the rules. Also new premises is not fulfilling the land norms. Hence, exercising the power under Rule 42 of the Haryana School Education Rules, 2003, I being competent authority, am of considered view that the recognition of concerned schools be withdrawn from next academic session (2023-24). Further the admissions in the school be restricted from first day of new academic session (2023-24).
