Whereas, the petitioners have filed the present CWP No.21538 of 2020 titled as Randhir Singh & Others v. State of Haryana & Another, in the nature of mandamus for directing the respondents to count the period of adhoc service of the petitioners for the purpose of seniority and for granting of other service benefits in view of the judgment passed by the Hon'ble High Court in Civil Writ petition No. 7862 of 2006 titled as Hanumant Singh and others v. State of Haryana and others.

The case came up for hearing before Hon'ble High Court on 24.11.2022. The Hon'ble High Court disposed of the writ petition and the operative part of the order is as under:-

“Learned counsel for the respondents raises no objection in deciding the legal notice of the petitioners dated 10.10.2018 (Annexure P-4) in a time bound manner by passing an appropriate speaking order.

Without commenting upon the merits of the case or about the entitlement of the petitioners for the relief which has been claimed by them in the legal notice dated 10.10.2018 (Annexure P-4), the present writ petition is disposed of with a direction to respondent No.2 to decide the legal notice dated 10.10.2018 (Annexure P-4) within a period of eight weeks from the receipt of copy of this order.”

In compliance of the above said orders, the legal notice dated 10.10.2018 was minutely examined and found that a similar matter was decided by the Hon'ble High Court in CWP No. 6305 of 2009 titled as Parmod Kumar & Others v. State of Haryana & others and the same was dismissed on 17.09.2018. The Finance Department, Haryana has issued the instructions dated 02.05.2019 and the relevant points are as under:-

- (i) The petitioners are not entitled to count their period of adhoc/work-charged/temporary service towards seniority in the cadre before the date they were regularized and became members of service for the first time in terms of the relevant policies of State Government.
- (ii) The petitioners are not entitled to benefit of Additional Increments for the period of their adhoc/work-charged service on completion on 8/18 years of service as well as 10/20 years, since such period does not qualify as regular satisfactory service as per modified scheme dated 07.08.1992.
- (iii) Similarly, the petitioners are not entitled to the benefit of financial up gradations of Higher Standard Scale or to the Assured career progressions scales for the period of their adhoc, work charge/temporary service etc. Only regular service rendered satisfactorily counts for claiming right to these monetary benefits strictly as per the provisions of these schemes.

That there is no provision under any rule by which adhoc service can be counted for the purpose of seniority and other retiral benefits.


