- So as to ensure transparency in tendering, Government has decided that henceforth all public procurement entities viz. Departments, Boards, Corporations, Authorities, Statutory Bodies, Societies, Missions, etc. shall publish on their websites, the procurement details of tenders/contracts above the value of Rs. Five (5) crores relating to procurement of goods, works and services.
- Details of all awards of tenders/contracts above Rs. Five (5) crores relating to goods, works and services shall be published both on departmental website and also the nodal website of Industries Department i.e. https://dsndharyana.gov.in/
- 3. Format of information to be published/posted on websites with immediate effect is as below:
 - Name of Procuring Entity(name of Dept/District/office etc.).
 - Brief description of Award.....(Scope of work/supply; time frame for completion).
 - iii. Total Value (in crores).
 - iv. Allotted to(name of agency).
 - v. Date of allotment/work order
- 4. The Directorate of Supplies & Disposal is directed to arrange software data format and "user log-ins" for all public procurement entities, so that they may immediately post details of Awards of tenders/contracts on the state procurement website.
- Further, it is directed that all the CVOs of all the public entities shall be responsible for posting of details of award of tenders/contracts on websites every month and they shall file a certificate with the office of Chief Secretary (In Vigilance Department/Branch) every month regarding updating the information in this regard.

All concerned are directed to ensure implementation of the above directions in letter and in spirit.
