Whereas, Sh. Anil Kumar has filed CWP No. 23658 of 2022 titled as Anil Kumar vs. State of Haryana & others before Hon'ble Punjab and Haryana High Court praying therein to direct the respondents to promote the petitioner to the post of Post Graduate Teacher (English) from the date his juniors have been promoted vide order dated 13.04.2022 issued by the Respondent No. 2 with all consequential benefits.

The Hon'ble Punjab & Haryana High Court disposed of said petition on dated 17.10.2022 with following orders:-

".....keeping in view the statement of the learned counsel for the respondents, the present petition may kindly be disposed of having been not pressed any further with liberty to the petitioner to approach the respondents by filing appropriate representation raising the grievance, as raised in the present petition before the authorities concerned.

Ordered accordingly."

In compliance of above said order, the representation dated 21.10.2022 of Sh. Anil Kumar, TGT English has been duly examined and it is found that he was initially appointed as JBT on 11.09.2008 and later on, promoted to the post of Trained Graduate Teacher (English) on 06.01.2020 w.e.f. 17.07.2018 and joined as TGT English on 22.07.2020.

Whereas, as per Haryana State Education School Cadre (Group- B) Service Rules, 2012, the qualification for promotion of English PGT (Post Graduate Teacher) from English TGT (Trained Graduate Teacher) is as under:-

Sh. Anil Kumar joined as TGT English on 22.07.2020 so, he did not possessed the mandatory 2 years teaching experience as TGT English as required under Haryana State Education School Cadre (Group- B) Service

Rules, 2012 (as amended) and hence, not eligible on 20.06.2022 for promotion to the post of PGT (English). Juniors of the petitioner were promoted to the post of PGTs reason being that they have the requisite experience for promotion as per the Haryana State Education School Cadre (Group- B) Service Rules, 2012 (as amended).

Keeping in view the facts enunciated above and documents on record, the claim of Sh. Anil Kumar is not tenable and hereby rejected being devoid of merits.
